### **Explanation:**

• In a significant move to strengthen the Know Your Customer (KYC) process, the Reserve Bank of India (RBI) introduced six amendments to its KYC Master Directions, effective November 6, 2024.

#### Amendments in KYC Rules are as follows:

- Customers who have already completed KYC will no longer need to repeat the process when opening new accounts or availing additional services within the same institution
- High-risk customers will need updates every 2 years, medium-risk every 8 years, and low-risk every
   10 years
- Financial institutions are now required to upload customer KYC data to the Central KYC Records
   Registry (CKYCR) for accounts opened after January 1, 2017
- High-risk accounts, including those with unusual cash deposits or cheque requests, will undergo more intensive monitoring.
- Throughout the Master Direction, references to "section" have been replaced with "paragraph" for consistency in legal language
- The designation of the Central Nodal Officer under the Unlawful Activities (Prevention) Act has been updated from "Additional Secretary" to "Joint Secretary" as per a corrigendum issued earlier this year.

- The RBI has added 10-year Sovereign Green Bonds (SGrBs) to the list of government assets eligible for non-resident investment under the Fully Accessible Route (FAR)
- Reserve Bank of India (RBI) transferred an additional 102 tons of gold from the Bank of England to secure storage facilities in India.
- The Reserve Bank of India's Governor Shaktikanta Das has been named the top central banker with A+ rating by Global Finance magazine, based in the United States
- Ujjivan Small Finance Bank Limited (Ujjivan SFB) has gained approval from the Reserve Bank of India (RBI) to provide currency products and services.
- The Reserve Bank of India's (RBI) annual Census on Foreign Liabilities and Assets of Indian Direct Investment Entities for 2023-24 shows that the United States of America (USA) remains India's leading source of FDI.
- The Reserve Bank of India (RBI) has added 13 additional firms to its 'Alert List' of unauthorized forex trading platforms, now totaling 88.
- RBI has approved the merger of Tata Capital, an unlisted entity, with Tata Motors Finance (TMFL), paving the way for the formation of India's 12th largest non-banking finance company. Resulting in Tata Motors holding a 4.7 per cent stake in the merged entity.
- The Reserve Bank of India (RBI) has expanded access to its Negotiated Dealing System-Order Matching (NDS-OM) electronic trading platform to more regulated entities (RE).
- The Reserve Bank of India (RBI) has lifted the restriction on JM Financial Products, allowing the company to continue financing activities such as loans for shares, debentures, and IPO subscription.
- In a draft circular on 'forms of business and prudential norms for investments,' the Reserve Bank of India (RBI) recommends that banks refrain from using group corporations to avoid requirements.

- The revisions are intended to make it easier to implement innovative ideas and new concepts throughout the insurance value chain.
- The purpose is to encourage innovation in insurance products, services, and processes through a more flexible regulatory environment.
- IRDAI set up an internal committee to evaluate the existing IRDAI (Regulatory Sandbox) Regulations.
- The committee's recommendations were used to propose revisions to the regulatory sandbox regulations.
- The IRDAI has released an exposure draft of the IRDAI (Regulatory Sandbox) (Amendment) Regulations, 2024.

- The collaboration will also enable Bajaj Finance to fund and support more women-owned microenterprises and micro-borrowers.
- The \$400 million loan from IFC will allow Bajaj Finance to improve access to financing for clients interested in purchasing EVs, including 2-wheelers, 3-wheelers, and 4-wheelers, as well as strengthen its presence in the EECG arena.
- The money is intended to boost competitiveness in the climate finance industry, assist the country's climate goals, and promote financial inclusion.
- IFC is a member of the World Bank Group that focuses on the private sector in emerging markets. In fiscal year 2024, the IFC committed \$56 billion to private firms and financial institutions in developing nations

- Tata Power Renewable Energy Ltd has teamed with IndusInd Bank to provide solar financing solutions for Micro and Small Enterprises (MSEs).
- Solex Energy has teamed with State Bank of India (SBI) to provide solar financing alternatives to commercial, industrial, and institutional customers.
- The Indian Institute of Management (IIM) Shillong and the Small Industries Development Bank of India (SIDBI) have joined to promote entrepreneurship in India's Northeast.

- ZIMSAT-2, a low-earth observation satellite, was launched from the Vostochny Cosmodrome in eastern Russia as part of a collaboration between the Zimbabwe National Geo-Spatial and Space Agency (ZINGSA) and Southwest State University in Russia.
- ZIMSAT-2 is equipped with a high-resolution multispectral camera that can be used for a variety of applications, including agriculture, resource exploitation, and environmental monitoring.

### **Recent News Headlines related to Defence**

- The Indian Army's Northern Command has inducted 550 Asmi machine pistols that were created, produced, and manufactured indigenously. Lokesh Machine Limited, situated in Hyderabad, manufactures Asmi machine pistols.
- India plans to launch the European Space Agency's Proba-3 mission from the Sriharikota spaceport early next month, according to Science and Technology Minister Jitendra Singh.
- Scientists in Japan are preparing to test the world's first wooden satellite, the "LignoSat". Kyoto University researchers and Sumitomo Forestry, a homebuilder, collaborated on the LignoSat project
- North Korea recently declared that it successfully test-fired its latest intercontinental ballistic missile, the 'Hwasong-19. It incorporates solid-fuel propulsion, which allows it to be deployed more rapidly than liquid-fueled missiles.
- The three astronauts from China's Shenzhou-19 manned mission have entered the Tiangong space station and met with another astronaut trio to begin a new round of in-orbit crew handover
- ShakthiSAT mission Launched by Aerospace startup Space Kidz to train 12,000 girls aged 14-18 from 108 countries in space technology, targeting a satellite launch under ISRO's Chandrayaan-4 mission in 2026
- The Army Chief, General Upendra Dwivedi officially launched "Agniastra," a portable multi-target detonation device, during the Army Commanders Conference in Gangtok
- Rostec, a Russian state enterprise, claims its Light Multipurpose Guided Rocket, also known as "Izdeliye 305" or "Product 305," is very resistant to jamming and interference on the Ukrainian battlefield.
- India successfully launched its fourth nuclear-powered ballistic missile submarine (SSBN) at the Ship Building Center (SBC) in Visakhapatnam, strengthening its nuclear deterrence capabilities.
- The upper stage of ISRO's Polar Satellite Launch Vehicle C-37 (PSLV C-37) successfully re-entered Earth's atmosphere. This is a crucial step towards ISRO's goal of achieving a debris-free space mission (DFSM) by 2030.

- This year's challenge cemented its reputation as a premier venue for generating innovative and sustainable solutions to global water concerns.
- The challenge brought together key collaborators, including Atal Innovation Mission (AIM), NITI Aayog, Innovation Centre Denmark (ICDK), and DTU Skylab as part of the DTU Next Generation Action Program, as well as invaluable support from the International Centre for Clean Water (ICCW), the Ministry of Jal Shakti, the Embassy of Denmark, Denmark's Environmental Protection Agency, and the DANIDA Fellowship.
- The Indian group included five startup companies that took part in the worldwide Next Generation Digital Action program, which brought together young talent from top institutions and innovation hubs in ten countries.
- Among them, three university teams Clim8 (VIT Vellore), Checkmate (VIT Vellore), and Qualgrip (IIT Madras), as well as early-stage businesses Navmarg and Scrapify produced intriguing solutions to major worldwide water concerns.

- Following occurrences of cheetahs from Madhya Pradesh trespassing into nearby Rajasthan, both governments have formed a joint corridor management committee to focus on feline conservation.
- The group will also address the construction of suitable locations for the future relocation of cheetahs from Madhya Pradesh's Kuno National Park (KNP) and Gandhi Sagar Sanctuary areas, as well as recommend steps for improvement, including the pre-augmentation basis, according to an official statement.
- On September 17, 2022, as part of the ambitious cheetah reintroduction project, eight Namibian cheetahs were released into enclosures at the KNP in Sheopur region. In February 2023, the park received additional 12 cheetahs from South Africa.
- The group will also look into the possibility of joint tourist itineraries in areas bordering both states, such as the National Chambal Gharial Sanctuary, Kuno National Park, and Ranthambore National Park, among others.

- Brigadier (Dr) BD Mishra (Retd), the Lieutenant Governor of Ladakh, opened the 4th LG Cup Horse Polo-2024 Tournament at the newly constructed Polo Stadium in Goshan, Drass.
- Anish Sarkar of Kolkata, West Bengal, has become the world's youngest FIDE-rated chess player. At the age of three years, eight months, and 19 days, Anish achieved a FIDE rating of 1555
- Indian boxers Parthavi Grewal, Vanshika Goswami, and Hemant Sangwan won gold medals at World Boxing's first U19 World Championships in Colorado, USA, showcasing their exceptional potential.
- Ravindra Jadeja surpassed Ishant Sharma to become India's sixth highest wicket-taker in Test cricket. He reached this big milestone on the first day of the third and final Test of the series against New Zealand at Wankhede Stadium here.
- India's former cricketer VVS Laxman will take over as head coach for the Indian team during their upcoming four-match Twenty20 International (T20I) tour of South Africa in November
- India finished second overall in the Asian Arm Wrestling Cup 2024, held at the Aurika Skycity Hotel in Mumbai.
- Manika Batra created table tennis history by being the first Indian to go to the quarterfinals of a WTT Champions event.
- India won nine medals, including gold and silver, at the Under-23 global championships in Tirana,
   Albania, with Chirag Chikkara emerging as the champion.
- The Indian wrestling contingent finished its U23 World Wrestling Championships 2024 campaign with nine medals—1 gold, 1 silver, and 7 bronze.
- Sreeja Akula, an Indian women's table tennis player, became the highest-ranked Indian player in the world. According to the most recent International Table Tennis Federation rankings, she is placed 22nd in the world for women's singles


