





- The bank acknowledged that it will seek regulatory permission by filing an application with the RBI under Section 35B of the Banking Regulation Act, 1935.
- Subramaniakumar, who was named MD & CEO in June 2022, became the second public sector banker after Prashant Kumar to lead a private sector bank.

- MIG-II: Interest subsidy of 3% for loans up to Rs.12 lakh.



- The Central Government and the Reserve Bank of India (RBI) have reached a crucial decision on the 5 rupee currency.
- A specific type of this currency is being removed from circulation, owing to unique issues and concerns.
- Coins ranging from 1 to 20 rupees are currently in circulation, with several types of 5 rupee coins, including ones made of brass and heavier metals.
- The thicker 5 rupee coins have grown scarce in circulation, hence manufacture has been stopped, leaving only brass coins in circulation.
- The fundamental reason is their misuse.
- The material utilized in these coins is recycled to produce blades, resulting in a large illegal blade market worth crores. A single coin can yield four to five blades.
- Thicker 5 rupee coins will no longer be made, leaving just brass 5 rupee coins in circulation.
- There is no need to deposit thicker coins at the bank.



- The 'Ram Temple project' of the Shri Ram Janmaboomi Temple in Ayodhya has received the 'Sword of Honour' from the British Safety Council.
- This award was one of the greatest recognitions in safety management, and the British Safety Council evaluated the safety processes, practices, and on-site activities during its audits, with only those who received a five-star rating being eligible for the 'Sword of Honour' award.
- Larsen & Toubro, the company in charge of the temple's construction, was also given a 'Golden' Trophy' by the National Safety Council for its construction safety procedures.
- Larsen and Toubro and Tata Consulting Engineers worked closely together to build the temple, which was effectively overseen by the Shri Ram Janmbhoomi Teerth Kshetra Trust's Construction Committee.
- The first and second floors of the temple, including the Shikhar (spire), were in their last stages of construction, with completion scheduled for June 2025.
- construction, with completion scheduled for June 2025.

 The temple is being built with Bansi Paharpur stone from Rajasthan, totaling around 15 lakh cubic feet of stone, as well as extensive marble covering.





- Jalvahak incentive scheme Launched by Union Minister Sarbananda Sonowal
- The Jalvahak incentive system is a pioneering project aimed at encouraging long-haul cargo transportation across the country's enormous national waterway network.
- The scheme focuses on National Waterways 1 (Ganga), 2 (Brahmaputra), and 16 (Barak), which serve key regions of India.
- The plan provides direct incentives for delivering goods over 300 km on waterways, aiming to reduce congestion on roads and rail networks and promote sustainable transportation.
- Provides reimbursement for up to 35% of cargo transportation operating costs. Incentives items traveled over 300 km or more via rivers.
- India plans to move 200 million tonnes of cargo by 2030 and 500 million tonnes by 2047
- An investment of Rs.95.4 crore by 2027 is expected to significantly boost cargo movement on national waterways

- Cai Yan Yan defeated India's Anmol Kharb in the singles final of the 2024 BWF Super 100 Guwahati event.
- Rithvik Sanjeevi. Satish Kumar won the men's singles title at the 2024 BWF Super100 Odisha Masters badminton event.
- The Indian women's junior hockey team successfully defended its Women's Junior Asia Cup title in Muscat, Oman, defeating China 3-2 in the final.
- Aryna Sabalenka received the WTA Player of the Year award for the first time after winning two
 Grand Slam titles and finishing 2024 at No. 1 in the rankings
- The Khelo India Winter Games 2025 will be held in both Ladakh and Jammu & Kashmir in two phases. Ladakh will hold ice hockey and skiing from January 23-27, while Jammu & Kashmir will host snow activities

- The PM Surya Ghar Muft Bijli Yojana, which was inaugurated by Prime Minister Narendra Modi on February 15, 2024, seeks to offer rooftop solar power to one crore families by March 2027.
- Under the scheme, installations are expected to exceed 10 lakh by March 2025, double to 20 lakh by October 2025, and reach 40 lakh by March 2026.
- As of December 9, 2024, more than 6.79 lakh installations (total households covered) had been completed since the scheme's commencement.
- Six states account for approximately 88% of the total installations to far. Gujarat has the most installations (over 3.02 lakh), followed by Maharashtra (over 1.39 lakh), Uttar Pradesh (over 56,000), Kerala (over 55,000), Tamil Nadu (over 21,000), and Rajasthan (over 20,000).

- The PM Surya Ghar plan provides homes with up to a 40% subsidy to make renewable energy more affordable. It also offers collateral-free, low-interest loans at approximately 7% interest for the installation of residential rooftop solar (RTS) systems with capacities of up to 3 kW.
- Over the 25-year lifespan of these rooftop solar systems, the initiative is expected to generate 1,000 billion units of electricity while reducing CO2 emissions by 720 million tonnes, resulting in a major environmental benefit.

The FSI undertakes an in-depth assessment of the country's forest and tree resources using remote sensing satellite data and field-based National Forest Inventory (NFI), with the results published in the ISFR. The India State of Forest Report 2023 is the 18th report in the series.
- According to the report, India's total forest and tree cover is 827,357 square kilometers, or 25.17% of the country's geographical area.
- Furthermore, the overall forest cover has expanded by 1,445 square kilometres since the 2021 assessment.
- According to the Forest Survey of India (FSI), forest cover includes all land with a tree canopy density of more than 10% and an area of one hectare or more, regardless of ownership or legal status.
- The forest and tree cover total 8,27,357 square kilometers, or 25.17 percent of India's geographical area.

- The futures market is a market in which an attempt is made to predict the future price of a commodity while taking into account its demand and supply.
- A commodity market is a market in which commodities are purchased and sold. A commodity is a tangible asset that serves as an input in the production of other goods, such as rice, wheat, crude oil, natural gas, gold, and silver. Commodities, such as mandis, are traded on the spot market as futures derivatives.

- The tagging of India's national aquatic animal, the Gangetic River Dolphin, is part of the Union Ministry of Environment, Forest and Climate Change's Project Dolphin, which aims to track the migration patterns of the extremely endangered species.
- The initiative's funding came from the National CAMPA (Compensatory Afforestation Fund Management and Planning Authority).
- It was carried out by the Wildlife Institute of India, Dehradun, in partnership with the Assam Forest Department and Aaranyak, a well-known biodiversity conservation group in Assam.
- The data acquired from the tagged dolphin will help conservationists better understand the species' movement range and habitat, allowing them to develop a more effective conservation plan.
- The Gangetic River Dolphin (Platanista gangetica) is also known as the Blind Dolphin, Ganges Susu, and Hihu's. The river dolphin is a mammal, not a fish. According to the Wildlife Institute of India, there are approximately 4000 River Dolphins in India, with approximately 2000 located in Uttar Pradesh.
