

- UPI is regarded as one of the world's most successful real-time payment systems, handling over 16 billion transactions by December 2024.
- The agreement will first provide UPI acceptance throughout Dubai Duty Free, improving the shopping and payment experience for Indian tourists.




- The FICCI expects India's GDP to rise by 6.4% in fiscal year 2024-25.
- This is a decrease from the 7.0% prediction issued in September 2024 and represents a significant deceleration from the 8.2% growth observed in 2023-24.
- The agricultural industry, including allied activities, is predicted to rise 3.6% in 2024-25, according to the FICCI Survey.

- On Indian Army Day, Prime Minister Narendra Modi dedicated three frontline naval combatants to the nation: INS Surat, INS Nilgiri, and INS Vaghsheer, which were commissioned at the Naval Dockyard in Mumbai, Maharashtra.
- The Prime Minister also introduced new platforms, such as the INS Nilgiri, which honors the Chola dynasty's nautical strength, and the Surat battleship.
- INS Surat, the fourth and last ship of the P15B Guided Missile Destroyer Project, is one of the world's largest and most advanced destroyers.
- INS Nilgiri, the first ship in the P17A Stealth Frigate Project, was designed by the Indian Navy's Warship Design Bureau and has sophisticated features for increased survivability, seakeeping, and stealth.
- INS Vaghsheer is the sixth and final submarine of the P75 Scorpene Project.

- India successfully evaluated its indigenously built third-generation Anti-Tank Fire-and-Forget Guided Missile (Nag Mk 2) at Rajasthan's Pokhran Field Firing Range.
- Blue Origin's New Glenn rocket will launch at 1 a.m. ET Monday from the Cape Canaveral Space Force Station in Florida.
- Goa Shipyard Limited (GSL) successfully launched two indigenously designed Fast Patrol Vessels (FPVs) for the Indian Coast Guard.
- India and the US have partnered to co-produce US sonobuoys for the Indian Navy's underwater domain awareness (UDA).
- People's Liberation Army Navy (PLAN) officially launched its latest amphibious assault ship (AAS) from Shanghai, named 'Sichuan' after a province in southwestern China.
- India has designated 2025 to be the 'year of changes' in the defence sector, promising "unprecedented" progress in strengthening India's security and sovereignty in the face of 21st-century challenges.
- Pakistan's atomic energy regulatory agency has approved the construction of the country's largest nuclear reactor for electricity generating.
- The Ministry of Defence (MoD) has signed a contract to Mazagon Dock Shipbuilders Limited (MDL) in Mumbai for air independent propulsion (AIP) plugs valued roughly Rs 1,990 crore.
- India marked a significant milestone in its self-reliance by delivering two warships to the Indian Navy: the destroyer Surat and the frigate Nilgiri.
- China successfully launched four Earth-observation radar satellites called 'PIESAT-2' using a Long March-2D rocket from the Taiyuan Satellite Launch Center in Shanxi Province.
- Space entrepreneurs in Japan and India had agreed to collaborate on a study of utilizing laser-equipped spacecraft to remove garbage from orbit, as an experimental answer to the increasingly pressing problem of orbital congestion.
- China's space program reached a milestone when two of its astronauts performed a ninehour spacewalk. Shenzhou-19 crew members Cai Xuzhe and Song Lingdong completed a nine-hour extravehicular exercise (EVA), breaking a 22-year-old US record
- Defence PSU BEML Limited has secured Rs.136 crore contract to supply indigenously designed High Mobility Vehicles (HMVs) 8×8.
- Starting in 2025, India's Aditya L1 and the European Space Agency's (ESA) Proba-3 missions will collaborate to further solar research.
- INS Tushil, a Russian-built guided missile frigate, was commissioned into the Indian Navy in Kaliningrad, Russia, in front of Defence Minister Rajnath Singh, Chief of Naval Staff Admiral Dinesh K Tripathi, and other senior officials.

- India placed third globally in fintech funding, despite a 33% year-over-year fall to USD 1.9 billion from USD 2.8 billion in 2023.
- The fintech sector received USD 805 million in funding in Q3 2024, a 61% increase over the previous year.
- According to the research, early-stage fundraising rounds decreased by 16% year on year, from USD 667 million in 2023 to USD 562 million in 2024, and by 70% from USD 1.9 billion in 2022.
- Seed-stage funding decreased by 19% year on year, from USD 219 million in 2023 to USD 178 million in 2024, and by 66% from USD 529 million in 2022.



#### Explanation:

• The Chief Election Commissioner and Other Election Commissioners (Appointment, Conditions of Service, and Term of Office) Act of 2023 establishes new processes to broaden the scope of selection.

Background to the New Law for Appointing CECs and ECs:


- Article 324 of the Indian Constitution states that the President will nominate the CEC and ECs, however this is subject to Parliamentary law (if such law exists).
- While this provision requires Parliament to propose a corresponding law, it has not done so (until now).
- In the lack of such a law, the President has made selections based on the Prime Minister's recommendations.
- In 2023, the Constitution Bench of the Supreme Court (in the Anoop Baranwal v. Union of India case) agreed to modify the process for Election Commission selections in order to ensure their independence.
- The Bench formed a committee that included the Prime Minister, the Leader of the Opposition in Parliament, and the Chief Justice of India (CJI).
- This committee will provide recommendations to the President on Election Commission appointments until Parliament passes a separate statute on the subject.

















New Appointment Process Under the Act:

- The Election Commission is made up of the Chief Election Commissioner and two Election Commissioners, who are currently Gyanesh Kumar and Sukhbir Singh Sandhu.
- Section 5 limits eligibility to current or past Secretary-level officers.
- Previously, the senior-most Election Commissioner succeeded the outgoing CEC. The Act provides for the selection of candidates outside of the Election Commission, which broadens the pool.
- Section 6 of the Act establishes a Search Committee chaired by the Minister of Law and Justice and two senior officials to select a panel of five candidates.
- Selection committee composition: The Prime Minister, a Cabinet minister, and the Lok Sabha's Leader of the Opposition make up the Selection Committee. This committee has the option of selecting a candidate within the panel or nominating someone from outside.







- The Department of Science and Technology, Union Ministry of Science and Technology, has inaugurated the first astronomical observatory in Eastern India and the sixth in the country, located on Panchet Hill in the Garpanchkot area of Purulia district in West Bengal.
- It is the sixth such observatory in India, following Ladakh, Nainital (Uttarakhand), Mount Abu (Rajasthan), Girbani Hills in Pune, and Kavalur in Tamil Nadu.
- The observatory in Garpanchkot Hills is named after the eminent scientist Satyendra Nath Bose. The Satyendra Nath Bose National Centre for Basic Sciences established the observatory.
- The Satyendra Nath Bose National Centre for Basic Sciences has signed a memorandum of understanding (MoU) with Sidhu Kanu Birsa University, Purulia to operate the observatory and share resources.
- In 1986, the Government of India's Department of Science and Technology established the Satyendra Nath Bose National Centre for Basic Sciences in Kolkata, West Bengal.







- Titled Tuesday is an online competition for titled chess players with legitimate Chess.com accounts. To ensure fair play, players are asked to be accessible on Zoom calls.



















- The International Cricket Council (ICC) has named Jasprit Bumrah of India and Annabel Sutherland of Australia as the ICC Men's and Women's Players of the Month for December 2024, respectively.
- The first Kho Kho World Cup kicked off on January 13, 2025, at the Indira Gandhi Indoor Stadium in New Delhi. Sudhanshu Mittal, President of the Indian Kho Kho Federation, officially opened the World Cup.
- India and Mumbai batter Shreyas Iyer, the second-most expensive player in the player auction, has been appointed captain by Punjab Kings for IPL 2025. The 2024 IPL winning captain has previously led Delhi Capitals (DC) and Kolkata Knight Riders (KKR) in the IPL.
- In squash, India's Anahat Singh won the Under 17 Girl's Singles title at the British Junior Open in Birmingham, England.
- Varun Tomar of the Indian Army has won the Men's 10-meter Air Pistol finals of the 67th National Shooting Championship 2024, which took place at Dr Karni Singh Shooting Range in New Delhi.
- Haryana Steelers reached a historic milestone by winning their first Pro Kabaddi League (PKL) title. In a thrilling final at the Shree Shiv Chhatrapati Sports Complex in Pune, the Steelers overcame the Patna Pirates by 32-23.
- West Bengal, the most successful team in the Santosh Trophy's history, added to its trophy collection by defeating Kerala in the final of the 78th edition. This was the Bengal team's 33rd Santosh Trophy.
- Hemanth Muddappa, known as the "Drag King," achieved a remarkable triple crown victory in the final round of the MMSC FMSCI Indian National Motorcycle Drag Racing Championship held at the Madras International Circuit (MIC).
- Kerala won the Senior National Men's Handball Championship for the first time, defeating Chandigarh 34-31. The event final was held in Changanassery, Kerala.
- Punjab's Vijayveer Sidhu defeated fellow Olympian Gurpreet Singh of the Army Marksmanship Unit to win his first men's 25m rapid-fire pistol (RFP) title at the 67th National Shooting Championship Competitions (NSCC) for pistol events
- Lakshya Sen from India secured third place at the King Cup International Badminton Open by defeating French player Alex Lanier in straight games


- Every year on January 21, the northeastern states of Manipur, Meghalaya, and Tripura celebrate Statehood Day, commemorating the momentous moment when they achieved full statehood under the North Eastern Region (Reorganization) Act of 1971.
- Manipur, dubbed the "Jewel of India," has a rich past that includes traditional art, dance, and literature. Manipur's sovereignty in 1972 enabled it to thrive while maintaining its distinct identity.
- Meghalaya, often known as the "Abode of Clouds," became a full-fledged state to preserve its own cultural and linguistic identity. In 1947, the rulers of the Garo and Khasi regions joined India.
- Meghalaya, located in the country's northeastern area, was established as an autonomous state inside the state of Assam on April 2, 1970, including the districts of United Khasi and Jaintia Hills, as well as the Garo Hills.
- Tripura was a princely state till it merged with India on November 15, 1949. Bir Bikram was the last monarch to reign before India gained freedom. After his death on May 17, 1947, his minor son Kirri Bikram Mannikya ascended to the throne of Tripura kingdom.

Eritrea's Berhane Tesfay and Kenya's Joyce Chepkemoi Tele won the men's and women's elite races, respectively, at the Mumbai Marathon 2025.

International Society for Krishna Consciousness (ISKCON) and the Adani Group Collaborate to ensure that nearly one lakh people are provided with nutritious meals daily during the 45-day spiritual gathering at Maha Kumbh Mela. SKCON has set up a large-scale kitchen at Harshvardhan Marg.

Russian President Vladimir Putin and Iranian President Masoud Pezeshkian signed a Comprehensive Strategic Partnership Treaty for 20 years at Moscow. The agreement seeks to enhance trade and economic ties, with bilateral trade having risen by 15.5% to \$3.77 billion between January and October 2024.

The National Broadband Mission (NBM) 2.0 aims to expand "operational" fiber connectivity to 2.7 lakh villages by 2030, from 50,000 now. The share of rural Indians who are subscribers should also grow from 45% to 60% by then.

India has ascended to the position of the world's seventh-largest coffee producer, with exports reaching \$1.29 billion in the fiscal year 2023-24, nearly doubling from \$719.42 million in 2020-21.

The introduction of coffee to India traces back to the 1600s when Sufi saint Baba Budan brought seven Mocha seeds to the hills of Karnataka.

### महत्वपूर्ण एक-पंक्ति करंट अफेयर्स

मुंबई मैराथन 2025 में इरिट्रिया के बेरहेन टेस्फे और केन्या की जॉयस चेपकेमोई टेली ने क्रमशः पुरुषों और महिलाओं की एलीट दौड जीती।

इंटरनेशनल सोसाइटी फॉर कृष्णा कॉन्शसनेस (इस्कॉन) और अदानी ग्रुप ने यह सुनिश्चित करने के लिए सहयोग किया है कि महाकुंभ मेले में 45-दिवसीय आध्यात्मिक सभा के दौरान लगभग एक लाख लोगों को प्रतिदिन पौष्टिक भोजन उपलब्ध कराया जाए। SKCON ने हर्षवर्द्धन मार्ग पर बड़े पैमाने पर रसोई स्थापित की है।

रूसी राष्ट्रपति व्लादिमीर पुतिन और ईरानी राष्ट्रपति मसूद पेज़ेशकियान ने मास्को में 20 वर्षों के लिए व्यापक रणनीतिक साझेदारी संधि पर हस्ताक्षर किए। यह समझौता व्यापार और आर्थिक संबंधों को बढाने का प्रयास करता है, जनवरी और अक्टूबर 2024 के बीच द्विपक्षीय व्यापार 15.5% बढ़कर 3.77 बिलियन डॉलर हो गया है।

राष्ट्रीय ब्रॉडबैंड मिशन (एनबीएम) 2.0 का लक्ष्य 2030 तक "ऑपरेशनल" फाइबर कनेक्टिविटी को 50,000 से बढाकर 2.7 लाख गांवों तक विस्तारित करना है। तब तक ग्रामीण भारतीयों की हिस्सेदारी भी 45% से बढकर 60% हो जानी चाहिए।

वित्त वर्ष 2023-24 में निर्यात 1.29 बिलियन डॉलर तक पहुंचने के साथ, भारत दुनिया के सातवें सबसे बड़े कॉफी उत्पादक की स्थिति में पहुंच गया है, जो 2020-21 में 719.42 मिलियन डॉलर से लगभग दोगुना हो गया है।

भारत में कॉफी की शुरूआत 1600 के दशक में हुई जब सूफी संत बाबा बुदान कर्नाटक की पहाड़ियों में सात मोचा बीज लाए।
