

- Overseas Indians deposited approximately \$12 billion in NRI deposit schemes from April to October FY25, nearly double the amount deposited the previous year (\$6.11 billion).
- In October 2024, the total outstanding NRI deposits reached \$162.69 billion, up from \$143.48 billion in October 2023.
- In October 2024, overseas Indians invested nearly \$1 billion in various NRI deposit schemes.
- FCNR (B) accounts enable NRIs to hold fixed deposits in India in freely convertible foreign currencies for one to five years.
- During April-October FY25, FCNR (B) deposits saw the most inflows, totaling \$6.1 billion, up from \$2.06 billion the previous year.
- The total outstanding FCNR (B) deposits were \$31.87 billion.

#### **Explanation:**

- India has become the global leader in Initial Public Offerings (IPOs), hosting twice as many IPOs as the United States and 2.5 times more than Europe, according to data analyzed by Pantomath Group.
- In the first 11 months of 2024, 76 companies in India raised ₹1.3 trillion through IPOs. The Pantomath report predicts that IPO fundraising in 2025 could break records, reaching over ₹2 trillion.
- For the first time, India ranked #1 globally in IPO volume, surpassing the US and Europe. India listed nearly double the number of IPOs compared to the US and 2.5 times more than Europe. However, the US still leads in total IPO proceeds (money raised), showing its market is highly attractive to global investors.
- Meanwhile, China's IPO activity dropped to its lowest in 10 years due to stricter regulations. Globally, the Technology, Media, and Telecommunications (TMT), industrials, and consumer sectors drove most IPO activity, contributing about 60% of the total IPOs.

This shows that although India leads in the number of IPOs, the US IPOs are much larger on average, raising more funds.

- In October 2024, the Reserve Bank of India (RBI) sold \$9.2 billion, its highest monthly sale in almost two years (since September 2022, when \$10.3 billion was sold).
- In October, the RBI bought and sold \$27.5 billion and \$36.7 billion of foreign currency respectively.
- The rupee fell by 0.34% in October, reaching 84 per dollar on October 11 and surpassing 85 per dollar by the end of the month.
- The RBI intervened strongly at 83.98 per dollar to control the rupee's volatility.
- In the first half of the current fiscal year (April-September), the RBI purchased \$8.52 billion.

- Adani Ports and Special Economic Zone (APSEZ) Mundra welcomed CMA CGM Fort Diamant, the first LNG-powered container vessel to berth at the port's Container Terminal-CT4.
- This vessel, 268 meters long and 43 meters wide, is the third in a line of LNG-powered ships with a capacity of 7,000 containers.
- The CIMEX2K/AS-1 service connects the Indian subcontinent and China, boosting global commerce lines.
- Adani's Mundra port is India's largest port and the showpiece of APSEZ, with cutting-edge infrastructure capable of handling vessels up to 21 meters deep and solid connectivity via highways, rail corridors, and the Dedicated Freight Corridor (DFC).
- Adani Ports and Special Economic Zone Limited (APSEZ) is India's largest commercial port operator, responsible for approximately a quarter of all cargo flow in the country.
- It has 13 domestic ports spread over seven marine states: Gujarat, Maharashtra, Goa, Kerala, Andhra Pradesh, Tamil Nadu, and Odisha.

- India marked a significant milestone in its self-reliance by delivering two warships to the Indian Navy: the destroyer Surat and the frigate Nilgiri.
- The Navy's Warship Design Bureau and MDL (Mumbai's Mazagon Dock Shipbuilders Limited) collaborated in India to design and build both ships.
- Surat's keel was placed on November 7, 2019 and launched on May 17, 2022. The Nilgiri's keel was placed on December 28, 2017 and launched on September 28, 2019.
- INS Surat is a Visakhapatnam-class destroyer with a length of 163 meters and a displacement of approximately 7,400 tons.
- INS Nilgiri is a 126-meter-long stealth frigate with a displacement of about 6,500 tons.
- The guided-missile destroyer INS Surat is the fourth and last ship in the Visakhapatnam class. Meanwhile, INS Nilgiri is the first of seven stealth-guided missile frigates in the class.





- Commercial supply of these items is planned to commence in 2027 and continue until 2032.



- The Pradhan Mantri Rashtriya Bal Puraskar is overseen by the Union Ministry of Women and Children Development. The Indian government introduced the prize in 1996.


#### **About the Pradhan Mantri Rashtriya Bal Puraskar:**

- It is given to youngsters aged 5 to 18 years for their extraordinary performance, abilities, and achievements. Each year, a maximum of 25 youngsters are honored.
- The award is offered in seven categories, which are essentially grouped into two: Child Bravery and Child Excellence.
- The Child Excellence Award is granted to children who have demonstrated extraordinary abilities and achievements in the following areas: (i) innovation (ii) arts and culture (iii) science and technology (iv) the environment (v) social service (vi) sports.

#### **IMPORTANT ONE - LINER Current Affairs**

The central government announced this amendment in the Right of Children and Free School Education Act 2010 (RTE Act 2010). The new amendments allow states to hold regular exams for the students of class 5 and 8 and hold them back if they fail. These amendments come five years after the RTE Act was amended, in 2019.



- According to the annual report of the industry regulator, as of March 2024, 11 percent of health claims were denied by Indian insurance firms, while 6 percent were still waiting.
- In the year ending March 2024, insurers rejected and "repudiated" health coverage claims totaling Rs 26,000 crore, a 19.10% rise from the previous year.
- The Insurance Regulatory and Development Authority of India (IRDAI) reports that the amount rejected in the year ending March 2023 was Rs 21,861 crore.
- When an insurance company declines to handle a claim because of certain problems with its legitimacy, it is said to be rejected or disallowed.
- This indicates that because of mistakes or inconsistencies in the policyholder's documentation, terms, or procedures, the insurer has rejected the claim altogether without having yet assessed it for coverage.
- Conversely, claim repudiation happens when the insurer rejects the claim following an examination, concluding that it does not comply with the policy's terms and conditions.
- According to the analysis, India's overall insurance penetration fell to 3.7% in 2023–2024 for the second year in a row. This is a drop from 4.2% in 2022–2023 and 4.2% in 2021–2022 during the pandemic.
- In 2023–2024, public sector insurers paid out more than they received in premiums, as evidenced by their settlement ratio of 103.38%. On the other hand, independent health insurers suffered with a low ratio of only 64.71%, while private insurers maintained a ratio of 88.71%.

  • For the year ended March 2024, life insurance firms paid out Rs 48,512 crore in death claims, up from Rs 46,380 crore the year before. The total amount paid for individual policies was Rs 28,868
- crore.

According to NPCI data, the two handled roughly 47.8% and 37.02 % of UPI transaction volumes in November, respectively.
- The deadline for current third-party application providers (TPAPs) to comply was extended by an additional two years by the apex payments authority after "considering various factors."
- Up 32.2% from 117.58 billion transactions in calendar year 2023 (CY23), UPI recorded 155.44 billion transactions as of November this year. The December 2024 numbers have not yet been released.
- In November 2020, the NPCI first suggested a 30% cap on the number of transactions that UPI apps may handle. The current players were given two years to comply with the volume cap.

- This is Pakistan's third nuclear power facility using this architecture. Two other plants, Karachi Nuclear Power Plants units 2 and 3, are already operational and supplying power to the national grid.

- Pakistan's installed nuclear energy capacity is around 3,530 MW, accounting for around 27% of total electricity generation in the national system.

- The Punjab Chief Minister, Bhagwant Singh Mann, approved the Punjab State (Development and Promotion of Sports) Act, 2024, making it the first state in the country to do so.
- Adani Ports and Special Economic Zone (APSEZ) Mundra welcomed CMA CGM Fort Diamant, the first LNG-powered container vessel to berth at the port's Container Terminal-CT4.
- Uttar Pradesh is the first state to connect its procurement process with the Centre's Govt e-Marketplace (GeM), replacing its traditional tendering system
- Masali, a village in Gujarat's Banaskantha district, has become India's first'solar village' near the border, a key milestone in the country's renewable energy efforts.
- Uttarakhand, often known as "Devbhoomi," will be the first Indian state to enact a specific Yoga Policy, aiming to make the state a global yoga destination.
- The first Ganges River Dolphin (Platanista Gangetica) has been tagged in Assam, marking a historic moment in animal conservation.
- NLC India Limited (NLCIL) and Uttar Pradesh Rajya Vidyut Utpadan Nigam Limited (UPRVUNL) partners to commence commercial operations of its 1st supercritical power plant '1980 Mega Watt (MW) Ghatampur Thermal Power Plant' (GTPP) in Uttar Pradesh.
- Dr. Jitendra Singh, Union Minister of State (Independent Charge) for Science and Technology, unveiled Kisan Kavach, India's first indigenous anti-pesticide bodysuit
- The New Delhi Indira Gandhi International (IGI) Airport has become the first airport in India to connect 150 destinations.
- The Indian Council of Medical Research (ICMR) in collaboration with the Madras Diabetes Research Foundation (MDRF) has set up the country's first diabetes biobank in Chennai.
- The Indian Council of Agricultural Research (ICAR) Indian Institute of Spices Research (IISR) introduced India's first ginger variety, "IISR Surasa," which was developed to use as a vegetable.


- The Income Tax Department has extended the deadline for the Vivad Se Vishwas Scheme 2024, offering taxpayers another chance to resolve disputes at lower tax rates.
- The new date of January 31, 2025, provides much-needed respite to those currently studying the concept. Initially scheduled for December 31, 2024, the extension avoids a 10% additional tax, resulting in a speedier settlement procedure.
- The Vivad Se Vishwas Scheme, proposed in Budget 2024, enables taxpayers to resolve pending disputes by paying a reduced amount of contested tax plus predetermined percentages.
- Applications received by January 31, 2025 will be subject to the lower rates listed in column (3) of the scheme's table. However, beginning February 1, 2025, applications will be subject to a 10% higher tax rate.
- The Vivad Se Vishwas Scheme makes dispute settlement easier by allowing taxpayers to settle issues with lower financial liability. Applications filed by January 31, 2025 will be charged at the rates shown in column (3) of the scheme's table.
- For example, new appellants must pay 100% of the challenged tax and 25% of the disputed penalty or interest if they file before the deadline. However, on February 1, 2025, these rates will increase to 110% and 30%, respectively.

- The Haryana government has agreed to enhance the maximum amount of Deathcum-Retirement Gratuity for state government employees by 25%.
- Government of India(GoI) sanctioned Rs. 4388 crore under the Pradhan Mantri Kisan Urja Suraksha evam Utthaan Mahabhiyan (PM-KUSUM) Scheme to solarize agriculture for states across India.
- Aam Aadmi Party (AAP) chief Arvind Kejriwal has launched a new scholarship programme aimed at Dalit students in Delhi. The scheme, named the Dr Ambedkar Samman Scholarship, will cover all expenses for Dalit students wishing to pursue higher education abroad.
- Delhi Chief Minister Atishi has introduced the Mukhyamantri Mahila Samman Yojana, which would pay a monthly stipend of Rs 1,000 to women residents with annual household incomes of up to Rs 3 lakh
- Gujarat, Maharashtra, and Uttar Pradesh have emerged as the top three states for rooftop solar installations under the PM Surya Ghar Muft Bijli Yojana plan. It is launched on February 15, 2024.
- West Bengal Chief Minister Mamata Banerjee has launched the "Banglar Bari" initiative, which aims to provide housing for the state's rural poor.
- Yuva Shuddhi Abhiyan Launched by Karnataka Governor Thaawarchand Gehlot to raise awareness about the dangers of drug abuse among youth.
- The Chief Minister introduced 'Him Bhog Atta,' which is prepared from maize harvested by farmers in Uttarakhand using natural agricultural practices.

Amit Aggarwal has been appointed as the Secretary, of the Department of Pharmaceuticals, Ministry of Chemicals and Fertilizers, Government of India.


