- Exto India Technologies Private Limited, situated in Chennai, was chosen to participate in the initiative's 'Test Phase'.
- The company tested an offline digital payment solution that combines Distributed Ledger Technology (DLT) with private biometric authorization, allowing for offline card-to-card and card-to-phone transactions.







- The Reserve Bank of India (RBI) has approved Tata Communications' intention to sell its full stake in Tata Communications Payment Solutions (TCPSL) to Transaction Solutions International (TSI), the Indian subsidiary of Findi, an Australian fintech business
- Reserve Bank of India (RBI), conducted a dollar-rupee buy/sell swap FX swap auction for USD 5.1 billion
- The Reserve Bank of India (RBI) has granted RMBS (Residential Mortgage-Backed Securitisation) Development Company Limited (RDCL) a Certificate of Registration (CoR), a significant milestone for India's housing finance sector
- The Reserve Bank of India (RBI) plans to inject approximately Rs 1.5 lakh crore into the banking system gradually
- According to the Reserve Bank of India's Payments System Report, the United Payments Interface (UPI) would account for 83% of total payment volume by 2024, up from 34% in 2019.
- According to the Reserve Bank of India's Annual Report on Ombudsman Scheme, the integrated Ombudsman Scheme received 32.81% more complaints from banking customers in FY2024, totaling 9.34 lakh.
- Business correspondents (BCs), who process millions of crores of rupees daily in domestic remittances, have urged RBI to ease the 14-year-old restrictions on monthly and daily transactions. They have asked the RBI to increase the monthly transfer limit to Rs.50,000.
- RBI has updated instructions for settling dues owed by borrowers to Asset Reconstruction Companies (ARCs) under the Master Direction-Reserve Bank of India (Asset Reconstruction Companies), 2024.
- Skydo Technologies, a cross-border payments startup, has been granted inprinciple authorization from the Reserve Bank of India (RBI) to function as a Payment Aggregator-Cross Border entity.
- The RBI has revealed the names of the members of the Standing External Advisory Committee (SEAC), which will evaluate applications for Universal Banks and Small Finance Banks. The **SEAC's** tenure will be three years.







- ATM interchange rates were last revised in August 2012, with consumer charges updated in August 2014.





- The PMRF plan, which was introduced in Budget 2018-19, offers direct admission to PhD studies at IITs, IISc, and IISERs, as well as substantial financial support.
- The PMRF initiative has recently been expanded to cover eligible students from all recognised Indian institutes and universities. Additionally, students doing MTech at AICTE-approved and centrally supported technical institutions (CFTIs) earn a monthly stipend of Rs 12,400.


- Air India and Kenya Airways Limited signed a Codeshare agreement to expand its network and offer more travel options for passengers.

- She won her first major slam at the French Open in 2018, and then her second at Wimbledon in 2019.




- The government will establish a second Gene Bank with 10 lakh germplasm lines in order to safeguard genetic resources while also ensuring food and nutritional security.
- This aims to help the public and private sectors conserve genetic resources while also ensuring future food and nutritional security.
- A gene bank collects and maintains genetic material such as seeds, tissues, and **DNA** samples from various plant and animal species.
- Established in 1972, the International Crops Research Institute for the Semi-Arid Tropics (ICRISAT) Genebank is a well-known institution dedicated to the preservation and protection of crop genetic resources.
- ICRISAT Genebank is an important institution that protects the genetic diversity of 11 critical crops, including millet, chickpea, pigeon pea, and groundnut. It has facilities in India, Zimbabwe, Niger, and Kenya.
- In 2019, ICRISAT established the world's first gene bank in Hyderabad, powered solely by solar energy.
