- Equitas Small Finance Bank has been fined Rs 65 lakh by the RBI for failing to comply with key guidelines on 'Levy of Foreclosure Charges/Pre-payment Penalty on Floating Rate Term Loans' and 'Credit Flow to Agriculture — Collateral-free agricultural loans'.
- India Post Payments Bank Ltd has been fined Rs 26.70 lakh for failing to comply with specific 'Customer Service in Banks' guidelines.
- Aptus Finance India Pvt Ltd has also received a Rs 3.10 lakh penalty for violating certain non-banking financial business standards.
- The fines are based on inadequacies in regulatory compliance and are not meant to determine the legitimacy of any transaction or agreement entered into by the firms with their consumers.
















#### Recent Penalties imposed on Banks by RBI:

- The Insurance Regulatory and Development Authority of India (IRDAI) issued a Rs.1 crore penalty on Royal Sundaram General Insurance for violating outsourcing standards
- RBI Fines Canara (Rs.1.63 crore), BOI (Rs.1 crore), and J&K Bank (Rs.3.31 crore) for Non-Compliance
- RBI has terminated the registration of X10 Financial Services Ltd, a non-banking financial company (NBFC), citing irregularities in its digital lending operations.
- IndusInd Bank Limited was fined Rs.27.30 lakh by the Reserve Bank of India (RBI) for not following the 'Reserve Bank of India (Interest Rate on Deposits) Directions, 2016'.
- The Reserve Bank of India issued a monetary penalty of Rs.5 lakh on The Panchkula Central Co-operative Bank Limited, Haryana.
- Penalty of Rs 59.20 lakh Imposed on South Indian Bank by RBI Due to noncompliance with directives on interest rate on deposits and customer service standards.
- The Reserve Bank of India (RBI) issued a penalty of Rs 28.30 lakh on SG Finserve **Limited** (previously Moongipa Securities).
- Arunachal Pradesh Rural Bank received a Rs 14 lakh penalty for failing to comply with Prudential Norms (Provisioning, Asset Classification, and Exposure Limit).
- The Reserve Bank of India (RBI) imposed a monetary penalty of Rs.61.60 lakh on The Surat People's Co-operative Bank Limited, Surat, for non-compliance with certain directions issued by RBI.
- The RBI imposed a monetary penalty of Rs.1.50 lakh on The Bihar Awami Cooperative Bank Ltd., Patna for violating section 26A and section 56 of the Banking Regulation Act, 1949 (BR Act) and failing to comply with RBI's 'Know Your Customer (KYC)' directions.



- Gongadi Trisha, an Indian batter, scored the most runs in this World Cup, earning Player of the Tournament honors. Vaishnavi Sharma, on the other side, became the leading wicket-taker with 17 in six matches, including a hat-trick.
- India won the title in the maiden edition in 2023, defeating England by seven wickets in the final.

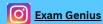




















- Onchocerciasis is a parasite illness spread by black flies that mostly affects rural communities in Sub-Saharan Africa, Yemen, and parts of Latin America.
- From 2008 to 2019, Niger's eradication efforts included vector control (insecticide spraying) and mass drug administration (MDA) with ivermectin and albendazole.
- Following rigorous control measures and medicinal therapies, the prevalence of onchocerciasis in Niger decreased from around 60% to 0.02%.
- Niger joins four other countries in the Americas that have been recognized by WHO as having eliminated onchocerciasis: Colombia (2013), Ecuador (2014), Guatemala (2016), and Mexico (2015).

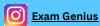
