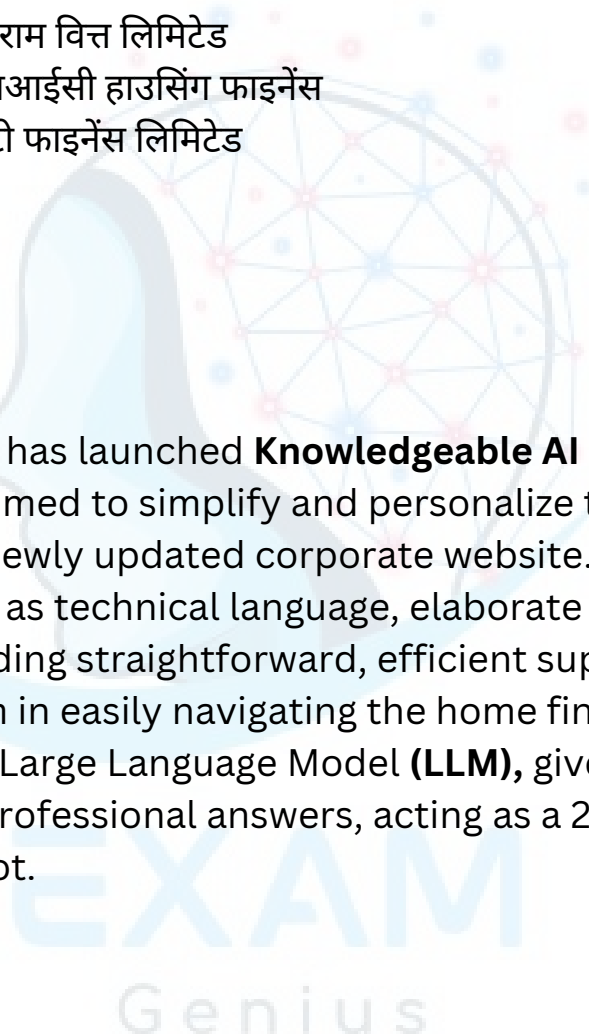

- This increased ceiling would be accessible for enterprises that invest their entire premium in India.
- The change is expected to attract more players and eventually contribute to the goal of '**Insurance for All**' by 2047. The addition of more businesses into the industry would not only increase penetration but also result in more job creation across the country.
- Currently, India has 25 life insurance businesses and 34 non-life or general insurance organizations. These include companies such as Agriculture Insurance Company of India Ltd and ECGC Ltd.

- Tax Savings for Rs.12 Lakh Income – A taxpayer earning Rs.12 lakh will benefit from Rs.80,000 in tax savings under the new regime.

- Tax Savings for Rs.25 Lakh Income – A taxpayer with Rs.25 lakh income will get a tax benefit of Rs.1.10 lakh.
- The revision in tax slabs is aimed at providing significant relief to taxpayers and encouraging economic growth.

- The Budget 2025-26 allocates ₹20,000 crore as 'revenue expenditure' for the PM Surya Garh Muft Bijli Yojana (**PMSGMBY**), which offers incentives for installing small-scale rooftop solar plants on residential roofs.
- The revised forecasts for 2024-25 boosted the budget from Rs.6,250 crore to Rs.11,100 crore, representing a significant increase. The nearly doubling of updated estimates over the anticipated amount for 2024-25 demonstrates that the strategy performed successfully.
- As a result, the government has increased the scheme's allocations by 80% over the revised forecasts for the previous year.
- The PMSGMBY, begun in February 2024, has a 4-year investment of Rs.75,021 crore and aims to construct 10 million small-size residential rooftops. As of December 2024, around 700,000 installations had been completed.
- If the money budgeted for 2025-26 is fully spent, it would mean that up to Rs.31,100 crore, or 41% of the program outlay, will be spent in the first two years.

- It is made up of directors from IIT and IIM Mumbai, representatives from Google India, Mahindra Group, and L&T, and officials from the Ministry of Electronics and Information Technology, Government of India.
- The task committee also includes experts from the Rajiv Gandhi Science and Technology Commission and India's Data Security Council.

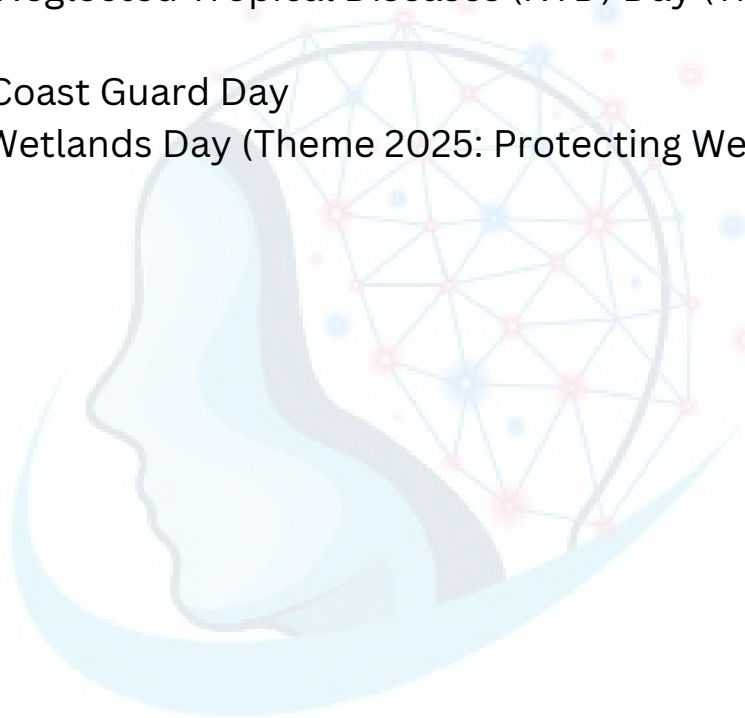
