Explanation :

- CRED has become the first fintech startup to introduce a beta version of its e-rupee wallet, which allows for transactions using India's central bank digital currency (CBDC).
- This project builds on the Reserve Bank of India's (RBI) plan to widen access to CBDC-Retail by allowing non-bank payment system operators to support digital currency transactions.
- The e-rupee wallet is intended to improve financial inclusion and streamline digital payments in India.
- Yes Bank will be the first sponsor bank to provide CBDC issuing for a third-party application provider such as CRED.
- CRED's e-rupee wallet allows transactions up to Rs.10,000 per transfer, with a daily transaction limit of Rs.50,000 and storage capacity of Rs 1 lakh. These will be fee-free merchant transactions.
- Future improvements will include programmable merchant payments, CRED Pay integration, and PIN-less transactions under Rs.500 for all CRED members in the coming months.

- **MobiKwik, one of India's leading digital wallet providers, has unveiled a fully operational version of India's Central Bank Digital Currency (CBDC) e-rupee wallet in collaboration with the Reserve Bank of India and Yes Bank.**
- **All MobiKwik Android users now have access to the e-rupee wallet, which allows for smooth peer-to-peer (P2P) and peer-to-merchant (P2M) transactions. The wallet is fully UPI compatible, so users may make payments by scanning any UPI QR code.**
- **Existing MobiKwik users who have completed the Know Your Customer (KYC) process can quickly open an e-rupee wallet and transfer funds from their bank accounts.**
- **To gain access to the functionality, new customers must first pass a video KYC process.**
- **The wallet supports transactions worth up to Rs 50,000 per day, with a single-transaction limit of Rs 10,000. It accepts denominations ranging from Rs 0.50 to 500.**

- The Odisha Warriors Club won the inaugural Women's Hockey India League 2024-25 title by defeating Soorma Hockey Club 2-1 in the final at the Marang Gomke Jaipal Singh Munda Astro Turf Hockey Stadium in Ranchi
- The 38th National Games will be held in Dehradun, Uttarakhand, during its Silver Jubilee year, with events taking place in 11 cities across 8 districts from January 28th to February 14th
- Indian Grandmaster Iniyen Panneerselvam showcased an exceptional performance to win the 9th Johor International Open Chess Tournament in Malaysia. Indian IM VS Raahul and Chinese IM Li Bo finished second and third respectively

- The Government of India has formed a Group of Ministers to address concerns about the viability of the country's power distribution utilities.
- Shripad Yesso Naik, Union Minister of State for Power, New and Renewable Energy, chairs the Group of Ministers.

The Group of Ministers will study and provide suggestions to the government on the following issues :

- Analyze the debt of electricity distribution boards in significant Indian states.
- Identify states in urgent need of liquidity support (cash) and propose a fiscal discipline program to help them avoid a debt trap.
- Suggest ways to strengthen the overall health of the power distribution sector in order to attract additional investment from private participants.
- Determine which parameters should be examined to ensure that power distribution utilities' borrowings are productive.
- Recommend principles for investment programs that include capital expenditures aimed at overall improvement.

- India and Oman signed a protocol to alter their Double Taxation Avoidance Agreement (DTAA) and agreed to expedite negotiations for the early signing of the Comprehensive Economic Partnership Agreement (CEPA).
- The pact to revise the DTAA to match it with worldwide cross-border taxation norms, simplify tax procedures, and promote greater tax cooperation was signed on the margins of Commerce and Industry Minister Piyush Goyal's visit to Muscat.
- In 1997, both countries signed the DTAA agreement. The modifications could help commerce, which is projected to rise once the CEPA between the two sides is finalized.
- During the visit, Goyal co-chaired the 11th session of the India-Oman Joint Commission Meeting (JCM) with the Sultanate of Oman's Minister of Commerce, Industry, and Investment Promotion, Qais bin Mohammed Al Yousef.





Recent News Headlines Related to MoU and agreement :

- The Directorate General of Shipping (DGS) and the Centre for Development of Advanced Computing (C-DAC), a Scientific Society under Ministry of Electronics and Information Technology (MeitY) signed an umbrella MoU to advance technological innovation and excellence in India's maritime sector
- The JSW Group, led by Sajjan Jindal, has inked an MoU with the Odisha government to build a 5-million-tonne steel facility in Keonjhar district.
- National Institution for Transforming India (NITI Aayog) and the National Association of Software and Service Companies (NASSCOM) Foundation Signed MoU to provide digital skills to one lakh individuals with an aim to reduce the issue of digital divide.
- The Department for Promotion of Industry and Internal Trade (DPIIT) has signed a Memorandum of Understanding (MOU) with the Bhaane Group, a subsidiary of Shahi Exports Pvt Ltd, the largest garment producer
- NTPC Limited and Ceylon Electricity Board of Sri Lanka signed MoU to develop a 50 Megawatt (MW) (extendable to 120 MW) solar project in Sampoor, Trincomalee, Sri Lanka.
- JSW Group and Maharashtra government Signed MOU to invest Rs.3 lakh crore across various sectors in Maharashtra, including in the naxal-infested Gadchiroli. The commitment aligns with Maharashtra's 'Green Maharashtra' mission.
- DPIIT and Apna platform have formed an alliance to conduct a talent search to provide DPIIT-registered startups with highly skilled personnel, thereby creating new job opportunities for unemployed youth.
- The Government of Odisha's Electronics and IT Department and Singapore's Global Finance & Technology Network (GFTN) have signed a MOU to establish a Global Competency Centre in Bhubaneshwar to foster FinTech collaboration, with a focus on developing inclusive and sustainable InsureTech and related areas.
- International Society for Krishna Consciousness (ISKCON) and the Adani Group Collaborate to ensure that nearly one lakh people are provided with nutritious meals daily during the 45-day spiritual gathering at Maha Kumbh Mela. ISKCON has set up a large-scale kitchen at Harshvardhan Marg.
- Russian President Vladimir Putin and Iranian President Masoud Pezeshkian signed a Comprehensive Strategic Partnership Treaty for 20 years at Moscow. The agreement seeks to enhance trade and economic ties, with bilateral trade having risen by 15.5% to \$3.77 billion between January and October 2024

- On Republic Day, Telangana Chief Minister A. Revanth Reddy introduced his government's four welfare schemes--Rythu Bharosa, Indiramma Atmiya Bharosa, Indiramma Indlu, and new ration cards.
- Chief Minister Reddy announced the initiative in Chandravanch village, Narayanpet district.

About the schemes :

- Rythu Bharosa : Eligible farmers would receive cash support of Rs. 12,000 per acre of arable land. The funds will be credited to the farmer's bank account.
- Indiramma Aathmeeya Bharosa : Financial assistance of Rs. 12,000 per year would be provided to landless agricultural labour families.
- Indiramma Indlu : housing initiative for homeless Dalits, Tribals, and Backward Classes. They would receive Rs 5 lakh in financial support to build their homes. The government has set an aim of constructing 4,50,000 dwellings by 2024-2025, with a budget of Rs 22,500 crore.



Recent News Headlines Related to Schemes

- The MoF announced the Unified Pension Scheme (UPS) as an option for central government employees who are already covered by the National Pension System (NPS).
- The Sukanya Samriddhi Yojana (SSY), launched by Prime Minister Narendra Modi on January 22, 2015, has been providing financial security to India's girl children for ten years.
- Chhattisgarh Chief Minister Vishnu Deo Sai has launched the 'Deendayal Upadhyay Bhoomiheen Krishi Majdoor Kalyana Yojana' in Raipur. Under this initiative, more than 5.62 lakh landless agricultural workers, Baigas, and Gunias in the state will receive Rs 10,000 each year.
- PARTH Yojana (Police Army Recruitment Training & Hunar) Launched by Madhya Pradesh To prepare youth for recruitment into Indian Army, Police, ParaMilitary forces, and related services.
- Mohan Charan Majhi, Chief Minister of Odisha announced Shahid Madho Singh Haath Kharcha Scheme with a budget of Rs 156 crore to support tribal students. Its aims is to reduce dropout rates and increase students' interest in education.
- PLI scheme for Specialty Steel, termed as PLI Scheme 1.1 Launched by Union Minister of Steel and Heavy Industries, Shri H. D. Kumaraswamy at Vigyan Bhavan New Delhi. It is launched for the Period of FY 2025-26 to FY 2029-30.
- The Mira Bhayandar Municipal Corporation (MBMC) has developed a flagship initiative named 'Faral Sakhi' to encourage women entrepreneurs in the city of Mira Bhayandar, Maharashtra.
- The Union Cabinet, led by Prime Minister Narendra Modi, has approved the extension of the Pradhan Mantri Fasal Bima Yojana and Restructured Weather Based Crop Insurance Scheme until 2025-26, with a total budget of Rs.69,515.71 crore from 2021-22 to 2025-26.
- The Income Tax Department has extended the deadline for the Vivad Se Vishwas Scheme 2024, offering taxpayers another chance to resolve disputes at lower tax rates. The extended new date is January 31, 2025.
- The Haryana government has agreed to enhance the maximum amount of Death-cum-Retirement Gratuity for state government employees by 25%.
- Government of India (GoI) sanctioned Rs. 4388 crore under the Pradhan Mantri Kisan Urja Suraksha evam Utthaan Mahabhiyan (PM-KUSUM) Scheme to solarize agriculture for states across India.

Explanation :

- Indian Air Force Group Captain Shubhanshu Shukla will be the first Indian astronaut to travel to the International Space Station (ISS) on a private mission.
- Shukla will fly on a SpaceX Dragon spacecraft from the Kennedy Space Center in Florida as part of NASA's Axiom Mission 4 (Ax-4), a collaborative effort with ISRO.
- Shukla was born on October 10, 1985, in Lucknow, Uttar Pradesh. He was commissioned into the Indian Air Force (IAF) Fighter Wing in 2006 and received astronaut training in Moscow in 2019.
- Peggy Whitson, a former NASA astronaut, will command the Ax-4 mission. Shukla will pilot the team, alongside mission specialists Slawosz Uznanski-Wisniewski (Poland) and Tibor Kapu (Hungary).
- The crew will stay on the ISS for up to 14 days, undertaking scientific investigations, educational outreach, and commercial operations with NASA and ISRO.
- The Ax-4 project marks the first collaboration between India, Poland, and Hungary in space, with Poland and Hungary returning to human spaceflight after more than 40 years.

- Tata Steel has become the first Indian company to manufacture hydrogen transportation pipes, helping India achieve its sustainable energy aspirations.
- The company's hydrogen-compliant API X65 pipes were manufactured at Tata Steel's Khopoli factory utilizing steel from its Kalinganagar facility.
- Tata Steel oversaw the whole production process, from designing and manufacturing hot-rolled steel to making the finished hydrogen transit pipes.
- India expects to create at least 5 MMT of green hydrogen per year by 2030, with the potential to increase to 10 MMT per year, necessitating modern transportation infrastructure such as Tata Steel's pipes.
