- Union Defence Minister Rajnath Singh opened Asia's largest 15th Aero India event in Bengaluru. The five-day expo, themed "**Runway to a Billion Opportunities**"
- The MoD secured defence contracts worth Rs 10,147 crore to strengthen the Indian Army's firepower
- The Indian Navy's First Training Squadron (1TS) ships, INS Sujata, INS Shardul, and ICGS Veera, have landed at Changi Naval Base in Singapore for Long-Range Training Deployment to Southeast Asia
- The Indian Army renamed Kolkata's Fort William, the headquarters of its Eastern Command, Vijay Durg as part of the Central Government's anti-colonial activities

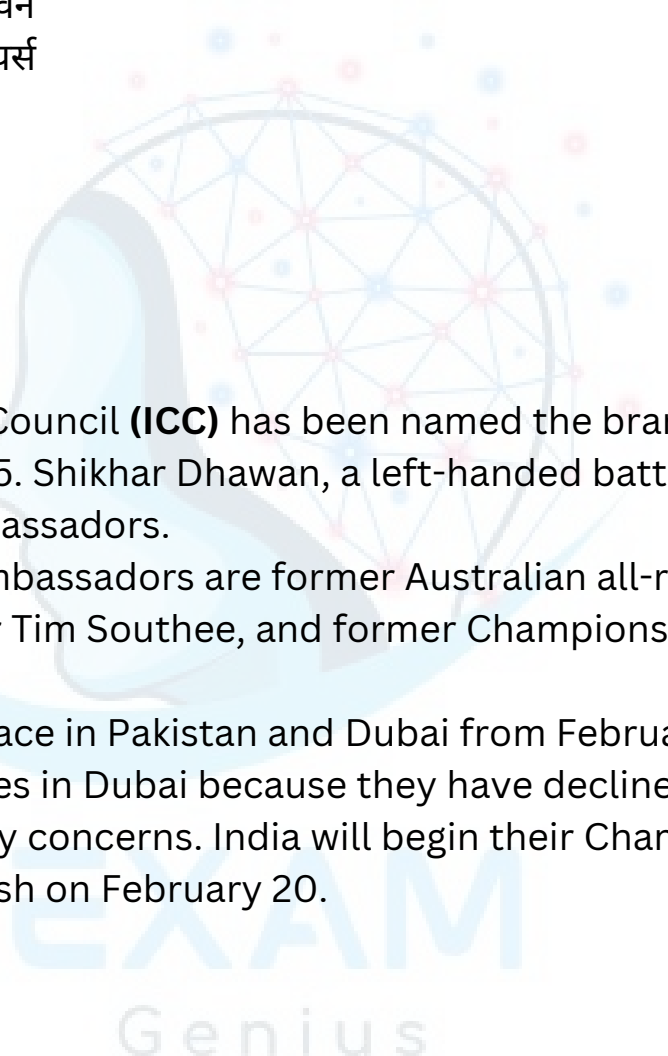

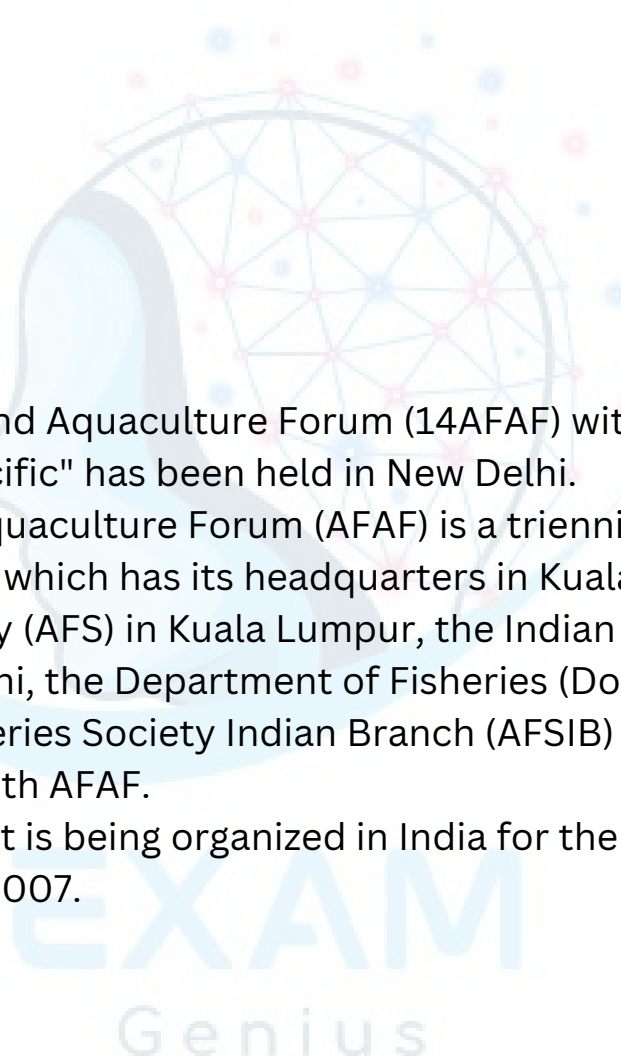

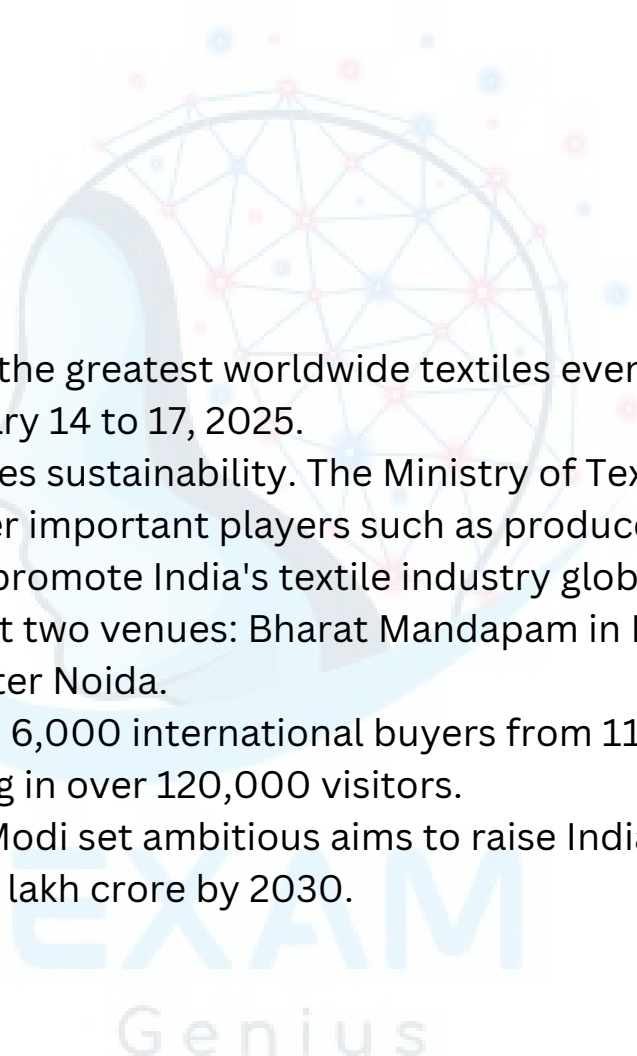
