- RBI has updated instructions for settling dues owed by borrowers to Asset Reconstruction Companies (ARCs) under the Master Direction-Reserve Bank of India (Asset Reconstruction Companies), 2024.
- The amended instructions were published through a circular under Sections 9 and 12 of the SARFAESI Act, 2002 (54 of 2002).
- Borrowers with more than 1 crore outstanding dues would have their proposal reviewed by an Independent Advisory Committee (IAC) before settlement.
- Borrowers with outstanding dues of Rs 1 crore or less might get settlement approval from a non-acquisition officer.


- The RBI has revealed the names of the members of the Standing External Advisory Committee (SEAC), which will evaluate applications for Universal Banks and Small Finance Banks. The SEAC's tenure will be three years.
- The Reserve Bank of India (RBI) has published the list of Non-Banking Finance Companies (NBFCs) in the Upper Layer (UL) category under Scale-Based Regulation (SBR) for FY24-25.
- RBI in cooperation with the government, has proposed amendments to the existing Foreign Exchange Management Act (FEMA) regulations to encourage cross-border transactions in the Indian rupee (INR) and local / national currencies.
- RBI has instructed banks and other regulated entities (REs) to use the '1600xx' phone numbering series exclusively for making transactional calls to customers.
- HSBC India, the Indian arm of London-based HSBC, has received approval from the Reserve Bank of India (RBI) to open 20 branches in 20 cities.
- The RBI will conduct daily Variable-Rate Repo (VRR) auctions until further notice. This measure will increase banking liquidity amid the deficit.
- The RBI has implemented new credit reporting rules. Lenders are now required to update credit bureau information every 15 days, rather than monthly. This directive went into force on January 1, 2025.
- The Reserve Bank Innovation Hub and IIMA Ventures have launched Swanari TechSprint 3.0, a program targeted at fostering women-centric financial firms in India.
- The RBI lifted the supervisory restrictions imposed on two non-banking financial companies (NBFCs) - Asirvad Micro Finance Limited and DMI Finance Private Limited.
- The Reserve Bank announced the winners of its 3rd Global Hackathon, themed 'Zero Financial Frauds' and 'Being Divyang Friendly'.
- The RBI has declared that the interest rate for RBI Floating Rate Savings Bonds (Taxable) FRSB 2020 (T) will stay at 8.05% from January 1 to June 30, 2025
- The Reserve Bank of India (RBI) lifted business restrictions on Arohan Financial Services Limited, a microfinance institution situated in Kolkata (West Bengal), after the lender implemented remedial steps and committed to fair loan pricing.
- HDFC Bank, India's largest private sector lender, has received the Reserve Bank of India's (RBI) approval to acquire up to a 9.5% stake in Kotak Mahindra Bank, AU Small Finance Bank, and Capital Small Finance Bank.
- The Reserve Bank of India has approved a voluntary merger between The National Co-operative Bank Ltd., Bangalore (Karnataka) and Cosmos Co-operative Bank Limited (Maharashtra).





- Skydo has received Payment Service Provider (PSP) clearance from Amazon, allowing it to process payments for exporters participating in the Global Selling program.

Criteria for payment aggregator-cross border (PA-CB) licence:


- In October 2023, the RBI released a circular mandating minimum net worth standards for non-banks operating as PA-CBs.
- Applicants must have a net worth of Rs 15 crore at the time of application and Rs 25 crore by March 31, 2026, as per the regulations.
- New non-banks must have a net value of Rs 25 crore by the end of the third financial year after authorization.



- The Paris Agreement, signed in 2015, is a global agreement aimed at keeping global warming to far below 2°C above pre-industrial levels, with efforts to restrict the increase to 1.5°C.
- The pact encourages countries to establish and meet their own emission-reduction objectives, known as Nationally Determined Contributions.
- The United States is the second-largest source of greenhouse gas emissions. Its decision to extract, consume, and export additional fossil fuels may nullify even this 2% reduction.

- India presently has approximately 1.59 lakh firms recognized by the DPIIT, and by January 15, 2025, it will have firmly established itself as the world's third-largest startup ecosystem.
- According to official data, this thriving ecosystem, led by over 100 unicorns, is continuing to reinvent innovation and entrepreneurship on a global scale.


- The Government of Odisha's Electronics and IT Department and Singapore's Global Finance & Technology Network (GFTN) have signed a MOU to establish a Global Competency Centre in Bhubaneshwar to foster FinTech collaboration, with a focus on developing inclusive and sustainable InsureTech and related areas.
- International Society for Krishna Consciousness (ISKCON) and the Adani Group Collaborate to ensure that nearly one lakh people are provided with nutritious meals daily during the 45-day spiritual gathering at Maha Kumbh Mela. ISKCON has set up a large-scale kitchen at Harshvardhan Marg.
- Russian President Vladimir Putin and Iranian President Masoud Pezeshkian signed a Comprehensive Strategic Partnership Treaty for 20 years at Moscow. The agreement seeks to enhance trade and economic ties, with bilateral trade having risen by 15.5% to \$3.77 billion between January and October 2024
- Government of Uttarakhand and Icelandic company Verkis Consulting Engineers (Verkis) signed an MOU for geothermal exploration and development in Uttarakhand. Under the agreement, feasibility studies for these projects will be funded by the Government of Iceland
- Amazon has inked a deal to acquire fintech loan start-up Axio, formerly Capital Float, for around \$190-200 million.
- Department for Promotion of Industry and Internal Trade (DPIIT) and ITC Limited signed MOU to accelerate startup growth and technological advancement besides creation of viable market opportunities for startups across the country.
- India and Spain have signed two MOU to promote and expand their bilateral relations. These agreements prioritized sports collaboration and sustainable urban development. both countries agreed to mark 2026 as the "Year of Culture, Tourism, and Artificial Intelligence (AI)"
- Bharat Heavy Electricals Limited (BHEL) and Oil & Natural Gas Corporation Limited (ONGC) Signed MoU to explore collaboration in the area of New and Renewable Energy (NRE) sector

- The Cabinet Committee on Economic Affairs (CCEA), chaired by Prime Minister Narendra Modi, has approved the Minimum Support Prices (MSP) for Raw Jute for the marketing season 2025-26.
- The MSP for raw jute (TD-3 grade) has been set at Rs.5,650/- per quintal for the 2025-26 season. This would result in a return of 66.8% over the all-India weighted average cost of production.
- The authorized MSP for raw jute for the marketing season 2025-26 is consistent with the premise of setting MSP at at least 1.5 times the all-India weighted average cost of production, as announced by the government in the Budget 2018-19.
- The MSP of raw jute for the marketing season 2025-26 has increased by Rs.315/- per quintal over the previous marketing season 2024-25.
- The Government of India increased the MSP of raw jute from Rs.2400/- per quintal in 2014-15 to Rs.5,650/- per quintal in 2025-26, representing a 2.35-fold increase.
