- Muthoot Finance, a finance and insurance firm, has received approval from the RBI to open 115 new branches.
- The corporation is also urged to make appropriate arrangements for the security and storage of gold jewellery, including a safe deposit vault, as specified in the existing guidelines, to the extent applicable.
- Muthoot Finance reported a 21% growth in consolidated PAT in Q3 FY25 to Rs.1,392 crore from Rs.1,145 crore in Q3 FY24.

Explanation :

- SEBI, the capital markets regulator, has imposed penalties totaling Rs 50 lakh on three foreign portfolio investors for breaching the short-term investment restrictions in debt securities.
- In three separate rulings, the regulator fined Nexpect Ltd and AIRD Investment Commercial LLC Rs 20 lakh apiece, while imposing a Rs 10 lakh penalty on Aviator Global Investment Fund.
- The orders came after Sebi inspected the custodian, Orbis Financial Corporation, during FY22.
- The regulator found that Aviator Global Investment Fund, Nexpect Ltd, and AIRD Investment Commercial LLC's investments in debt instruments did not meet the allowed limits (in terms of residual maturity) for FPIs as of March 31, 2022.





Recent News Headlines Related to SEBI

- The Securities and Exchange Board of India (SEBI) has canceled the registrations of 19 foreign venture capital institutions (FVCI) after investigations revealed that they had violated capital market rules
- 'MITRA' (Mutual Fund Investment Tracing and Retrieval Assistant) Launched by SEBI to help investors trace their unclaimed or inactive mutual fund folios
- SEBI is planning to introduce a new financial product that combines Mutual Funds (MFs) investments with Term Life Insurance (TLI)
- On India's 76th Republic Day, the Securities and Exchange Board of India (SEBI) launched 'Dharohar - Milestones in the Indian Securities Market,' a digital knowledge repository
- SEBI, the market regulator, has created a web-based site for stock exchanges and other market infrastructure institutions to submit preliminary and final root cause analysis (RCA) reports on technical issues
- SEBI has collaborated with the National Institute of Securities Markets (NISM) to offer an e-learning course on municipal bonds.
- Sebi has made significant modifications to the nomination requirements for mutual funds and demat accounts to reduce unclaimed assets.
- According to SEBI Chairperson Madhabi Puri Buch, total capital market fundraising in FY2025 is likely to increase by 21% to Rs.14.7 lakh crore from Rs.11.8 lakh crore in FY2024.
- Cosmea Financial Holdings (CFH) Private Limited, led by Sam Ghosh, was granted approval by the SEBI to sponsor a Mutual Fund (MF). CFH plans to invest Rs 200 crore (USD 23.3 million) in its Asset Management Company (AMC).
- SEBI, the market regulator, slapped a Rs 54 lakh penalty on Jaiprakash Power Ventures, its MD and CEO Suren Jain, and other key personnel for falsifying the company's financial statements.
- SEBI has extended the prohibition on future trade of seven agricultural commodities until January 2025: soybeans and their derivatives, crude palm oil, wheat, rice (non-basmati), moong, chana, and mustard seeds.
- SEBI has urged stock exchanges, clearing organizations, and depositories to implement a common strategy for sharing data used in research and research publications conducted by approved academic institutions.

- SEBI imposed a total penalty of Rs 5.05 crore on Indian Clearing Corporation (ICCL), a wholly owned subsidiary of the BSE, for alleged violations of cyber security and system auditing standards.
- The market regulator performed an inspection from December 2022 to July 2023, after which it issued the show-cause notice in October.
- According to Sebi's findings, ICCL submitted the network auditor report to the regulator with no comments from management or the board.
- The requirements require that the audit report, along with management comments, be presented to the governing board of market infrastructure institutions. The same, together with the board's comments, must be reported to Sebi within one month of the audit's completion.

- This program transforms a former naval warship into an underwater museum and artificial reef, making it a first for India.
- The ship was handed over in Karwar to MTDC on a 'as is where is' basis.
- The ex-INS Guldar was built in Poland and commissioned in the Indian Navy on December 30, 1985.
- It operated in the Eastern Naval Command until 1995, then in the Andaman and Nicobar Command until its deactivation on January 12, 2024.
- Several military boats in India have been converted into museums, including the underwater museum INS Kursura near Visakhapatnam and the museum INS Vikrant, which was recommissioned in 2022.

- The 200 MW Solar Project is part of a 500 MW Agreement signed in 2023 with MP Power Management Company Limited (MPPMCL) for a 25-year period under which SECI will sell electricity to the state.

- The Nayab Singh Saini-led BJP government announced the "Haryana Witness Protection Scheme, 2025" to protect witnesses as the state prepares to adopt three new criminal legislation.
- The system will apply to witnesses to offences punished by death, life imprisonment, or imprisonment for seven years or more.
- It will also address sanctions under Sections 74, 75, 76, 77, 78, and 79 of the Bharatiya Nyaya Sanhita, as well as Sections 8, 10, 12, 14, and 15 of the Protection of Children from Sexual Offences (POCSO) Act, 2012.
- According to a government official, the system will divide witnesses into three categories based on their perceived threat level.
- Category A comprises situations in which the witness's life, the lives of their family members, or any other individual in whom the witness is interested, is threatened during or after the inquiry or trial.
- Category B instances contain threats to the witness's safety, reputation, or property, as well as their family members, whereas category C cases involve moderate threats, such as harassment or intimidation of the witness, their family members, and so on.

- Gulveer Singh, who won bronze in the Hangzhou Asian Games, became the first Indian to break the 13-minute mark in the men's 5000 metre indoor race.
- The top-seeded Indian duo of Jeevan Nedunchezhiyan and Vijay Sundar Prasanth won the men's doubles title at the Pune ATP Challenger 100. They defeated the second-seeded Australian pair of Blake Bayldon and Matthew Romios.
- A 20-year-old Indian student Vishvaa Rajakumar has made headlines by winning the Memory League World Championship, an intense online competition where participants compete in rapid memorisation challenges
- Md Shami, India's star bowler, reached a historic milestone by taking three wickets in India's first match against Bangladesh in the ICC Champions Trophy 2025 in Dubai, bringing his total to 200 in one-day international cricket
- The 34th ITTF-ATTU Asian Cup table tennis competition begins in Shenzhen, China.
- The 9th Asian Winter Games were place in Harbin, Heilongjiang Province, China. China won the most medals, with 85 (32 gold, 27 silver, and 26 bronze)
- The first edition of the Olympic Esports Games, a landmark event both in the world of esports and within the Olympic Movement, will be held in 2027 in Riyadh, Saudi Arabia
