
- PM Surya Ghar: Muft Bijli Yojana (PMSGMBY), the world's largest home rooftop solar scheme, has reached an important milestone by completing 10.09 lakh installations across the country as of March 10, 2025.
- This ambitious project, inaugurated by PM Modi on February 13, 2024, intends to deliver free electricity to 1 crore residential families via rooftop solar systems, reducing reliance on traditional power sources and empowering residents to become energy producers.
- The program allows each family to contribute to climate change mitigation by lowering carbon emissions equivalent to planting 100 trees.
- Under PM Modi's leadership, a fundamental aspect of the PM Surya Ghar: Muft Bijli Yojana is the availability of collateral-free loans through 12 Public Sector Banks (PSBs) at a subsidized interest rate of 6.75% for loans up to Rs.2 lakhs, making rooftop solar systems more accessible to the general public.
- With the easy financing arrangement, a 3 KW rooftop solar system could be constructed with an investment as low as Rs.15,000/-, yielding returns up to Rs.15 lakh over 25 years.
- Notably, Chandigarh and Daman & Diu have met 100% of their governmentmandated rooftop solar targets, leading the country in clean energy adoption. States such as Rajasthan, Maharashtra, Gujarat, and Tamil Nadu also perform admirably, contributing significantly to total installation figures.

- The area is also well connected to National Waterway-1 and approximately 30 kilometers from Lal Bahadur Shastri Airport, ensuring reliable transportation for both local and international trade.
- The project is intended to produce significant investment opportunities and job creation, hence bolstering India's logistics sector.

- The bond is issued at a discount of Rs.49,546 for a face value of Rs.1 lakh, meaning an investor pays Rs.50,454 at issuance and receives Rs.1 lakh at maturity.
- These bonds have a maturity period of 121 months (10 years and 1 month).
- The total number of bonds issued has been capped at 10 lakh as per the government's notification.







- The Sovereign Gold Bond Scheme was introduced to encourage investments in digital gold and reduce reliance on physical gold.



- The Program is consistently working toward its aim of eliminating tuberculosis by 2025. The number of missing cases has been reduced from 15 lakh in 2015 to 2.5 lakh by 2023.
- The program was able to notify 25.5 lakh tuberculosis and 26.07 lakh cases in 2023 and 2024, the highest ever.
- A shorter and safer oral Bedaquiline-containing drug resistant TB treatment regimen has been implemented throughout all states/UTs, increasing treatment success rates for drug-resistant TB patients from 68% in 2020 to 75% by 2022.
