- In RBI's 90-year history, only three women have previously served as Deputy Governors – KJ Udeshi, Shyamala Gopinath, and Usha Thorat.
- With her appointment, RBI now has four Deputy Governors – Swaminathan J, T Rabi Sankar, M Rajeshwar Rao, and Poonam Gupta.

- The second edition of Trade Watch Quarterly for Q2 of FY 2024-25 (July–September) was officially released in New Delhi by Dr. Arvind Virmani, Member of NITI Aayog.
- Published by NITI Aayog, the report provides an analysis of India's trade performance, sector-specific trends, and emerging opportunities in global trade.
- During Q2 FY25, India's trade grew steadily by 5.67% in the April–September 2024 period compared to the same timeframe in 2023.
- Copper entered the top ten import categories, registering a 28% year-on-year increase due to rising infrastructure demand.
- While exports remained stable, electrical machinery and nuclear reactors showed growth, whereas mineral fuels and iron & steel saw declines.
- North America and the European Union accounted for nearly 40% of India's exports, while Northeast and West Asia remained key import partners.
- The edition highlights the textile sector, which plays a crucial role in industrial output, employment, and exports.
- India ranks among the top ten textile exporters globally, holding a 4% market share, with cotton and carpets comprising around 70% of textile exports.

- Tax refunds in March 2025 surged by 41%, totaling Rs.19,615 crore.

- The FY25 export figure fell short of the Rs.30,000 crore target by 21.26%.
- Defence Public Sector Undertakings (DPSUs) recorded a 42.8% rise in exports, highlighting the growing global acceptance of Indian defence products.
- The private sector contributed Rs.15,233 crore (64.5%), while DPSUs contributed Rs.8,389 crore (35.5%) to total exports.
- Indian defence exports reached approximately 80 countries, with the US, France, and Armenia being the top buyers.
- The government aims to achieve Rs.50,000 crore in defence exports by 2029

- The Cabinet Committee on Economic Affairs (CCEA), chaired by Prime Minister Narendra Modi, has approved the inclusion of Bihar's Kosi Mechi Intra-State Link Project under the Pradhan Mantri Krishi Sinchai Yojana – Accelerated Irrigation Benefits Programme (PMKSY-AIBP).
- The central government will provide Rs.3,652.56 crore in financial support for the project, which has a total estimated cost of Rs.6,282.32 crore and is expected to be completed by March 2029.
- The project aims to provide irrigation to an additional 2,10,516 hectares of farmland in the Kharif season across Araria, Purnea, Kishanganj, and Katihar districts.
- It will divert approximately 2,050 million cubic meters of surplus Kosi river water through the proposed link canal to improve irrigation.
- The remodeling of the existing Eastern Kosi Main Canal (EKMC) will also help address irrigation shortfalls for 1.57 lakh hectares of land.
- Launched in 2015-16, the Pradhan Mantri Krishi Sinchai Yojana (PMKSY) aims to expand irrigation coverage, improve water access for farming, and promote water conservation.
- The scheme has been extended for the period 2021-26 with a total budget of Rs.93,068.56 crore, including Rs.37,454 crore in central government support.
