

- The two securities being re-issued are the "6.64% Government Security 2027" for Rs.6,000 crore and the "6.79% Government Security 2034" for Rs.30,000 crore.
- The government has the option to accept up to Rs.2,000 crore extra in subscriptions for each of these securities, offering flexibility in its borrowing programme.
- The auction will be carried out via RBI's E-Kuber platform, ensuring secure and efficient electronic bidding.
- These G-Secs will be eligible for "When Issued" trading, allowing participants to buy and sell the securities before their actual issuance, thereby improving liquidity and market depth.





- She succeeds Ajay Bhushan Pandey, whose term ended on March 31, 2025.








- Founded in 1949, Manappuram Finance is a key player in the gold loan segment and also offers services like microfinance, vehicle finance, and housing finance.








- According to SBI's Deputy Managing Director Jayati Bansal, this initiative will leverage SBI's vast rural network to reach the heart of India's agricultural communities





- IndusInd Bank Limited transferred corporate loans worth over Rs 10,000 crore to ICICI Bank Limited and Federal Bank Limited using Inter-Bank Participation Certificates (IBPC), a money market instrument used by banks to share loans and meet year-end lending targets.
- The selling bank receives 40% of the loan amount, which aids in liquidity management and deposit retirement.
- Loans were moved via the Inter-Bank Participation Certificate (IBPC) market, which is a short-term instrument (often with a 6-month tenor) that allows banks to borrow or lend using loan collateral.
- The purchased loans have an interest rate of 7.5-8%, which reflects normal market conditions for such short-term securities.
- IndusInd Bank conducted this transaction to secure liquidity and manage risks connected with a Rs.2,000 crore net value loss caused by accounting issues.

- This includes retired All India Service Officers, former Members of Parliament (MPs), retired High Court and Supreme Court judges, ex-Presidents and Vice Presidents, and officials from civil ministries and departments.
- However, the authorisation excludes pension disbursement for officials from the Railways, Posts, Telecom, and Defence sectors.





- This ECB facility comes with a 3-year tenure and includes a green shoe option allowing the amount to go up to \$300 million, depending on investor interest.
- The funding was arranged with the participation of global banks including First Abu Dhabi Bank, Standard Chartered Bank, Sumitomo Mitsui Banking Corporation, and HSBC.
- The raised funds are fully hedged to safeguard against currency and interest rate fluctuations, ensuring stability in repayments.
- With this deal, Piramal's total ECB borrowings for FY25 stand at \$815 million.
- The company noted that the cost of funds via ECB is more competitive compared to domestic borrowing rates, making it a cost-effective financing strategy.



- This strategic alliance is expected to play a vital role in empowering rural communities in Assam and supporting the region's long-term economic sustainability.






- On a quarterly basis, external debt saw a 0.7% rise, up from USD 712.7 billion in September 2024.
- The external debt to GDP ratio was 19.1% at the end of December 2024, slightly higher than the 19% recorded in September 2024.
- Long-term debt (with original maturity over one year) was reported at USD 578.3 billion, indicating it makes up the majority of the total debt.
- Short-term debt accounted for USD 139.6 billion of the total as of December 2024.






- The assessment classifies lions as 'largely depleted' in terms of ecological recovery, though they remain listed as 'Vulnerable' on the IUCN Red List.
- Lions are the second-largest big cats in the world, after the Asian tiger (Panthera tigris).
- In Asia, lions exist only in India, specifically in a single sub-population located in the Gir National Park and Wildlife Sanctuary and surrounding areas in Gujarat, covering about 14,000 sq. km.
- According to data, there are approximately 23,000 lions in Africa (as of 2023) and around 670 lions in India (as of 2020), mostly in Gujarat.






- The Central Board of Indirect Taxes and Customs (CBIC) will launch electronic processing for the import and export of gems, jewellery, and machinery samples via personal carriage by air passengers starting May 1, 2025.
- This initiative will enhance transparency, ease of doing business, and tracking of such items.
- Export of gems and jewellery through personal carriage will be allowed at 9 airports: Delhi, Mumbai, Kolkata, Chennai, Kochi, Coimbatore, Bangalore, Hyderabad, and Jaipur.
- Import of gems and jewellery through personal carriage will be permitted at 7 airports: Delhi, Mumbai, Kolkata, Chennai, Bangalore, Hyderabad, and Jaipur.
- For machinery samples or prototypes, this facility will initially be available only at 4 airports: Bengaluru, Chennai, Delhi, and Mumbai.
- The processing will involve filing Bill of Entry/Shipping Bill electronically, streamlining documentation and reducing manual intervention.



- India has become a global leader in railway locomotive manufacturing by producing a record 1,681 locomotives in the financial year 2024-25.
- This figure surpasses the total locomotive production of regions like the United States, Europe, South America, Africa, and Australia.
- Compared to the 1,472 locomotives produced in 2023-24, this is an increase of 209 units, marking a 19% growth.
- The surge in production is a result of efforts under the "Make in India" initiative to boost domestic manufacturing.
- Between 2004 and 2014, India produced 4,695 locomotives with an annual average of 470 units.
- From 2014 to 2024, the total production rose to 9,168 locomotives, increasing the annual average to around 917.
- In 2024-25, production across Indian Railways' manufacturing units was distributed as follows: 700 at Chittaranjan Locomotive Works, 477 at Banaras Locomotive Works, 304 at Patiala Locomotive Works, and 100 each at Madhepura and Marhowrah units.



- The Kumbakonam betel leaf is cultivated in the Cauvery Delta region, including areas like Thiruvaiyaru, Papanasam, Thiruvidaimarudhur, Kumbakonam, and Valaigaman blocks in Thanjavur and Tiruvarur districts.
- The GI tag was granted after a three-year application process, recognizing the sixgeneration old tradition of craftsmanship.
- The betel leaf has a historical significance, with its cultivation dating back centuries. In addition to paddy, common crops in these wetlands include sugarcane and betel vine.
- The Thovalai maanikka maalai is a unique type of garland that is exclusively crafted in Thovalai, highlighting its cultural and regional uniqueness.

- The Centre has increased pay under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) by 2-7% for fiscal year 2025-26.
- The NREGS wage rates for 2025-26 have been increased by 2.33-7.48%, as announced in a notification. NREGS salary have increased by Rs 7-26.
- NREGS wages increased by ₹7 in five states: Andhra Pradesh, Arunachal Pradesh, Assam, Nagaland, and Telangana.
- In Haryana, NREGS salaries are expected to reach Rs 400 per day by 2025-26, representing the largest rise of Rs 26 from the current rate of Rs 374 per day.
- This is the first time NREGS pay will reach Rs 400 per day in any state.
- In 2024-25, Goa experienced the highest pay rate increase of 10.56% over the previous year (2022-23), while Uttar Pradesh and Uttarakhand saw the lowest increase of 3.04%.


- The Protection of Interest in Aircraft Objects Bill, 2025, which was enacted by both the Lok Sabha and the Rajya Sabha, is the second major aviation reform under Civil Aviation Minister Ram Mohan Naidu.
- The measure seeks to connect India's aircraft leasing and financing environment with global standards, bolstering investor confidence in the country's rapidly expanding aviation business.
- It builds on the foundation of the Cape Town Convention of 2001, which aimed to simplify and standardize international leasing contracts.
- Although India formally embraced this agreement in 2008, loopholes in legal enforcement resulted in higher lease costs—typically 8-10% higher than in other countries.
- India's aviation sector has expanded rapidly, with annual passenger volume doubling from 10.38 crore (Independence to 2014) to 22.81 crore by 2024, and the number of airports expanding from 74 in 2014 to 159 in 2024.
- The Act promotes the sector's growth—as indicated by aircraft numbers increasing from 340 in 2014 to over 840 in 2024—while addressing issues such as high Aviation Turbine Fuel (ATF) costs, which account for 45% of airline operational expenses.
- Future goals include producing 2.5 crore gallons of Sustainable Aviation Fuel (SAF) by 2025, converting over 100 airports to renewable energy, and expanding Flight Training Organizations (FTOs) to fulfill the demand for 30,000-34,000 pilots over the next 10-15 years.

- Additionally, a Rs.6 lakh penalty was added because Flipkart continued selling insurance policies even after applying for renewal of registration.





- In the context of RRBs, the fiscal year 2021–2022 marked a turning point when the Center agreed to provide Rs.5,445 crore as its share over two years in order to support growth capital.
- Through three stages of merger, the Center's structural consolidation of RRBs, which began in 2004-05, reduced the number of these institutions from 196 to 43 until 2020-21.
- These banks were established under the RRB Act of 1976 with the intention of lending money and offering other services to small farmers, agricultural laborers, and craftspeople in rural regions.
- As of March 31, 2024, 43 RRBs were functioning through a network of 22,069 branches across 700 districts in 26 States and 3 Union Territories (Jammu & Kashmir, Ladakh, and Puducherry).



- However, this year's message from India-rooted in peace and etched in sand-is making the biggest mark.



- In accordance with the National Logistics Policy and in support of the "Make in India" campaign, the law streamlines coastal trade operations and eliminates the need for general trading permits for Indian ships.
- The measure intends to lower logistics costs, promote Indian ship ownership, increase shipbuilding, port services, and employment, and restrict foreign vessel participation through particular licenses.
- Green clearance channels, lower bunker fuel GST, and a National Database for Coastal Shipping are among the provisions. According to the law, coastal freight traffic is expected to increase from 162 million tonnes in 2023-2024 to 230 million tonnes by 2030.
