• Nonetheless, the MSME finance gap is currently USD 5.7 trillion, and when informal businesses are taken into account, it increases to USD 8 trillion.





• Due to UPI's popularity, India accounts for nearly 46% of the world's digital transactions, with a 90x increase in retail digital payments over the last 12 years.







- The Best Stunt Design category is the second significant addition to the Oscars in the last 14 Months.
- Previously, the Academy added a competitive Oscar for casting, which will be awarded for the First time at Next Year's Ceremony.

• He has delivered key judgments including those related to Article 370, electoral bonds, pan-India guidelines against illegal demolitions or the 'bulldozer culture' of States , and personal liberty in the Manish Sisodia bail case.

• He is also notable as the first Dalit CJI from the Scheduled Caste community in many decades.

- The International Big Cat Alliance (IBCA) was launched by Prime Minister Narendra Modi in April 2023, coinciding with the 50th anniversary of Project Tiger.
- The alliance aims to promote the global conservation of seven major big cat species: Tiger, Lion, Leopard, Snow Leopard, Puma, Jaguar, and Cheetah.
- As per the headquarters agreement signed in April 2024, India will host the permanent headquarters and secretariat of IBCA.
- The Government of India has committed Rs.150 crore towards the alliance between 2023-24 and 2028-29. This will cover corpus funding, infrastructure, and recurring expenses.
- India became an official member in September 2023, after ratification by five initial signatories: India, Liberia, Eswatini, Somalia, and Nicaragua.
- IBCA attained global legal status in February 2024, making it an internationally recognized conservation platform.
- The agreement was signed by P. Kumaran (Secretary, East MEA) and S. P. Yadav (Director General, IBCA), confirming India as the host nation for the headquarters.
