• Concessional personal, housing, and education loans are also part of the benefits under this pact.









- RBI's draft circular proposes that all lenders together can invest up to 15% in a single AIF scheme.
- A single lender's investment cap is 10% of the AIF corpus.
- Registered Entities (RE) can invest up to 5% without restrictions.
- 100% provisioning is required if downstream debt is made to the RE's borrower (excluding equity shares).
- Some AIFs may get strategic exemptions in consultation with the government.
- These proposed norms aim to boost capital inflow from RBI-regulated lenders while aligning with SEBI rules and preventing misuse.


• The Reserve Bank of India (RBI) has granted in-principle approval to Emirates NBD Bank PJSC to establish a wholly owned subsidiary (WOS) in India.

• Emirates NBD will be the third foreign bank to enter India via the WOS route after DBS Bank and SBM Bank.

• Currently, Emirates NBD operates in India through branches in Chennai, Gurugram, and Mumbai.

• The minimum startup capital requirement for the WOS is Rs.300 crore with a minimum capital adequacy ratio of 10%.









# **Recent News Headlines Related to RBI**

- RBI based on the Economic Capital Framework (ECF), may transfer a record surplus ranging from Rs.2.5 lakh crore to Rs.3 lakh crore to the government for the financial year 2024-25
- As per RBI's latest data, UPI QR codes recorded the fastest growth in digital payment infrastructure in FY 2024-25
- RBI recently revealed data showing that American Express and HSBC were the top foreign banks with notable gains
- RBI approved the formation of an interim "Committee of Executives" to oversee IndusInd Bank's operations
- RBI has eased investment norms for Foreign Portfolio Investors (FPIs) in corporate debt securities via the general route
- RBI has officially recognised the Fixed Income Money Market and Derivatives Association of India (FIMMDA) as a Self-Regulatory Organisation (SRO) for financial markets
- RBI has sought the government's approval to remove the 30% cap on foreign banks using vostro accounts to purchase short-term sovereign debt, including treasury bills
- The Reserve Bank of India (RBI) purchased 57.5 tonnes of gold during the fiscal year 2024–25, making it the second-highest annual purchase since it began accumulating gold in December 2017
- According to RBI report, India's total exports in 2024–25 reached \$824.9 billion, which reflects a 6.01% increase over \$778.1 billion in 2023-24
- RBI has announced that starting 1st May 2025, all banks, financial companies, and regulated entities must use the PRAVAAH portal for submitting applications related to regulatory authorisations, licences, and approvals
- Zaak ePayment Services, a wholly owned subsidiary of Mobikwik, received final approval from the Reserve Bank of India (RBI) to operate as an Online Payment Aggregator
- RBI has launched three important surveys in May 2025 to collect inputs for future monetary policy decisions. These include the Inflation Expectations Survey of Households (IESH), Urban Consumer Confidence Survey (UCCS), and Rural Consumer Confidence Survey (RCCS)
- The Reserve Bank of India (RBI) revoked the license of Imperial Urban Co-operative Bank, located in Jalandhar, in 2025



• SEBI has barred the Managing Directors (MDs) of Market Infrastructure Institutions (MIIs) from being members of their audit committees to ensure independence and transparency in audits.

- Key Managerial Personnel (KMPs) may attend audit committee meetings only with the chairperson's approval but do not have voting rights.
- The new internal audit norms for MIIs aim to strengthen governance and audit mechanisms, covering functions like operations, regulatory compliance, risk management, investor grievances, and business development.
- Internal auditors must report only to the audit committee, and institutions may consult the Industry Standards Forum to define the audit scope.
- These norms will become effective after three months from their notification, following findings of gaps in audit practices during inspections.

- SEBI and the Ministry of Corporate Affairs, through IEPFA, launched 'Niveshak Shivir', a nationwide investor assistance program
- SEBI released a consultation paper in May 2025 proposing enhanced disclosure norms for High Value Debt Listed Entities (HVDLE)
- SEBI has introduced a regulatory framework for Specialized Investment Funds (SIFs), effective from April 1, 2025
- Capitalmind Financial Services has received final approval from SEBI (Securities and Exchange Board of India) to launch its mutual fund business, branded as Capitalmind Mutual Fund
- SEBI has approved Aye Finance, a Non-Banking Financial Company (NBFC), to raise Rs.1,450 crore through an Initial Public Offering (IPO)
- SEBI has formed a high-level committee (HLC) of six members to review rules on conflict of interest. The committee is headed by Pratyush Sinha, a retired IAS officer and former Chief Vigilance Commissioner
- SEBI has extended the deadline for regulated firms to implement the Cybersecurity and Cyber Resilience Framework (CSCRF) by three months, until June
- SEBI has introduced a framework for the Past Risk and Return Verification Agency (PaRRVA) to verify performance-related claims made by research analysts, investment advisors, and algorithm providers
- SEBI has approved increasing the disclosure threshold for foreign portfolio investors (FPIs) from Rs.25,000 crore to Rs.50,000 crore in equity AUM.
- SEBI has extended the suspension of derivatives trading in seven agricultural commodities until March 31, 2026
- Paytm Money Limited, a subsidiary of One 97 Communications Limited (OCL), has been registered as a Research Analyst (RA) by the Securities and Exchange Board of India (SEBI) under the 2014 Regulations
- The SEBI has reduced the minimum investment requirement for Zero Coupon Zero Principal (ZCZP) instruments on the SSE from Rs 10,000 to Rs 1,000
- The SEBI introduced Specialised Investment Funds (SIFs) to bridge the gap between mutual funds and portfolio management services
- The SEBI has decreased the timescale for completing rights issues from 126 days to 23 days.





- The Bio-foundry is a cutting-edge facility supporting biotechnology innovation, synthetic biology, and research.
- India's bio-economy grew from USD 10 billion in 2014 to USD 165.7 billion in 2024, with a goal of USD 300 billion by 2030.
- This milestone reflects India's growing emphasis on public-private partnerships, research infrastructure, and global collaboration in biotechnology.



• It covers about 6 lakh acres of tribal land without electricity connection, enabling irrigation through solar energy.

• The scheme supports empowerment of Scheduled Tribes farmers under the Forest Rights Act, benefiting 2.3 lakh farmers with land rights over 6.69 lakh acres.

• Additional initiatives include solar projects and bus ownership for women Self Help Groups (SHGs).





• Assam Chief Minister Himanta Biswa Sarma launched the 'Eti Koli Duti Paat' scheme during the 200th celebration of Assam Tea. Under this scheme, the Government of Assam will provide a one-time assistance of Rs.5,000 to each permanent and temporary tea garden worker

- The Government of Kerala launched the 'Jyothi' scheme in May 2025 to support the education of children of migrant workers
- The Adishakti Abhiyan is a women's empowerment initiative by the Maharashtra government that focuses on effective implementation and awareness of government schemes for women and children
- The Pandit Lakhmi Chand Kalakar Samajik Samman Yojana was launched by the Haryana government to financially support senior artists who have significantly contributed to arts like singing, acting, dance, drama, and visual arts
- The Ministry of Road Transport and Highways (MoRTH) launched the Cashless Treatment of Road Accident Victims Scheme, 2025. It is implemented by the National Health Authority (NHA). The scheme provides cashless treatment of up to Rs.1.5 lakh per accident per person
- The Mukhyamantri Neera Samvardhan Yojana has been launched by the Bihar Government to boost neera (palm nectar) production and support toddy tappers



- The WHO declared an outbreak of wild polio virus in Papua New Guinea after two children were found infected.
- Papua New Guinea was declared polio-free in 2000, but low immunisation rates and a brief outbreak in 2018 posed challenges.
- Polio mainly affects children below 5 years and causes paralysis by attacking the nervous system.
- The disease spreads primarily via the faecal-oral route, including through contaminated food and water.
- The Global Polio Eradication Initiative (GPEI), launched in 1988, has helped reduce wild poliovirus cases globally by 99%.
- The first polio vaccine was invented by Jonas Salk in 1952, followed by the oral polio vaccine by Albert Sabin, which uses a weakened live virus.







• Prof. Siddique was recognized for his significant and sustained contributions to international agricultural research through Crawford Fund's programmes and related initiatives.










#### Explanation :



- It runs from May 14 to May 28, 2025, covering land, sea, and air operations.
- The exercise is held at the Ream Naval Base in Sihanoukville, Cambodia's southern coast.
- More than 900 Chinese soldiers and over 1,300 Cambodian troops participate.
- The theme focuses on joint counterterrorism and humanitarian relief operations.
- The Ream Naval Base was officially inaugurated in April 2025 with Chinese warships docking, reflecting China's growing naval presence in the Gulf of Thailand.
- The drills coincide with the U.S.-Philippines-led 'Balikatan' exercise involving U.S., Philippines, Australia, and Japan.
- China's access to dual-use ports in countries like Cambodia mirrors its presence in other strategic locations such as Sri Lanka (Hambantota) and Pakistan (Gwadar).







#### Recent News Headlines Related to Defence Exercise :

• The Indian Army and the National Disaster Response Force (NDRF) jointly conducted Exercise Raahat in Assam, focusing on humanitarian assistance and disaster relief (HADR) operations

• The Indian Army conducted 'Teesta Prahar', a large-scale integrated field exercise at the Teesta field firing range in West Bengal. The exercise was held under the Trishakti Corps, part of the Eastern Command

• India is set to join the Talisman Sabre 2025 military drill for the first time. This exercise is a biennial event. It aims to enhance strategic cooperation and defense collaboration in the Indo-Pacific region.

• Exercise "Aakraman," a significant military exercise, was carried out by the Indian Air Force (IAF) to simulate strikes on both ground and mountain targets

• The Indian Air Force contingent took part in Exercise Desert Flag-10, held at Al Dhafra Air Base, UAE

• The 1st edition of Africa India Key Maritime Engagement (AIKEYME 2025) was conducted in Tanzania

• Exercise Prachand Prahaa Held at High-altitude terrain of Arunachal Pradesh between Indian Army, Navy, and Air Force. It is Conducted by Indian Army's Kolkata, West Bengal-based Eastern Command

• The Indian Air Force (IAF) is set to participate in the multinational air exercise INIOCHOS-25 in Greece. This 12-day exercise, hosted by Greece's Hellenic Air Force, will be held at Andravida Air Base and will continue until April 11, 2025

• The 14th edition of Exercise INDRA was conducted between the Indian Navy and the Russian Navy. The exercise was divided into two phases: the Harbour Phase, which took place off the coast of Chennai, and the Sea Phase, which was held in the Bay of Bengal

• The India-U.S. tri-service exercise 'Tiger Triumph' is a Humanitarian Assistance and Disaster Relief (HADR) exercise. The Harbour Phase of the exercise will take place in Visakhapatnam from April 1 to 7, 2025.

- The OCI scheme, introduced in 2005 through an amendment to the Citizenship Act, 1955, allows Persons of Indian Origin (PIOs) to register as Overseas Citizens of India.
- Eligibility includes those who were Indian citizens on or after January 26, 1950, excluding those connected to Pakistan or Bangladesh citizenship.




### Explanation :

• The Government of India has proposed to delicence the 5925-6425 MHz frequency band for unlicensed indoor use of low and very low power wireless systems.

• This means no authorization or frequency assignment will be needed to operate devices in this band indoors, with power capped at 30 dBm.

• Usage is restricted and prohibited in land vehicles, boats, aircraft flying above 10,000 feet, and drones.

• The move aims to promote deployment of advanced Wi-Fi technologies like Wi-Fi 6E and Wi-Fi 7, enabling better data-intensive applications indoors.



• Their win adds to India's strong performance in global shooting events and enhances Olympic preparation.









- The Gahirmatha Marine Sanctuary is recognized as the world's largest rookery for these turtles.
- Olive Ridley turtles are known for mass nesting (arribada), traveling thousands of kilometers to lay eggs in Odisha.




• President Droupadi Murmu invoked Article 143 of the Constitution, which allows the President to seek the Supreme Court's opinion on important legal or constitutional matters.

• The President sought clarification on the Supreme Court's earlier judgment that seemed to impose a timeline on Governors and the President to give assent to bills passed by State Legislatures.

• Articles 200 and 201 describe the roles of the Governor and President in giving assent to bills but do not specify any time limits.

• The President questioned whether the Judiciary can impose timelines when the Constitution is silent, and whether Article 142's "complete justice" power can override Articles 200 & 201.

• The President also raised concerns on the appropriateness of States approaching the Supreme Court under Article 32 for such federal disputes, suggesting Article 131 might be more suitable.


• The Indian government allotted a quota of 180 tonnes of gold import from the UAE for 2025-26 under this agreement.

• Earlier, gold imports from UAE were taxed at 5%, but CEPA reduced this to 1%.

• The Directorate General of Foreign Trade (DGFT) received 2,960 applications for the 180-tonne quota, but only limited quota and strict eligibility led to many rejections.

• Priority was given to applicants who used 80% of their quota the previous year, while scheduled commercial banks were excluded as they import directly.



# Explanation:

- The Yala Glacier in Nepal's Langtang Valley has shrunk by 66% since the 1970s and is now declared 'dead'.
- It is the only glacier from the entire Himalaya listed in the Global Glacier Casualty List (GGCL).
- The GGCL project was launched in 2024 by Rice University, University of Iceland, Iceland Glaciological Society, World Glacier Monitoring Service, and UNESCO.
- Glacial loss accelerates global warming due to less albedo effect, contributes to sea-level rise, disrupts freshwater supply, and increases natural disaster risks like Glacial Lake Outburst Floods (GLOFs) and avalanches.
- Other recently declared dead glaciers include Sarenne Glacier (France, 2023) and Pico Humboldt Glacier (Venezuela, 2024).
- The first glacier funeral was held for Okjokull Glacier in Iceland in 2019 (officially declared dead in 2014).

Anurag Bhushan Appointed as Ambassador of India to the Kingdom of Sweden. He Replaced Tanmaya Lal.

Former Chief Justice of India Dr. DY Chandrachud has joined National Law University, Delhi, as a Distinguished Professor. DY Chandrachud served as CJI from November 2022 to November 2024

The Ministry of Culture launched the 'Ek Desh Ek Dhadkan' campaign, which translates to "One Nation, One Heartbeat." The illumination activities were carried out under the Archaeological Survey of India (ASI).

The Assam Cabinet, led by Chief Minister Himanta Biswa Sarma, has approved renaming Dibrugarh Airport after Bhupen Hazarika, a great singer and cultural figure, to commemorate his 100th birth anniversary.

Prof. Ajay Kumar Sood, the Principal Scientific Advisor to the Government of India, launched the report on India's Priority Corridors for Zero Emission Trucking. The report identifies 10 critical highway corridors in India that are ideal for Zero-Emission Truck (ZET) deployment.

The Uttar Pradesh government has introduced a first-of-its-kind Vistadome coach service connecting the Katarniaghat Wildlife Sanctuary to the DudhwaTiger Reserve in Pilibhit.
