



• Two key restrictions have been withdrawn : Short-term investment limit, which capped FPI holdings in short-term instruments. And Concentration limit, which restricted the FPI exposure to a single corporate issuer.

• These changes aim to simplify the investment process and boost FPI participation in India's corporate bond market.

• However, FPIs must still comply with overall investment ceilings and macroprudential regulations under the General Route 1 framework.



• The committee will report to the Oversight Committee of the Board, chaired by Sunil Mehta, the Chairman of IndusInd Bank.



• Additionally, SBI forecasts nominal GDP growth for FY26 to be between 9% and 9.5%, slightly below the Union Budget estimate of 10%.











- This marks a major leap from earlier methods where businesses used the Razorpay dashboard for initiating and authorizing payments.











- The revision follows the IMD's forecast of an above-normal monsoon, which is expected to support better Agri-GVA growth.
- Crop-wise targets : Rice: 147 MT (+8%), Wheat: 117 MT (+2%) and Kharif contribution: 168.88 MT
- Current year's foodgrain production so far stands at 330.97 MT, excluding summer crops.
- The agriculture sector's GVA growth is projected at 3.8% in FY25, compared to 1.4% in FY24.
- The Viksit Bharat Sankalp Abhiyan (May 29–June 12) will promote awareness on modern farming techniques and seed varieties.

- Implemented by the Prohibition, Excise, and Registration Department in collaboration with Jeevika, this scheme offers livelihood support.
- Around 20,000 toddy tappers will receive Rs.8 per litre as incentive via Direct Benefit Transfer (DBT).
- The plan includes utilizing 2 lakh palm trees, with Rs.30 per tree for identification and Rs.15,600 for owners of 10+ trees.
- Districts like Nalanda, Gaya, Muzaffarpur, and Vaishali have the highest toddy tapper populations.
- Neera kiosks are being set up, especially in Nalanda, to promote its sale as a nutritious, non-alcoholic drink.
- The scheme aligns with Bihar's alcohol prohibition policy, offering neera as a healthy alternative and source of income.
- This move follows Tejashwi Yadav's call for amending the Prohibition Act, reflecting a shift toward sustainable livelihoods.
