- Following the sale of items from Bharat Mart warehouses, banks are now permitted to assist exporters to realize and repatriate the whole export profits within nine months.
- Now, subject to simple verifications, Indian exporters with a valid Importer Exporter Code (IEC) can open or rent warehouses in Bharat Mart without any prior requirements and provide money for setup and operations.

- The IMF projects that the global economy would expand by 2.8 percent in 2025. The projection for January had projected a 3.3% growth rate.
- In 2024, the global economy is predicted by the IMF to expand by 3.3%. In its most recent edition of the World Economic Outlook Report, the IMF made these predictions for the global economy and India.

- West Indian wicketkeeper-batsman Nicholas Pooran was named the Leading T20 Player in the World.

Five Wisden Cricketers of the Year

- Every year, Wisden selects five cricketers for their performance in the English domestic season. It is given only once to a cricketer. This year, the selected players were Gus Atkinson, Jamie Smith, Dan Worrall, Liam Dawson, and Sophie Ecclestone.

Wisden Trophy for the Year's Outstanding Performance :

- New Zealand's Mitchell Santner was named the Wisden Trophy for the Year's Outstanding Performance.

- Earlier, at the Buenos Aires World Cup (Argentina) from 1–10 April 2025, India had finished second with eight medals – 4 gold, 2 silver, and 2 bronze.

Gold medal winners :

- Suruchi Singh in the women's 10m air pistol event. She had also won the gold at the Buenos Aires event.
- Saurabh Chaudhary & Suruchi Singh in the 10m air pistol mixed team event.

Silver Medal winners :

- Manu Bhaker in the women's 10m air pistol event. She failed to win a medal at the Buenos Aires event.
- Arjun Babuta in the men's 10m air rifle event
- Simranpreet Kaur Brar in the women's 25m pistol event. It was Simranpreet's first-ever medal at the World Cup.

- A monetary incentive of Rs. 1 crore (for Rank 1), Rs. 75 lakh (for Rank 2), and Rs. 50 lakh (for Rank 3) is included with each award. Certificates and specially made trophies will be given to the winners.
- Notably, women Sarpanches are in charge of three of the six awardee Gram Panchayats: the Hatbadra Gram Panchayat in Odisha, the Motipur Gram Panchayat in Bihar, and the Dawwa S Gram Panchayat in Maharashtra.

IMPORTANT ONE – LINER Current Affairs

India's cricket captain Rohit Sharma Appointed as Brand ambassador for Season 3 of the Twenty20 (T20) Mumbai League. Season 3 will maintain an eight-team format, with two new additions.

The Financial Intelligence Unit (FIU) has slapped a Rs.37 lakh penalty on Union Bank of India for discrepancies in reporting suspicious transactions for 2011-2014.

Oscar Jack Piastri, an Australian Formula 1 (F1) driver representing the United Kingdom (UK)-based McLaren won F1 Saudi Arabian Grand Prix(GP) 2025 held at Jeddah Corniche Circuit in Jeddah, Saudi Arabia.

In order to encourage women in higher education institutions to pursue jobs in artificial intelligence (AI), Microsoft and the Ministry of Skill Development and Entrepreneurship (MSDE) have signed a Memorandum of Understanding (MoU) to establish AI jobs for Women, a groundbreaking skilling program.

Neeraj Chopra, India's two-time Olympic medallist, started his 2025 season by winning a gold medal at the NWU Potch Invitational held in South Africa. With a throw of 84.52 meters, he took first place, surpassing both Duncan Robertson (71.22 meters) and Douw Smit (82.44 meters) of South Africa.

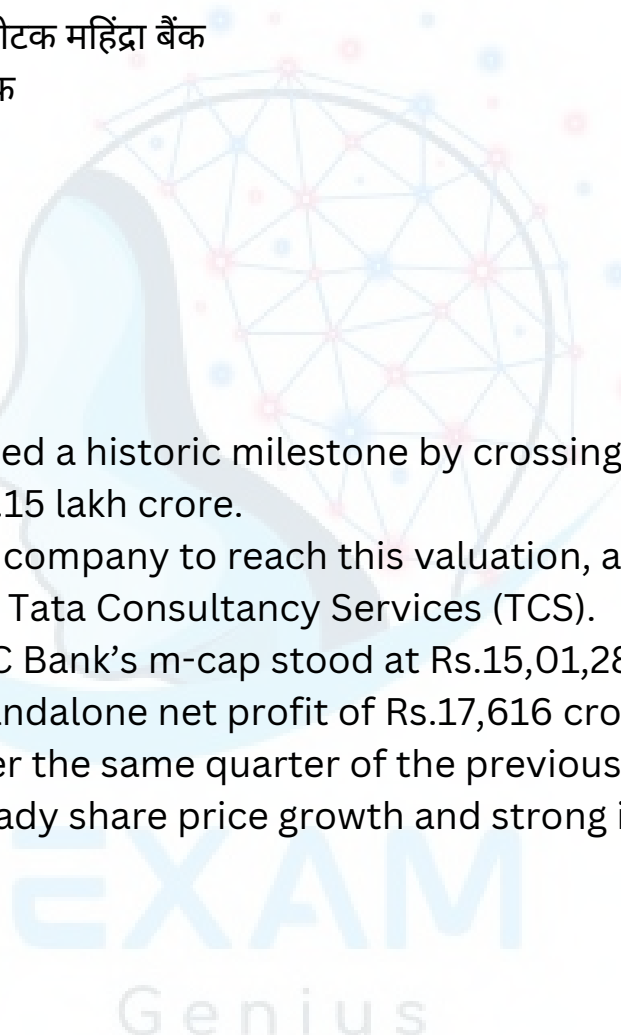

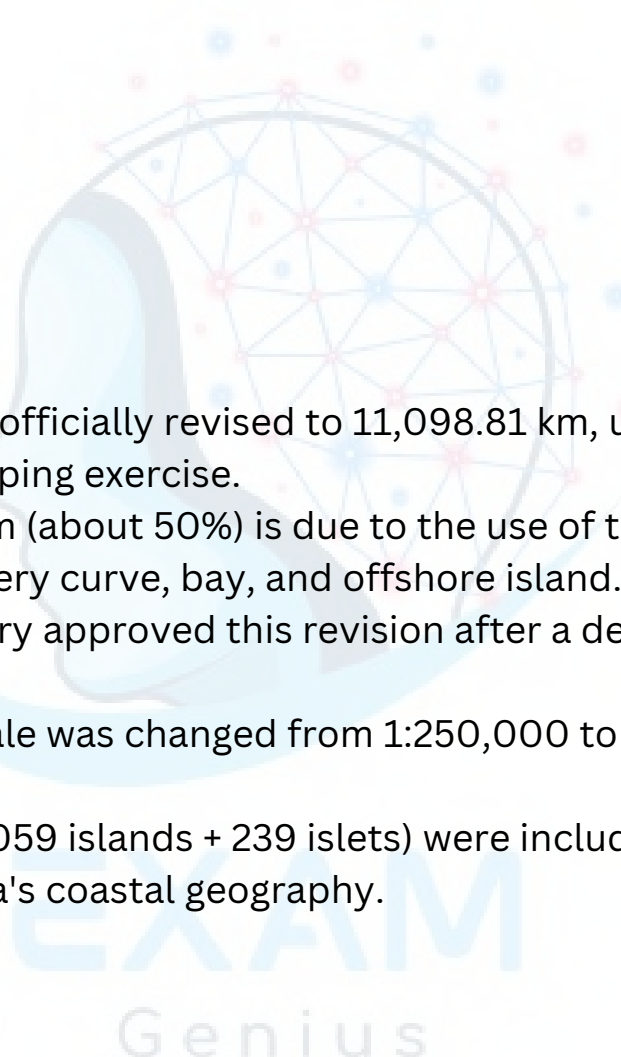

- The increase of 3,537.21 km (about 50%) is due to the use of the fractal mapping method, which captures every curve, bay, and offshore island.
- The Union Shipping Ministry approved this revision after a decade of review and consultation.
- The technical mapping scale was changed from 1:250,000 to 1:25,000, offering higher accuracy.
- A total of 1,298 islands (1,059 islands + 239 islets) were included, enhancing precision in measuring India's coastal geography.

- Delivery will use surface transport, keeping it cost-effective, with rates ranging from Rs.20 (up to 300g) to Rs.100 (up to 5kg).
- The maximum weight limit per packet is 5 kg, and tracking is available for all shipments.

- India's total crude oil imports ranged between 5.2 to 5.3 million barrels/day in April 2025.
- Experts expect stable Russian supplies unless stricter sanctions are imposed, though Saudi Arabia and the US may regain share via new collaborations.

- The plant will treat 40 million litres per day (MLD) of wastewater using membrane filtration technologies like RO, microfiltration, ultrafiltration, and nano filtration.
- It will serve 1,400+ industrial units, ensuring wastewater reuse and reducing reliance on freshwater, promoting sustainable urban infrastructure

- It connects Mawlyngkhung (Shillong, Meghalaya) with Panchgram (Silchar, Assam).
- The corridor aims to improve connectivity from Guwahati to Silchar and enhance access to Tripura, Mizoram, Manipur, and the Barak Valley.
- Total investment : Rs.22,864 crore (including land acquisition and civil construction).
- It will generate an estimated 74 lakh direct and 93 lakh indirect man-days of employment and boost tourism and logistics.

- The Red-Crowned Roofed Turtle (Batagur kachuga), classified as critically endangered, was reintroduced into the Ganga River on April 26, 2025, after being absent from the main river channel for over 30 years.
- This initiative is part of the Namami Gange Mission and was led by the TSAFI Project, Garhaita Turtle Conservation Center, and National Chambal Sanctuary, with support from Haiderpur Wetland.
- A total of 20 turtles were released – 10 in the Haiderpur Wetland and 10 directly into the Ganga, each equipped with ultrasonic tracking devices to monitor their movement.
- The goal is to restore turtle biodiversity in the river ecosystem and study migration and survival strategies.
- The Haiderpur Wetland, which connects with the Ganga during monsoon, will allow for natural migration, and the turtles will be monitored for the next two years.

- These satellites will orbit at around 630 km (approx. 400 miles) altitude.
- This follows Amazon's earlier launch of 2 test satellites in 2023.
- To reduce reflection and support astronomical observation, the satellites are coated with mirror film.
- Eventually, Amazon plans to launch over 3,200 satellites globally.

- If the recovery falls below 9.5%, a minimum Rs.329.05/quintal is assured.
- The hike aims to protect farmers amid a decline in sugar output and boost sugarcane cultivation.
- The cost of production is Rs.173/quintal, so the new FRP is 105.2% above cost.
