- In Q1 of FY26, Foreign Portfolio Investors (FPIs) sold Government Securities (G-Secs) worth Rs.25,544 crore under the Fully Accessible Route (FAR).
- This marks the largest quarterly sale since G-Secs were included in global bond indices.
- Notably, G-Secs were added to the JP Morgan GBI-EM Index (effective June 28, 2024) and Bloomberg's EM LC Government Index (January 31, 2025).


Key reasons for the sell-off include:

- A reduced yield spread (~180 bps) between the 10-year US Treasury and the 10year Indian G-Sec (down from 400-500 bps earlier)
- Geopolitical tensions (e.g., India-Pakistan) and global trade/tariff uncertainties.
- Profit-booking after a bond rally, supported by 50 bps RBI rate cuts earlier this year.



- HDFC Bank currently holds a 94.36% stake in HDB Financial Services.
- The IPO is in compliance with the RBI's upper-layer NBFC norms, which mandate listing by 30 September 2025.
- Funds raised will be used to augment Tier-I capital and meet future lending needs.
- The company filed its Draft Red Herring Prospectus (DRHP) in October 2024.
- Lead book-running managers include JM Financial, BNP Paribas, BofA Securities, Goldman Sachs, HSBC, IIFL, Jefferies, Motilal Oswal, among others.

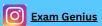

- Punjab & Sind Bank reported strong financial results in Q4 and FY 2024-25.



- Carlyle sold 82 crore shares at a price between Rs.21.61 Rs.21.68 per share.
- Post-sale, Carlyle's stake in YES Bank declined from 6.84% to 4.22%.
- This development followed the announcement by SBI and 7 other lenders to sell 20% combined stake in YES Bank to Sumitomo Mitsui Banking Corporation (SMBC) of Japan for Rs.13,483 crore, marking the largest cross-border investment in the Indian banking sector.
- Following the sale, YES Bank shares fell over 10% on both BSE and NSE.



- The approval further solidifies Wise's footprint in the Indian fintech and remittance market.




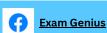

- Another MoU was signed with the Spices Board, represented by Director Rema Shree AB.
- Under this project:
- Rubber farmers will receive Rs.75,000 per hectare, and
- Cardamom farmers will receive Rs.1,00,000 per hectare (for up to 2 hectares).
- The project will benefit rubber farmers in Kottayam, Ernakulam, Pathanamthitta, Kannur, Malappuram, and Thiruvananthapuram, and cardamom farmers in Idukki.
- It also aims to replant 30,000 hectares of aged rubber plantations with a total project outlay of Rs.225 crore.



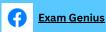
- Prime Minister Narendra Modi launched the Aravalli Green Wall Project on June 5, aligning with World Environment Day 2025.
- The project aims to combat desertification and restore degraded land across four states - Delhi, Haryana, Rajasthan, and Gujarat.
- It has an estimated cost of Rs.16,053 crore and will create a 5 km buffer zone around the 700-km-long Aravalli range.
- The initiative covers about 6.45 million hectares and is expected to establish a carbon sink of 2.5 to 3 billion tonnes of CO₂ equivalent.
- Though the land restoration project began in 2023, a detailed action plan has now been launched.
- This is a part of India's commitment to restore 26 million hectares of degraded land by 2030 under global climate goals.
- The Aravalli hills play a vital ecological role by preventing the spread of the Thar Desert and supporting rivers and biodiversity.

- It has replaced the Russian-made Grad BM-21 in the Indian Army's arsenal.
- The system includes two pods of 6 rockets each, capable of launching 12 rockets in salvo mode within 44 seconds.
- Recently, a Licensing Agreement for Transfer of Technology (ToT) was signed with NIBE Limited for its production and deployment.
