


**Answer: Option B** 

- The Reserve Bank of India (RBI) has barred banks, NBFC-ULs, and certain other lenders from levying foreclosure or prepayment charges on floating rate loans extended to Micro and Small Enterprises (MSEs) and on floating rate personal loans.
- The norms apply to loans sanctioned or renewed after January 1, 2026.
- This includes loans by commercial banks, tier-4 UCBs, NBFC-ULs, and All India Financial Institutions.
- Small Finance Banks, RRBs, and Local Area Banks have been excluded, as they are already prohibited from charging prepayment fees on loans up to Rs.50 lakh.
- For cash credit/overdraft, no charges will apply if the borrower gives prior notice of non-renewal as per the agreement.












- RBI has granted in-principle approval to Saraswat Co-operative Bank (SCB) for the acquisition of the New India Co-operative Bank (NICB) under the voluntary amalgamation scheme for Urban Co-operative Banks (UCBs)
- As per the RBI's June 2025 Financial Stability Report, the Gross Non-Performing Assets (GNPA) ratio of Scheduled Commercial Banks (SCBs) is projected to rise marginally from 2.3% in March 2025 to 2.5% by March 2027 under the baseline scenario
- According to the June 2025 edition of RBI's Financial Stability Report (FSR), India's household debt as a percentage of GDP declined from 42.9% (June 2024) to 41.9% (December 2024).
- RBI has revised the operational hours for SDF and MSF. Effective July 1, 2025, these liquidity tools will now be available from 7:00 PM to 11:59 PM every day
- According to the RBI, India's external debt rose by 10% to USD 736.3 billion at the end of March 2025, up from USD 668.8 billion in March 2024
- RBI has issued new guidelines to tighten the security of Aadhaar Enabled Payment System (AePS) transactions and reduce fraud risks
- Panaji (Goa) based Instifi has received Certificate of Authorization (COA), a final authorization from RBI to operate as a licensed online Payment Aggregator (PA) under the Payments and Settlement Systems (PSS) Act, 2007
- As per the June 2025 bulletin of the Reserve Bank of India (RBI), India has emerged as the top destination in the Global South for Greenfield investments in the digital economy
- RBI has extended call money market hours by 2 hours, now operating from 9:00 AM to 7:00 PM
- RBI has scheduled a 7-day Variable Rate Reverse Repo (VRRR) auction of Rs.1 lakh crore on June 27, 2025 to absorb surplus liquidity in the banking system
- To address the rising issue of digital payment frauds, the Reserve Bank of India (RBI) is collaborating with major public and private sector banks to build a new platform named DPIP (Digital Payment Intelligence Platform)

- The Floating Rate Savings Bonds (FRSB) 2020 (Taxable) have an interest rate that is reset every 6 months, in January and July.
- The interest rate is linked to the National Savings Certificate (NSC) rate, with a +0.35% spread.
- For July to December 2025, the NSC rate is 7.70%, hence the bond's rate is: 7.70% + 0.35% = 8.05%
- The interest is non-cumulative and paid semi-annually, next on January 1, 2026.






- On July 1, 2025, SBI inaugurated Global Trade Finance Centres in Kolkata and Hyderabad.























- The Financial Fraud Risk Indicator (FRI) is a risk-based tool developed by DoT's Digital Intelligence Unit (DIU).
- It classifies mobile numbers into Medium, High, and Very High risk categories using inputs from sources like I4C-NCRP, Chakshu, and banks/UPI platforms.
- Helps banks take real-time preventive actions such as blocking, warning, or delaying high-risk financial transactions.
- Already adopted by institutions like PhonePe, ICICI Bank, HDFC Bank, Paytm, etc.
- Supports inter-agency coordination, enhancing Digital India's cyber resilience.





- SBI's Fraud Identification Committee (FIC) flagged the matter, leading to Anil Ambani's name being reported to the RBI.
- While RCom claims the loans were used for repayments, SBI found no valid purpose, raising concerns about management integrity.

- The Management Effectiveness Evaluation (MEE) report 2025, launched by Union Environment Minister Bhupendra Yadav during the Indian Conservation Conference (ICCON) 2025 in Dehradun, assessed 438 National Parks and Wildlife Sanctuaries.
- Kerala topped all states with a score of 76.22%, making it the only state rated as "Very Good."
- It outperformed Karnataka (74.24%), Punjab (71.74%), and Himachal Pradesh (71.36%) which were rated as "Good."
- Chandigarh topped among UTs with 85.16%, while Ladakh was the only region rated as "Poor" (34.9%).
- Eravikulam National Park (Kerala) and Dachigam National Park (J&K) received the highest individual scores of 92.97% each.
- The 2025 edition also included evaluations for 113 Coastal and Marine Protected Areas for the first time.
- A platform called TechBridge was also launched during the event to showcase innovations in conservation technology

- The computer was fabricated at a nanofabrication unit at Penn State, proving the potential for non-silicon alternatives that could lead to smaller and faster devices in the future






- WHO, headquartered in Geneva, Switzerland, has declared Suriname to be the first nation in the Amazon region to be malaria-free. To far, 46 nations and 1 territory have received this designation from WHO.
- The Marine Products Export Development Authority (MPEDA) organized the grand finale of the first National Skill Olympiad on seafood value addition during the Seafood Expo Bharat in Chennai
- National Highways Authority of India (NHAI) has developed India's first dedicated wildlife corridor on a 12-km stretch of the Delhi-Mumbai Expressway in Bundi district, Rajasthan, passing through the buffer zone of the Ranthambore Tiger Reserve
- The Italian Institute of Technology's iRonCub3, the world's first jet-propelled humanoid robot, has achieved a breakthrough in humanoid robotics by lifting off the ground by around 50 cm and remaining stable throughout.
- Sagarmala Finance Corporation Limited (SMFCL), formerly known as Sagarmala Development Company Limited, has been inaugurated as India's first NBFC in the maritime sector

- The scheme supports Self-Help Group (SHG) women to become entrepreneurs under the state's 'One Family, One Entrepreneur' (OF-OE) vision.
- It aims to transform SHGs into Small and Medium Enterprises (SMEs) and set up 9,034 Common Service Centres (CSCs) across Urban Local Bodies (ULBs).
- Selected women will receive support to secure loans between Rs.2 lakh to Rs.2.5 lakh to establish and run CSCs sustainably.





#### **Recent News Headlines Related to Schemes**

- The Union Cabinet chaired by Prime Minister Narendra Modi approved the Employment Linked Incentive (ELI) Scheme, focusing on employment generation, employability, and social security
- The Union Cabinet, chaired by Prime Minister Shri Narendra Modi, has approved the Research Development and Innovation (RDI) Scheme with a corpus of Rs. 1 lakh Crore
- SPREE 2025 (Scheme to Promote Registration of Employers/Employees) has been relaunched by ESIC from July 1 to December 31, 2025. The scheme was originally introduced in 2016, aiming to expand ESI coverage across India
- The Bihar Cabinet has approved the 'Mukhya Mantri Kanya Vivah Mandap Yojana' to construct marriage halls in all 8,053 gram panchayats of the state
- The Ministry of Heavy Industries launched a portal under the Scheme to Promote Manufacturing of Electric Passenger Cars in India (SPMEPCI)
- Ahead of Assembly elections, Bihar CM Nitish Kumar increased the monthly pension under the Social Security Pension Scheme from Rs.400 to Rs.1,100
- The scheme is named Janajati Immersive Holistic Intervention for Novel Development (JAIHIND). It was launched by Delhi University to provide tribal students of classes 9 to 12 from remote areas with practical skills and CUET orientation
- The 'Mukhya Mantrir Jiban Anuprerana' scheme was launched by Assam Chief Minister Himanta Biswa Sarma to provide one-time financial assistance to research scholars, especially Divyang (specially-abled) scholars, to promote research and development in Assam
- Karnataka Chief Minister Siddaramaiah will inaugurate the PM-KUSUM Component C scheme on June 11, 2025, at Gauribidanur, Chikkaballapura district
- Pradhan Mantri Kaushal Vikas Yojana (PMKVY) was launched in 2015 to offer shortterm, industry-relevant skill training to youth. As of April 18, 2025, more than 1.63 crore youth have been trained under this scheme



- The platform uses 2D hydrodynamic flood modeling powered by National Supercomputing Mission (NSM).
- It provides two-day advance flood forecasts up to village level for Mahanadi, Godavari, and Tapi river basins.


- Union Home Minister Amit Shah, speaking at the "A Golden Year of Trust in the Justice System" programme in New Delhi, stated that the new criminal laws will ensure justice is delivered from the FIR stage to the Supreme Court, with clearly defined deadlines for investigation (within 90 days), chargesheet filing, charge framing, and judgment delivery.
- The Indian Penal Code (IPC) has been replaced with Bharatiya Nyay Sanhita (BNS) 2023, CrPC with Bharatiya Nagarik Suraksha Sanhita (BNSS) 2023, and the Indian Evidence Act with Bharatiya Sakshya Adhiniyam (BSA) 2023.
- The focus of these new laws is justice, not punishment.
- Mandatory forensic examination for crimes with punishment of 7+ years and DNA matching in POCSO cases have been introduced.
- E-evidence and e-summons are active in 11 states/UTs, community service in 12, and Nyay Shruti in 6.
- Delhi has been acknowledged as the best-performing region in implementing these reforms.
- For the first time, terrorism and organised crime have been defined legally with provisions for stricter punishment.
















