- The raised funds will be used to finance solar energy projects in Sri Lanka, including ground and rooftop installations.
- DFCC Bank PLC was established in 1955 and is headquartered in Colombo, Sri Lanka.
- The current Chairman of DFCC Bank is Jegatheesan Durairatnam.




- According to the National Statistical Office (NSO), retail inflation (CPI) in May 2025 dropped to 2.82%, the lowest level in 75 months. In April, the rate was 3.16%.
- The primary reason for this dip was the sharp fall in food prices, especially vegetables and pulses.
- The Consumer Food Price Index (CFPI) also declined to 0.99% in May, compared to 1.78% in April, making it the lowest since October 2021.
- HDFC Bank has cautioned that due to heavy rains, some vegetable prices may rise again in select regions.
- Kotak Mahindra Bank observed that downward trends in pulses and cereals are continuing.
- Inflation could remain below the RBI's FY26 forecast of 3.7%.
- The RBI is not expected to cut the repo rate before September 2025, though rate cuts may follow if inflation remains controlled.




- The Reserve Bank of India (RBI) has allowed STRIPS (Separate Trading of Registered Interest and Principal of Securities) for State Government Securities (SGS).
- This facility was previously only applicable to Government of India (GoI) bonds.
- Now extended to bonds issued by states and union territories.
- To be eligible for STRIPS, an SGS must have Minimum outstanding amount of Rs.1,000 crore, and Residual maturity of up to 14 years.
- STRIPS separate the interest (coupon) and principal components of a bond into individual zero-coupon securities, which are Traded at a discount, and Redeemed at face value.
- Its objective is to Enhance liquidity in the primary and secondary markets and promote overall bond market development.


- RBI has reduced the qualifying asset threshold for Non-Banking Financial Companies – Microfinance Institutions (NBFC-MFIs) from 75% to 60% to provide a boost to the sector
- RBI will discontinue daily Variable Rate Repo (VRR) auctions from June 12, 2025, as the liquidity surplus in the banking system has significantly improved
- The Reserve Bank of India (RBI) published data in June 2025 indicating that bank deposit growth in India decreased to 10.6% YoY in FY25, the fiscal year 2024–2025, from 13% in FY24
- Security Printing and Minting Corporation of India Ltd (SPMCIL) delivered 3.4 tonnes of refined gold to the Reserve Bank of India (RBI) during FY25
- RBI has rejected the application of Annapurna Finance for a Universal Bank Licence
- RBI has increased the Loan-to-Value (LTV) ratio for gold jewellery-backed loans up to Rs.2.5 lakh to 85%.
- In the 55th meeting of the Monetary Policy Committee (MPC) held from June 4 to 6, 2025, RBI reduced the Policy Repo Rate by 50 basis points to 5.50%.
- RBI launched a Hindi Book Writing Scheme (2024-25) to encourage original works in Economics, Banking, and Finance. The scheme is open to working or retired professors from UGC-recognized Indian universities
- As per RBI's 2025 amendment titled "Inoperative Accounts/Unclaimed Deposits in Banks - Revised Instructions", any bank deposit not operated for 10 years or more will be transferred to the Depositor Education and Awareness (DEA) Fund
- To address long-standing gaps in climate-related financial data, the Reserve Bank of India (RBI) introduced the "Reserve Bank-Climate Risk Information System (RBI-CRIS)," a two-pronged data platform
- The Reserve Bank of India (RBI) imposed total penalties of Rs.54.78 crore in FY 2024-25 on various regulated entities for statutory violations
- RBI announced a five-part documentary series in collaboration with Jio Hotstar. The series is titled "RBI Unlocked: Beyond the Rupee", produced by Chalkboard Entertainment, a Mumbai-based production house
- RBI's balance sheet expanded by 8.2% in FY 2024-25, reaching a total size of Rs.76.25 lakh crore



- Following this transaction, PhonePe's total stake in CE Info Systems dropped from 18.74% to 13.74%.
- After the stake sale, CE Info Systems' stock price fell 9.39%, closing at Rs.1,768.75.
- PhonePe is a subsidiary of Flipkart, which is owned by Walmart.

- It will provide care for 3,000 paediatric and blood cancer patients and include 215 beds, bone marrow transplant, and immunotherapy services.
- The total campus capacity after this expansion will be 555 beds across 10.7 lakh sq. ft. with 19 LINACs for radiotherapy.

- The Reserve Bank of India (RBI) has extended the deadline for low-risk individual customers to update their KYC (Know Your Customer) details.
- The new deadline is 30 June 2026 or within one year from the due date, whichever is later.
- This move comes in response to a large backlog, especially in accounts opened under DBT (Direct Benefit Transfer), Scholarship schemes and Pradhan Mantri Jan Dhan Yojana (PMJDY)
- RBI has also authorized Business Correspondents (BCs) including NGOs, SHGs, MFIs, and local kirana shopkeepers — to collect self-declarations from customers if there are no changes or only address changes in KYC.
- Banks are mandated to send three advance notices, including one by letter, and conduct awareness camps to ensure smoother KYC completion.


- According to Bank of Baroda Economic Research, India received \$729 billion in cumulative Foreign Direct Investment (FDI) through equity flows from 2000 to March 2025.
- Over 85% of this FDI came from just 12 countries, including Mauritius, Singapore, the US, the UK, and the Netherlands.
- Singapore's share increased significantly from 13% in 2024 to 24% by March 2025, while Mauritius' share declined from 35.2% to 24.7%.
- FDI in the IT software & hardware sector rose dramatically from \$15 billion (2015) to \$111 billion (2025).
- The services sector also grew from \$43 billion to \$118 billion during the same period.
- However, sectors like pharmaceuticals (5.3% → 3.2%) and construction (9.7% → 3.7%) saw declines due to price competition and inventory/land issues, respectively.
- FDI in non-conventional energy (renewables) increased from 1.5% to 3%, and trading sector FDI nearly doubled from 3.2% to 6.5%, thanks to liberalized FDI policies.



- Out of this 62% (Rs.2.54 lakh crore) came from the services segment and 38% (Rs.1.55 lakh crore) from product sales
- GeM has become a key e-procurement platform with 1.6 lakh government buyers and 22.5 lakh sellers/service providers.
- Since launch in 2016, it has processed 2.59 crore+ orders with cumulative GMV of over Rs.11.64 lakh crore.







- The scheme aims to provide one-time financial assistance to research scholars, especially Divyang (specially-abled) scholars, to promote research and development in Assam.
- Benefits given are Rs.25,000 for full-time research scholars and Rs.40,000 for Divyang research scholars
- Eligibility: Permanent residents of Assam studying in state or central public institutions.
- Additionally, the CM also launched the Swagata Satirtha Portal, aimed at simplifying and making the transfer process for government employees more transparent and time-bound.














- Karnataka Chief Minister Siddaramaiah will inaugurate the PM-KUSUM Component C scheme on June 11, 2025, at Gauribidanur, Chikkaballapura district
- Pradhan Mantri Kaushal Vikas Yojana (PMKVY) was launched in 2015 to offer shortterm, industry-relevant skill training to youth. As of April 18, 2025, more than 1.63 crore youth have been trained under this scheme
- Under the EV manufacturing scheme, the minimum investment required in India over 3 years is Rs.4,150 crore (approximately USD 500 million)



- Unlike passive chatbots, Kruti understands voice and text input, remembers past interactions, and adapts to user behavior over time.
- It supports communication in 13 Indian languages and can adjust responses based on tone, length, and context.
- Ola Founder Bhavish Aggarwal described Kruti as a "task-getting AI assistant" that simplifies everyday life, not just a conversational bot.
- Kruti's advanced AI features, such as image creation and research, are available free of cost.

- The Economic Participation and Opportunity subindex improved to 40.7%, but Political Empowerment declined, with women's representation in Parliament at only 13.8%.





- SBI Mutual Fund acquired the entire stake sold by RIL.
- RIL originally invested ₹500 crore in Asian Paints in January 2008, making this exit a 15x return deal.
- Even after this transaction, RIL continues to hold 87 lakh shares in Asian Paints.
- Asian Paints' market share declined from around 60% to 50% in FY25.








- Bengaluru (Karnataka) was declared India's 'Leopard Capital' after a year-long camera-trap survey (2024-2025) conducted by the Holématthi Nature Foundation (HNF).
- The survey estimated 80-85 leopards in the forests and scrublands around Bengaluru, surpassing Mumbai's 54 leopards documented inside Sanjay Gandhi National Park.
- It was conducted over an area of 282 sq km, using more than 250 camera traps.
- Key habitats surveyed included Turahalli, B.M. Kaval, U.M. Kaval, Roerich Estate, and Bannerghatta National Park (BNP).
- Among these, 54 leopards were found inside BNP, and 30+ in other forested areas on Bengaluru's outskirts.



- I-STAR stands for Intelligence, Surveillance, Target Acquisition, and Reconnaissance.
- These aircraft will be capable of detecting, tracking, and targeting enemy infrastructure like radar stations, mobile air defense units, and command hubs — all without entering hostile airspace.
- India plans to procure three aircraft from global aviation companies such as Boeing and Bombardier, which will then be fitted with indigenous sensor and electronic systems developed by DRDO's Centre for Airborne Systems (CABS).

















- IIT Gandhinagar led archaeological research that discovered human presence in the Great Rann of Kutch dating back at least 5,000 years before the Harappan civilisation
- IIT Madras has signed a MOU with Grid Controller of India Limited (GRID-INDIA) under the Ministry of Power to enhance Tanzania's electrical grid infrastructure. The collaboration is based at IIT Madras Zanzibar, the institute's international campus in Tanzania.
- IIT Kharagpur and Singapore's Institute of Microelectronics (IME), under the Agency for Science, Technology and Research (A\*STAR) Signed MOU at SEMICON Southeast Asia 2025 to collaborate on semiconductor research and talent development
- The Bharat Forecast System (BFS) is developed by Indian Institute of Tropical Meteorology (IITM), Pune. It provides a 6 km resolution, which is the highest resolution in the world for weather forecasting
- IIT Delhi launched the 'Manasvi' mentorship programme in New Delhi to inspire high-school girls to pursue careers in STEM fields (Science, Technology, Engineering, Mathematics)

- The 787-8 is considered among the most advanced commercial jets, with a range of 13,530 km and passenger capacity of 248.
- Over 2,500 units of the 787 have been sold globally, including 47 to Air India.
- The crashed aircraft was powered by twin GE Aerospace engines.
- The 787 series is built using composite materials, providing 20% more fuel efficiency and enabling airlines to open new routes without relying on larger aircraft like the Boeing 747.
- Boeing had outsourced a significant portion of the aircraft's structure globally, which later led to supply chain issues, prompting the company to admit it had overextended outsourcing.

- Australia, Fiji, Kenya, Mexico, Palau, and Seychelles have joined France and Brazil in endorsing the initiative.
- These revised NDCs represent the highest form of political commitment under the UN Framework Convention on Climate Change (UNFCCC).

- The Ministry of Electronics & IT (MeitY) has highlighted this as a milestone in India's global collaboration in drone technology.



- He was also the highest goal scorer of the tournament with 8 goals.
