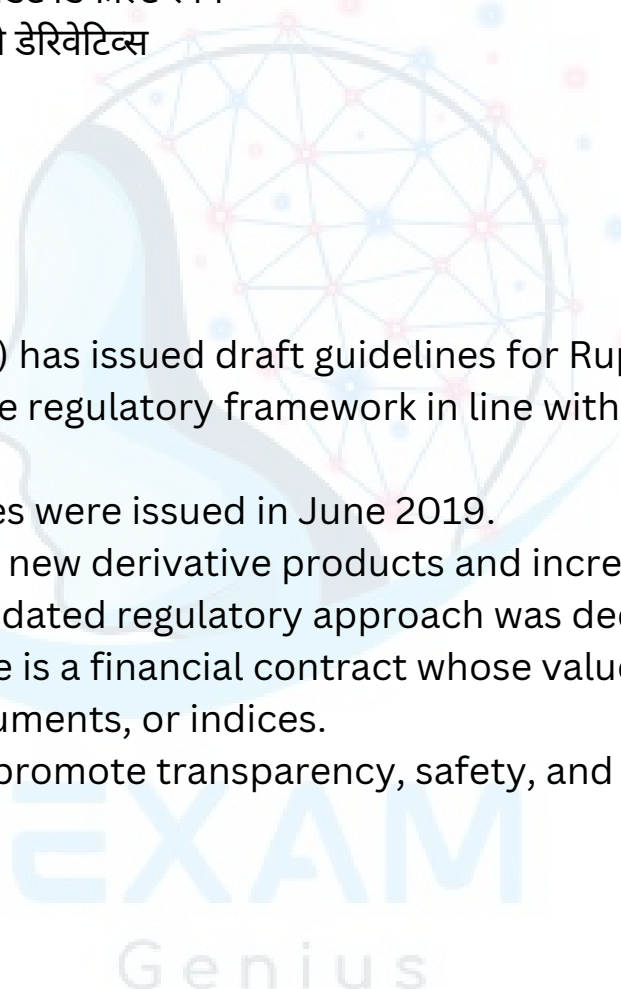

- Reserve Bank of India (RBI) has issued draft guidelines for Rupee Interest Rate Derivatives (IRD) to keep the regulatory framework in line with evolving market dynamics.
- The previous IRD guidelines were issued in June 2019.
- Due to the introduction of new derivative products and increased participation of non-resident entities, an updated regulatory approach was deemed necessary.
- An Interest Rate Derivative is a financial contract whose value is based on rupee interest rates, related instruments, or indices.
- The revised norms aim to promote transparency, safety, and broader market access.

- RBI plans to re-issue sovereign green bonds (SGrBs) during the upcoming government securities (G-Secs) auction on June 13, 2025
- RBI has allowed STRIPS (Separate Trading of Registered Interest and Principal of Securities) for State Government Securities (SGS)
- RBI has extended the deadline for low-risk individual customers to update their KYC (Know Your Customer) details
- RBI has reduced the qualifying asset threshold for Non-Banking Financial Companies – Microfinance Institutions (NBFC-MFIs) from 75% to 60% to provide a boost to the sector
- RBI will discontinue daily Variable Rate Repo (VRR) auctions from June 12, 2025, as the liquidity surplus in the banking system has significantly improved
- The Reserve Bank of India (RBI) published data in June 2025 indicating that bank deposit growth in India decreased to 10.6% YoY in FY25, the fiscal year 2024–2025, from 13% in FY24
- Security Printing and Minting Corporation of India Ltd (SPMCIL) delivered 3.4 tonnes of refined gold to the Reserve Bank of India (RBI) during FY25
- RBI has rejected the application of Annapurna Finance for a Universal Bank Licence

- Indian Renewable Energy Development Agency (IREDA) raised Rs.2,005.90 crore via Qualified Institutional Placement (QIP)
- The Asian Development Bank (ADB) approved a \$109.97 million (Rs.927 crore) results-based loan to Gujarat

- It was launched on June 16, 2025, in Goa by Smt. Kavita Harbola, in the presence of ADG Anil Kumar Harbola, Commander (Western Seaboard).
- The vessel is 52 meters long, 8 meters wide, and weighs 320 tons, capable of reaching a top speed of 27 knots using a CPP-based propulsion system.
- It features 60% indigenous content and dual certification from the American Bureau of Shipping and the Indian Register of Shipping.
- Built at a cost of ₹473 crore, it supports MSME employment and Aatmanirbhar Bharat goals, while enhancing maritime patrol and surveillance capabilities.

- This move aligns with India's strategic goal of building a self-reliant rare earth value chain to support indigenous manufacturing.

- The move is part of the PM-WANI (Prime Minister Wi-Fi Access Network Interface) scheme, which seeks to expand affordable internet access via public Wi-Fi.
- TRAI observed that some Internet Service Providers (ISPs) were charging 40–80 times higher than residential broadband rates for commercial hotspot setups.
- The new rule mandates that hotspot operators be charged no more than residential users, making Wi-Fi access more feasible for small entrepreneurs and public use.
- While Broadband India Forum and Tata Communications opposed the cap citing commercial impacts, TRAI stood firm to ensure internet affordability and digital inclusion.

- South Africa clinched the ICC World Test Championship 2025 title by defeating defending champions Australia in the final held at Lord's, London
