- This funding will be directed towards projects aligned with Sustainable Development Goals (SDGs), covering Ethanol plants and Electric vehicles (EVs)
- Other eco-friendly and sustainable infrastructure initiatives is the minimum loan amount per project under this scheme is Rs.100 crore.
- Eligible borrowers include Central and State governments, government agencies, and private sector entities.
- As per Deputy MD Ajay Kumar Sood, this facility was initially launched in FY25 and is being scaled up in FY26.

RECENT LOANS AND AGREEMENTS :

- NTPC Limited secured a USD 750 million loan via External Commercial Borrowing (ECB) for financing capital expenditure and renewable energy projects
- CreditAccess Grameen (CA Grameen), India's largest NBFC-MFI, secured a USD 100 million loan via External Commercial Borrowing (ECB)
- Indian Renewable Energy Development Agency (IREDA) raised Rs.2,005.90 crore via Qualified Institutional Placement (QIP)
- The Asian Development Bank (ADB) approved a \$109.97 million (Rs.927 crore) results-based loan to Gujarat
- Adani Airports Holdings Limited (AAHL), a subsidiary of Adani Enterprises, has raised \$750 million (6250 crore) through External Commercial Borrowings (ECB)
- Asian Development Bank (ADB) President Masato Kanda announced that ADB is ready to provide up to \$4.5 billion annually in sovereign lending to India
- The Asian Development Bank (ADB) has committed up to \$10 billion over 5 years for India's urban transformation, including metro expansions
- Vivriti Asset Management (VAM) Secured USD 20 Million from Vienna (Austria)-based Development Bank of Austria (OeEB) for its Vivriti India Retail Assets Fund (VIRAF), bolstering the fund's capital base to USD 165 million
- Bank of Maharashtra has sanctioned Rs.1500 crore to the Mumbai Metropolitan Region Development Authority (MMRDA)
- Uttarakhand secures Rs 1910 crore urban development funding from European Investment Bank (EIB) to enhance urban infrastructure development across four cities (Pithoragarh, Sitarganj, Rudrapur, and Kashipur) in Uttarakhand
- A loan of \$85.4 million has been authorized by the Asian Development Bank (ADB) to finance essential industrial infrastructure in Tripura's nine industrial complexes
- As of December 31, 2024, the Asian Development Bank has committed \$59.5 billion in loans to India overall, up from \$55.3 billion in 2023
- Argentina and the International Monetary Fund inked a \$20 billion, 48-month Extended Fund Facility agreement
- National Bank for Financing Infrastructure and Development (NaBFID) has provided a loan of Rs.1,787 crore to BluPine Energy Private Limited to optimize financial structuring, enhance operational efficiency, and fuel portfolio expansion
- India and Japan have signed credit agreements totaling 191.736 billion Japanese yen for six projects through Japan's Official Development Assistance (ODA) to India

- As per UNCTAD's World Investment Report 2025, India ranked 15th in the world in terms of Foreign Direct Investment (FDI) inflows for the year 2024, improving one spot from the previous year.
- FDI inflows remained stable at \$27.6 billion, almost the same as in 2023.
- India retained its 4th position globally in greenfield project announcements, showing continued investor interest in new projects.
- However, India dropped to 5th place in international project finance deals (97 deals in 2024 vs. 123 in 2023).
- India is also among the few developing nations receiving over 30% of its FDI in renewable energy and infrastructure, signaling a green investment shift.

Top 5 FDI recipient countries in 2024:

- USA – \$279 billion
- Singapore – \$68 billion
- Hong Kong – \$62 billion
- China – \$61 billion
- Netherlands – \$54 billion





Ques: What is the new priority sector lending (PSL) requirement for Small Finance Banks (SFBs) as per RBI's updated guidelines for FY 2025-26 onward?

Explanation:

- The Reserve Bank of India (RBI) has revised the priority sector lending (PSL) norms for Small Finance Banks (SFBs) effective from FY 2025-26.
- Earlier, SFBs were mandated to lend 75% of their Adjusted Net Bank Credit (ANBC) or Credit Equivalent of Off-Balance Sheet Exposures (CEOBE) to priority sectors.
- Out of the revised 60% , 40% remains fixed for core PSL categories (like agriculture, MSMEs, etc.) and The remaining 20% can be allocated to one or more sub-sectors where the bank has a competitive advantage.
- Under the revised norms:
 - The additional 35% PSL component has been reduced to 20%.
 - Thus, the overall PSL target now stands at 60% of ANBC or CEOBE, whichever is higher.





Recent News Headlines Related to RBI

- RBI has revised the agency commission structure for banks managing government-related transactions such as revenue receipts, pension disbursements, and other payments.
- RBI discontinued its daily Variable Rate Repo (VRR) auctions due to a liquidity surplus of Rs. 2.75 to Rs. 3 lakh crore in the banking system, exceeding 1% of Net Demand and Time Liabilities (NDTL), effective from 11 June 2025.
- On June 16, 2025, RBI Deputy Governor T. Rabi Sankar inaugurated the new Regional Office of the Reserve Bank of India in Vijayawada, Andhra Pradesh
- Telecom Regulatory Authority of India (TRAI), in collaboration with RBI and banks, launched a pilot project to digitise legacy user consents
- RBI has issued draft guidelines for Rupee Interest Rate Derivatives (IRD) to keep the regulatory framework in line with evolving market dynamics
- RBI plans to re-issue sovereign green bonds (SGrBs) during the upcoming government securities (G-Secs) auction on June 13, 2025
- RBI has allowed STRIPS (Separate Trading of Registered Interest and Principal of Securities) for State Government Securities (SGS)
- RBI has extended the deadline for low-risk individual customers to update their KYC (Know Your Customer) details
- RBI has reduced the qualifying asset threshold for Non-Banking Financial Companies – Microfinance Institutions (NBFC-MFIs) from 75% to 60% to provide a boost to the sector
- RBI will discontinue daily Variable Rate Repo (VRR) auctions from June 12, 2025, as the liquidity surplus in the banking system has significantly improved
- The Reserve Bank of India (RBI) published data in June 2025 indicating that bank deposit growth in India decreased to 10.6% YoY in FY25, the fiscal year 2024–2025, from 13% in FY24
- Security Printing and Minting Corporation of India Ltd (SPMCIL) delivered 3.4 tonnes of refined gold to the Reserve Bank of India (RBI) during FY25
- RBI has rejected the application of Annapurna Finance for a Universal Bank Licence
- RBI has increased the Loan-to-Value (LTV) ratio for gold jewellery-backed loans up to Rs.2.5 lakh to 85%.
- In the 55th meeting of the Monetary Policy Committee (MPC) held from June 4 to 6, 2025, RBI reduced the Policy Repo Rate by 50 basis points to 5.50%.

- The Reserve Bank of India (RBI) has eased project funding norms, especially for under-construction loans, to support infrastructure financing and reduce liquidity stress on banks.
- Effective from October 1, 2025, the standard asset provisioning requirement has been reduced to 1% from the earlier proposed 5% for general under-construction project finance loans.
- For under-construction commercial real estate (CRE), the provisioning will be 1.25%. Once the project becomes operational, provisioning rates will be 1% for CRE, 0.75% for CRE-RH (Residential Housing) and 0.40% for other projects.
- This phased approach is aimed at encouraging project finance by making capital requirements more flexible as risk reduces post-completion.
- The reform is expected to boost infrastructure lending and ease cash flow pressure on financial institutions.

- The Reserve Bank of India (RBI) has amended the Master Direction – Import of Goods and Services, originally issued on January 1, 2016.
- Under the new circular, Authorised Dealer Category-I (AD Cat-I) banks are now allowed to permit advance remittances for shipping vessel imports.
- The major relaxation is Importers can send advance remittance up to USD 50 million. No requirement for bank guarantee or an unconditional, irrevocable standby Letter of Credit (LC).
- This move aims to ease international trade and boost the shipping industry.
- The circular is issued under Section 10(4) and Section 11(1) of the Foreign Exchange Management Act (FEMA), 1999.

- Amrita Vishwa Vidyapeetham was ranked 41st, and Lovely Professional University (LPU) was placed at 48th.
- JSS Academy of Higher Education and Shoolini University were jointly ranked 96th.
- A total of 135 Indian institutions participated, but only these four made it to the top 100.
- The rankings evaluate universities based on performance indicators such as research, outreach, and campus operations related to SDGs like SDG 4: Quality Education, SDG 7: Affordable and Clean Energy and SDG 6 & Lifelong Learning: Water sustainability and education access
- Notably, Amrita Vishwa Vidyapeetham scored 100/100 in lifelong learning and water sustainability metrics.
- Western Sydney University (Australia) retained its top global rank for the fourth consecutive year.

- George Russell, representing Germany-based Mercedes, clinched his first Formula One (F1) Grand Prix victory of the 2025 season by winning the 63rd edition of the Canadian Grand Prix
- The Hockey Unit of Tamil Nadu (HUTN), officially announced that it will host the inaugural edition of the Hockey India Masters Cup for men (40+ age group) and women (35+ age group) from June 18 to 27 at the Mayor Radhakrishnan hockey stadium

- The GBU-57A/B Massive Ordnance Penetrator (MOP), also known as a "bunker buster", is a 30,000-pound (13,600 kg) precision-guided bomb developed by the United States.
- It is designed to penetrate up to 200 feet (61 meters) of reinforced concrete or rock before detonation, making it effective against deeply buried nuclear sites or military bunkers.
- The bomb is 6.6 meters long and features a hardened steel casing and a specialised delayed-fuse system for deep penetration.
- The only aircraft capable of deploying the GBU-57 is the B-2 Spirit stealth bomber, developed by Northrop Grumman.
- The B-2 has a range of up to 11,500 miles (18,500 km) with aerial refueling and can carry two GBU-57 bombs.
- As tensions rise in the Middle East, this bomb has come into focus as one of the few capable of striking Iran's fortified nuclear facilities.

- 40% of the world's land area is increasingly experiencing frequent and severe droughts.
- The economic cost of an average drought is projected to rise by 3% to 7.5% annually.
- By 2035, there is a minimum 35% projected increase in drought-related economic losses.
- Since 1980, 37% of global land has seen significant soil moisture loss, and groundwater levels are declining in many regions.

- The first Indian epigraphical reference to Halley's Comet was found in a 1456 CE copper plate inscription at the Mallikarjunaswamy Temple in Srisailam, Andhra Pradesh.
- The inscription, from the Vijayanagara period, is written in Sanskrit using the Nagari script.
- It mentions the appearance of a comet and meteor shower, matching the historical record of Halley's Comet in 1456 CE.
- The grant was made by Vijayanagara ruler Mallikarjuna on June 28, 1456 CE (Śaka 1378, Āshāḍha ba. 11) to a Vedic scholar named Limṅaṇarya.
- The grant was given to mitigate the calamity believed to be caused by the comet.
- The donated village was named Simgapura, located in Kelajhasima of Hastinavati Vemṭhe.
- Although comets (dhūmaketus) are mentioned in ancient texts, this is the first known inscriptional evidence of Halley's Comet in Indian history.

- The word Solstice comes from Latin, meaning "stalled sun".
- It is a natural astronomical event that occurs twice every year, once in summer and once in winter, in each hemisphere.
- On 21st June, the Northern Hemisphere experiences the longest day and shortest night of the year.
- This is because the Sun shines directly overhead on the Tropic of Cancer (23.5° North), and the North Pole is tilted towards the Sun, while the South Pole is tilted away.
- The Earth's axis, which is always tilted at 23.5 degrees, is responsible for this phenomenon.
- In contrast, Equinoxes occur twice a year when the Earth's axis is perpendicular to the Sun's rays, resulting in nearly equal day and night across the globe.
- The Vernal (Spring) Equinox occurs around March 20 or 21, and the Autumnal Equinox around September 22 or 23 in the Northern Hemisphere.
