Explanation:

- The Reserve Bank of India (RBI) has set the Financial Inclusion Index (FI-Index) at 67.0 for March 2025, which is an improvement from 64.2 in March 2024.
- The index is constructed without any base year and was first published in August 2021.
- It measures financial inclusion based on three dimensions : Access – 35%, Usage – 45% and Quality – 20%
- The index score ranges between 0 to 100, where 0 means complete exclusion and 100 means full inclusion.
- The improvement in FY 2025 was driven mainly by increased Usage and Quality, indicating better financial literacy and service standards.

- RBI Permits Currant Sea Investments B.V to Acquire 9.99% Stake in Infrastructure Development Finance Company (IDFC) First Bank at a Cost of Rs.4876 crores
- RBI included NSDL Payments Bank Limited in the Second Schedule of the RBI Act, 1934 through a notification dated June 19, 2025
- EximPe has received in-principle approval from the Reserve Bank of India (RBI) to operate as a Payment Aggregator for Cross-Border (PA-CB) transactions
- RBI has amended the Basel III Capital Regulations to expand credit rating options for Scheduled Commercial Banks (excluding Local Area Banks, Payments Banks, and Regional Rural Banks)
- RBI has issued draft guidelines for the closure of shipping bills in the Export Data Processing and Monitoring System (EDPMS)
- According to RBI guidelines, a Jan Dhan account is marked as “inoperative” if no customer-initiated transaction occurs for 24 consecutive months
- TZF Logistics Solutions, a subsidiary of logistics-tech firm BlackBuck, has received the Prepaid Payment Instrument (PPI) licence from the Reserve Bank of India (RBI)
- RBI has disclosed that Rs.2000 denomination banknotes valued at Rs.6,099 crore are still in circulation, despite being withdrawn from active use on May 19, 2023.
- RBI has barred banks, NBFC-ULs, and certain other lenders from levying foreclosure or prepayment charges on floating rate loans extended to Micro and Small Enterprises (MSEs) and on floating rate personal loans.
- RBI has granted in-principle approval to Saraswat Co-operative Bank (SCB) for the acquisition of the New India Co-operative Bank (NICB) under the voluntary amalgamation scheme for Urban Co-operative Banks (UCBs)
- As per the RBI’s June 2025 Financial Stability Report, the Gross Non-Performing Assets (GNPA) ratio of Scheduled Commercial Banks (SCBs) is projected to rise marginally from 2.3% in March 2025 to 2.5% by March 2027 under the baseline scenario
- According to the June 2025 edition of RBI’s Financial Stability Report (FSR), India's household debt as a percentage of GDP declined from 42.9% (June 2024) to 41.9% (December 2024).
- RBI has revised the operational hours for SDF and MSF. Effective July 1, 2025, these liquidity tools will now be available from 7:00 PM to 11:59 PM every day

- These top five states together account for nearly 50% of all active GST taxpayers.
- As of May 31, 2025, India has over 1.52 crore active GST registrations, and gross GST collection has nearly doubled over five years — from Rs.11.4 lakh crore in FY21 to Rs.22.1 lakh crore in FY25.

- Each Bima Sakhi will aim to insure 24 individuals annually and earn commission, thereby promoting insurance awareness and financial inclusion in rural areas.

- BITS Pilani will invest a total of Rs.2,319 crore to expand its presence and academic offerings
- Interorient Navigation Co Limited and Danship & Partners Limited, two major shipping firms based in Cyprus, announced a Rs.10,000 crore investment in India's shipping industry in 2025
- Asian Infrastructure Investment Bank (AIIB) provide \$100 million loan to IIFL Home Finance Limited to help more low-income families in India get access to affordable housing

- Other initiatives under this grant include solar electrification for 10,000 Buddhist temples and Pirivenas and the classical language status accorded to Pali by India.

- Since January 2025, TCS has lost ₹3.4 lakh crore in market cap, while Bharti Airtel has gained Rs.1.95 lakh crore.
- Reliance Industries (Rs.19.33 lakh crore) and HDFC Bank (Rs.15.34 lakh crore) continue to hold the first and second spots respectively.
- Other top companies by market cap include ICICI Bank, SBI, Infosys, Bajaj Finance, LIC, and HUL.

- WiFEX (Winter Fog Experiment) was launched in 2015 at Indira Gandhi International Airport, New Delhi, and has now completed 10 years of dedicated research into dense winter fog over North India.
- It is led by the Indian Institute of Tropical Meteorology (IITM) under the Ministry of Earth Sciences, with support from IMD and NCMRWF.
- It is one of the few global open-field experiments solely focused on fog, helping improve aviation safety and forecasting over the Indo-Gangetic Plain.
- Researchers used instruments like ceilometers, micrometeorology towers, and high-frequency sensors to collect data.
- A 3 km high-resolution probabilistic fog prediction model developed under WiFEX now achieves over 85% accuracy for very dense fog (visibility below 200 meters).

- Under the Special Intensive Revision (SIR) of the electoral records, the previous cap of 1,500 electors per station has been changed to 1,200. Since this expansion, Bihar's total number of polling places has increased from 77,895 to 90,712.

- Suhani Shah became the first Indian female mentalist to win at the International Federation of Magic Societies (FISM). She was born on January 29, 1990, in a Marwari family from Udaipur, Rajasthan.
- Maharashtra becomes the 1st state in India to granted agricultural status to livestock farming, aimed to support small farmers engaged in dairy, poultry, goat, and pig rearing, in rural areas of the state.
