



- To address the rising issue of digital payment frauds, the Reserve Bank of India (RBI) is collaborating with major public and private sector banks to build a new platform named DPIP (Digital Payment Intelligence Platform).
- DPIP will function as a Digital Public Infrastructure (DPI) under RBI's supervision and will enable real-time intelligence sharing and advanced data analytics to detect and prevent digital frauds.
- This initiative is a direct response to the growing fraud volumes, which reached Rs.36,014 crore in FY25, with a large chunk of these being digital in nature.
- The platform is expected to become operational within a few months and will significantly enhance fraud risk management across the Indian banking ecosystem.




- RBI has revised the priority sector lending (PSL) norms for Small Finance Banks (SFBs) effective from FY 2025-26
- RBI has eased project funding norms, especially for under-construction loans, to support infrastructure financing and reduce liquidity stress on banks
- RBI has amended the Master Direction Import of Goods and Services, originally issued on January 1, 2016
- RBI has revised the agency commission structure for banks managing governmentrelated transactions such as revenue receipts, pension disbursements, and other payments.
- RBI discontinued its daily Variable Rate Repo (VRR) auctions due to a liquidity surplus of Rs. 2.75 to Rs. 3 lakh crore in the banking system, exceeding 1% of Net Demand and Time Liabilities (NDTL), effective from 11 June 2025.
- On June 16, 2025, RBI Deputy Governor T. Rabi Sankar inaugurated the new Regional Office of the Reserve Bank of India in Vijayawada, Andhra Pradesh
- Telecom Regulatory Authority of India (TRAI), in collaboration with RBI and banks, launched a pilot project to digitise legacy user consents
- RBI has issued draft guidelines for Rupee Interest Rate Derivatives (IRD) to keep the regulatory framework in line with evolving market dynamics
- RBI plans to re-issue sovereign green bonds (SGrBs) during the upcoming government securities (G-Secs) auction on June 13, 2025
- RBI has allowed STRIPS (Separate Trading of Registered Interest and Principal of Securities) for State Government Securities (SGS)
- RBI has extended the deadline for low-risk individual customers to update their KYC (Know Your Customer) details
- RBI has reduced the qualifying asset threshold for Non-Banking Financial Companies - Microfinance Institutions (NBFC-MFIs) from 75% to 60% to provide a boost to the sector



- This update aims to improve the accuracy of retail inflation measurement and serve as a more effective macroeconomic indicator.





- The move is intended to safeguard government funds and ensure higher standards of banking service in the implementation of public welfare schemes.









- The Income Tax Department has granted a 10-year TDS exemption under Section 80LA for specified businesses operating in the International Financial Services Centre (IFSC).
- The exemption covers 17 types of payments including professional fees, interest income, rent, technical services, and brokerage commissions.
- It applies to entities like Recognised Stock Exchanges, Finance Companies, Fund Managers, and Depositories, among others.
- Effective from July 1, the exemption can be availed for any 10 consecutive assessment years as selected by the payee.
- To avail the exemption, beneficiaries must submit Form No. 1, and the payer shall not deduct TDS during those years.
- The move aims to promote export-oriented financial services in the IFSC by reducing the tax burden and boosting business.




- The Government of India is set to notify the Legal Metrology (Indian Standard Time) Rules, 2025 to make the use of Indian Standard Time (IST) mandatory for legal, commercial, digital, and administrative purposes.
- IST (UTC+5:30) is calculated from the 82°30'E meridian which passes through Mirzapur, Uttar Pradesh and is maintained by CSIR-NPL.
- Historically, regions like Assam use an informal time called 'Chaibagan Time', which is one hour ahead of IST, introduced by British tea companies for productivity.
- The move towards 'One Nation, One Time' seeks to eliminate multiple time practices and standardize official timing across the country.

- It is the last warship of the Indian Navy to be constructed outside India, marking a milestone in the Atmanirbhar Bharat and Make in India initiatives.
- Part of the Krivak-class (Tushil class), INS Tamal will be the eighth such frigate to be inducted from Russia.
- The vessel includes 26% indigenous components, including the BrahMos missile system, advanced sensors, and weapons.
- Weighing 3,900 tonnes, it features enhanced stealth and stability, and will join the Western Fleet post-commissioning.

















- INS Teg is a stealth Talwar-class guided missile frigate of the Indian Navy, deployed in the South West Indian Ocean Region
- The GBU-57A/B Massive Ordnance Penetrator (MOP), also known as a "bunker buster", is a 30,000-pound (13,600 kg) precision-guided bomb developed by the **United States**
- Russia has trademarked technology for launching autonomous spacecraft from orbital stations. This will be the world's first drone platform with self-maintenance robotic systems
- Rudrastra is an indigenously developed VTOL (Vertical Take-Off and Landing) drone tested by the Indian Army for precision strikes
- 'Achal' is the 5th Fast Patrol Vessel (FPV) in a series of 8 being constructed by Goa Shipyard Ltd. (GSL) for the Indian Coast Guard
- The Indian Air Force (IAF) is set to acquire I-STAR aircraft under a Rs.10,000 crore project, which is expected to be cleared soon by the government
- INS Arnala is the first Anti-Submarine Warfare Shallow Water Craft (ASW-SWC) of the Indian Navy. It will be commissioned on 18 June 2025 at the Naval Dockyard in Visakhapatnam, presided over by General Anil Chauhan, Chief of Defence Staff
- MSC Irina is the world's largest container ship, with a carrying capacity of 24,346 TEUs (Twenty-foot Equivalent Units).
- The MV Wan Hai 503, a Singapore-flagged container vessel, caught fire 88 nautical miles off the Beypore coast in Kerala
- The Indian Navy will commission INS Arnala, the first Anti-Submarine Warfare Shallow Water Craft (ASW-SWC), on June 18, 2025, at Naval Dockyard, Visakhapatnam
- The yacht 'Triveni', indigenously built, was used for India's first-ever international open-sea sailing mission by an all-women Tri-Services team
- The Pinaka Multi Barrel Rocket Launcher (MBRL) is a modern, high-precision indirect fire weapon system developed by the Armament Research & Development Establishment (ARDE)



- Record 2: On June 21, more than 3 lakh people participated in a synchronized yoga session along a 28-km stretch of RK Beach in Visakhapatnam, led by Prime Minister Narendra Modi.
- Andhra Pradesh Chief Minister N. Chandrababu Naidu described IYD 2025 as a historic event for the state.

- The International Cricket Council (ICC) is considering allowing four-day Test matches for smaller nations during the 2027-29 World Test Championship cycle.
- However, traditional cricketing powerhouses like India, Australia, and England will still be allowed to play five-day Tests.
- The aim is to enable smaller nations to play more Test matches and longer series.
- The 2025-27 cycle will continue with the five-day format, starting with Sri Lanka vs Bangladesh.
- In four-day Tests, a minimum of 98 overs per day will be mandated instead of 90 to compensate for lost time.


- Neeraj Chopra, India's star javelin thrower, won the Paris Diamond League 2025 with a top throw of 88.16 metres in his very first attempt
- The 12th edition of the World Para Athletics Championships will be held in New Delhi from September 27 to October 5, 2025 – for the first time in India
- The 10th ICC Women's T20 World Cup will be held in 2026 and will be hosted by England
- The International Shooting Sport Federation (ISSF) organized the Munich leg of the Rifle/Pistol and Shotgun World Cup 2025 in Munich, Germany
- George Russell, representing Germany-based Mercedes, clinched his first Formula One (F1) Grand Prix victory of the 2025 season by winning the 63rd edition of the Canadian Grand Prix

- Hillang Yajik from Arunachal Pradesh won 1 gold and 1 silver medal at the 15th South Asian Bodybuilding and Physique Sports Championships 2025 in Thimphu, Bhutan
- Nishant Dev, an Indian boxer, won his second professional fight against Josue Silva by a majority decision of 60-54 in a Super Welterweight match at Madison Square Garden Theatre in New York.
- U Mumba defeated Jaipur Patriots 8-4 in Ahmedabad to win the Ultimate Table Tennis Season 6 title

- The facility is part of a 7:3 joint venture between IFFCO's subsidiary IFFCO Nanoventions and Brazilian company NANOFERT.
- The plant will have a production capacity of 4.5 million litres per year, with trial production expected to begin by the end of 2025.
- The move aims to meet rising global demand for nano-fertilisers, which have shown effectiveness in increasing crop yields and reducing traditional fertiliser use by over 20% in crops like corn, soybean, sugarcane, and coffee.




- Uttarakhand has become the first state in India to launch a Yoga Policy, announced by Chief Minister Pushkar Singh Dhami on the 11th International Yoga Day.
- The policy includes up to Rs.20 lakh subsidy for establishing yoga and wellness centres and up to Rs.10 lakh in grants for research in yoga, meditation, and naturopathy.
- The state aims to establish five new yoga hubs by 2030 and ensure yoga services in all AYUSH Health and Wellness Centers by March 2026.
- A booklet on the Yoga Policy was released and a sapling was planted under the initiative "Ek Vriksha, Yoga Ke Naam".
- Uttarakhand will also set up one Spiritual Economic Zone each in Garhwal and Kumaon, and two new cities focused on yoga, ayurveda, and spirituality in mountainous areas.





- The National Institute of Immunohaematology (NIIH), under the Indian Council of Medical Research (ICMR), launched India's first national rare blood donor registry in Mumbai.
- This registry will help patients with rare blood groups (such as those with thalassemia or sickle cell disease) who require frequent blood transfusions.
- Rare blood groups are defined by absence of high-frequency antigens, negative for common antigen combinations, or null phenotypes.
- The registry will be integrated with the e-Raktkosh portal a centralized blood bank management system launched on 7th April 2016.
- Most Indian blood banks currently test only for ABO and RhD, while the International Society of Blood Transfusion (ISBT) recognizes 360+ antigens in 47 blood group systems, many of which are not routinely tested.



- The revised amount will be credited to beneficiaries' accounts by the 10th of every month, starting from July 2025.
- This move counters RJD's earlier promise under the Mai-Baap Samman Yojna to raise pensions to Rs.1,500.
- The CM also highlighted the Jeevika Project, which has empowered 1.4 crore women through self-help groups.























- The National Chambal Sanctuary, spanning MP, Rajasthan, and UP, hosts about 77% of the global gharial population.
- The Project Crocodile was launched in 1975 with UNDP and FAO support to protect species like the gharial.









