- This move supports India's commitments under its Nationally Determined Contributions (NDCs) as part of the Paris Agreement 2015, helping the country transition to a sustainable infrastructure ecosystem.

- SBI also reported significant growth in deposits (Rs.53.82 lakh crore) and advances (Rs.41.63 lakh crore), showing massive expansion since its inception.
- The bank now holds 22.5% of total deposits and 19.4% of total credit among all scheduled commercial banks in India.

- The Reserve Bank of India (RBI) has granted in-principle approval to Saraswat Co-operative Bank (SCB) for the acquisition of the New India Co-operative Bank (NICB) under the voluntary amalgamation scheme for Urban Co-operative Banks (UCBs).
- NICB faced a crisis in February 2025 after an RBI inspection revealed ₹122 crore fund misappropriation.
- As of March 2025, SCB had a total business of ₹91,800 crore, while NICB stood at ₹3,500 crore.
- The acquisition aims to safeguard depositors' interests and is subject to approval by the shareholders of both banks.
- With this move, SCB will add 27 NICB branches to its existing 312 branches, marking its 8th acquisition of a stressed UCB.





Recent News Headlines Related to RBI

- As per the RBI's June 2025 Financial Stability Report, the Gross Non-Performing Assets (GNPA) ratio of Scheduled Commercial Banks (SCBs) is projected to rise marginally from 2.3% in March 2025 to 2.5% by March 2027 under the baseline scenario
- According to the June 2025 edition of RBI's Financial Stability Report (FSR), India's household debt as a percentage of GDP declined from 42.9% (June 2024) to 41.9% (December 2024).
- RBI has revised the operational hours for SDF and MSF. Effective July 1, 2025, these liquidity tools will now be available from 7:00 PM to 11:59 PM every day
- According to the RBI, India's external debt rose by 10% to USD 736.3 billion at the end of March 2025, up from USD 668.8 billion in March 2024
- RBI has issued new guidelines to tighten the security of Aadhaar Enabled Payment System (AePS) transactions and reduce fraud risks

- This move targets mainstream investors by reducing technical barriers and has been driven by the fact that 34% of active CoinSwitch users engaged with new tokens in the past 6 months.
- Globally, DEX platforms recorded \$2.45 trillion in trading volume in the last year, highlighting the growing adoption of decentralised crypto trading.

- Mail/Express (Non-AC) : Increase by 1 paisa/km for all classes
- AC Classes (Mail/Express) : Increased by 2 paisa/km across categories (AC Chair Car to Executive Anubhuti)

- Changes applicable to tickets booked on or after 01.07.2025
- Suburban fares and season tickets remain unchanged

- Ministry of Coal is now set to launch the Exploration Module on the Single Window Clearance System web portal through Central Mine Planning and Design Institute Limited, scheduled to be inaugurated by the Union Minister of Coal on 4th July 2025.
- The Ministry of Power has announced the launch of a task force to conceive the India Energy Stack (IES), a pioneering initiative aimed at creating a unified, secure, and interoperable digital infrastructure for India's energy sector
- The Ministry of New and Renewable Energy (MNRE) has issued revised guidelines under the Waste-to-Energy Programme, a sub-scheme of the National Bioenergy Programme

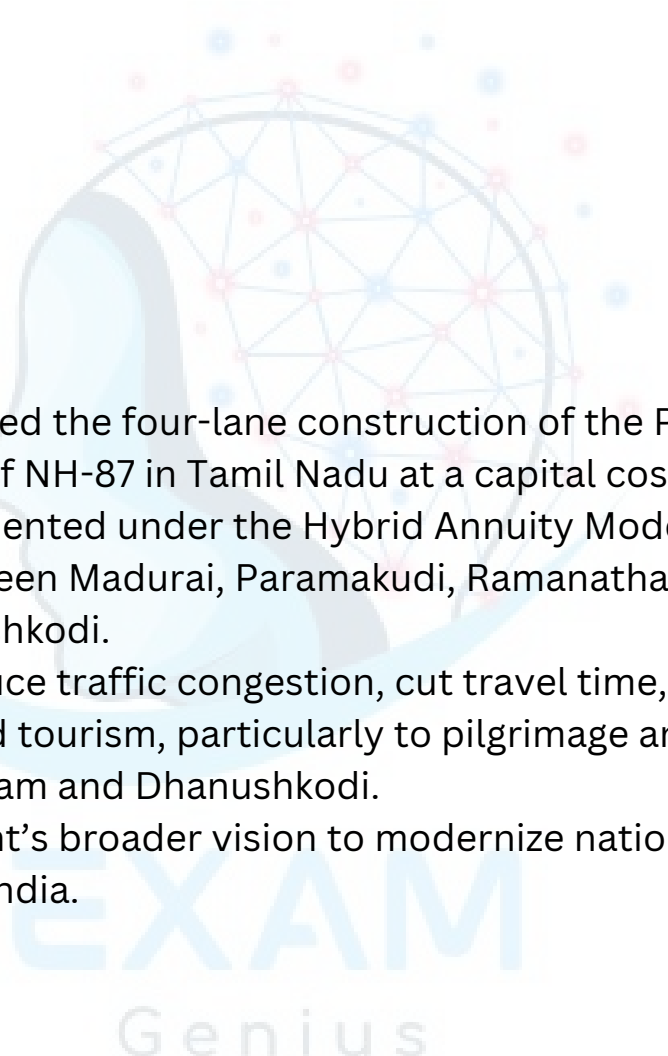

- The Union Cabinet approved the four-lane construction of the Paramakudi–Ramanathapuram section of NH-87 in Tamil Nadu at a capital cost of Rs.1,853 crore.
- The project will be implemented under the Hybrid Annuity Mode (HAM) and will enhance connectivity between Madurai, Paramakudi, Ramanathapuram, Mandapam, Rameshwaram, and Dhanushkodi.
- This new highway will reduce traffic congestion, cut travel time, and boost economic development and tourism, particularly to pilgrimage and coastal destinations like Rameswaram and Dhanushkodi.
- It is part of the government's broader vision to modernize national highway infrastructure in southern India.

- The G7 nations, under Canada's presidency, have agreed to a "side-by-side" taxation model for U.S. multinational companies, exempting them from the 15% global minimum corporate tax under the OECD's Pillar Two.
- Under this model, U.S. companies will be taxed only in the United States — not in the foreign jurisdictions where they operate.
- This exemption was advocated by the Donald Trump administration to ensure exclusive U.S. taxing rights on both domestic and foreign income of its corporations.
- This move marks a major deviation from the 2021 OECD global tax agreement, where nearly 140 countries agreed to:
 - Pillar One: Reallocate taxing rights over large MNCs
 - Pillar Two: Impose a 15% minimum corporate tax to prevent profit shifting and tax base erosion.

- The Department of Telecommunications (DoT), under the Ministry of Communications, in collaboration with NDMA (Ministry of Home Affairs), has initiated nationwide testing of an indigenous Cell Broadcast (CB) Disaster Alert System.
- This system is designed to instantly send alerts to all mobile phones in a specific area during natural disasters or emergencies such as earthquakes, tsunamis, lightning, gas leaks, etc.
- Unlike SMS (sent individually), Cell Broadcast sends messages to all devices in an area simultaneously, making it faster and more reliable.
- It was developed by C-DOT (Centre for Development of Telematics) in Bengaluru, Karnataka, and complements the SMS-based SACHET portal.
- The system is already active in all 36 States/UTs and has delivered over 6,899 crore alerts in 19 Indian languages during past disaster events.

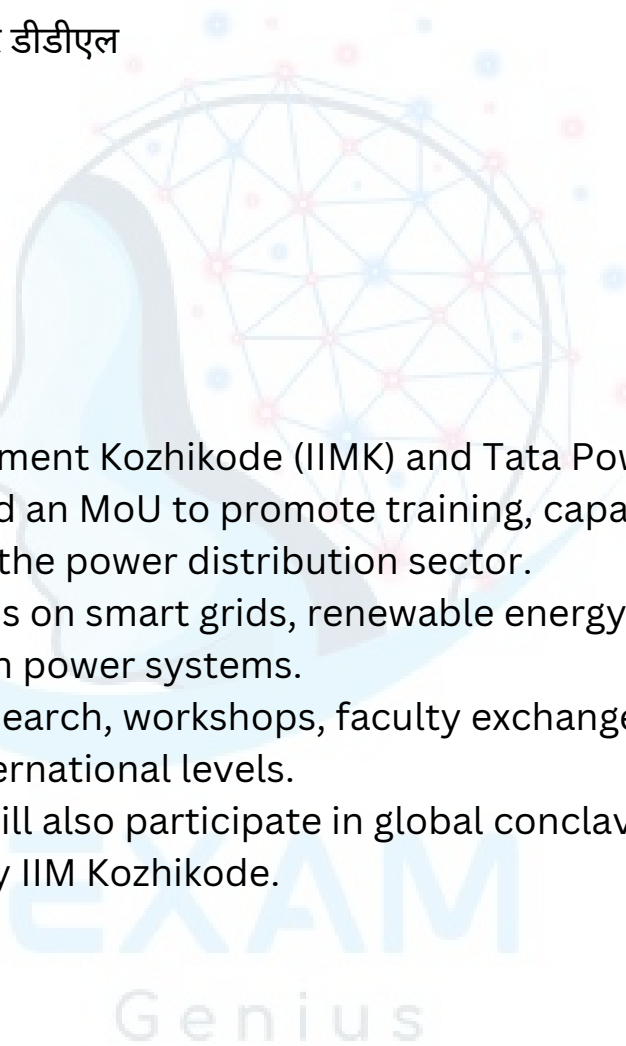

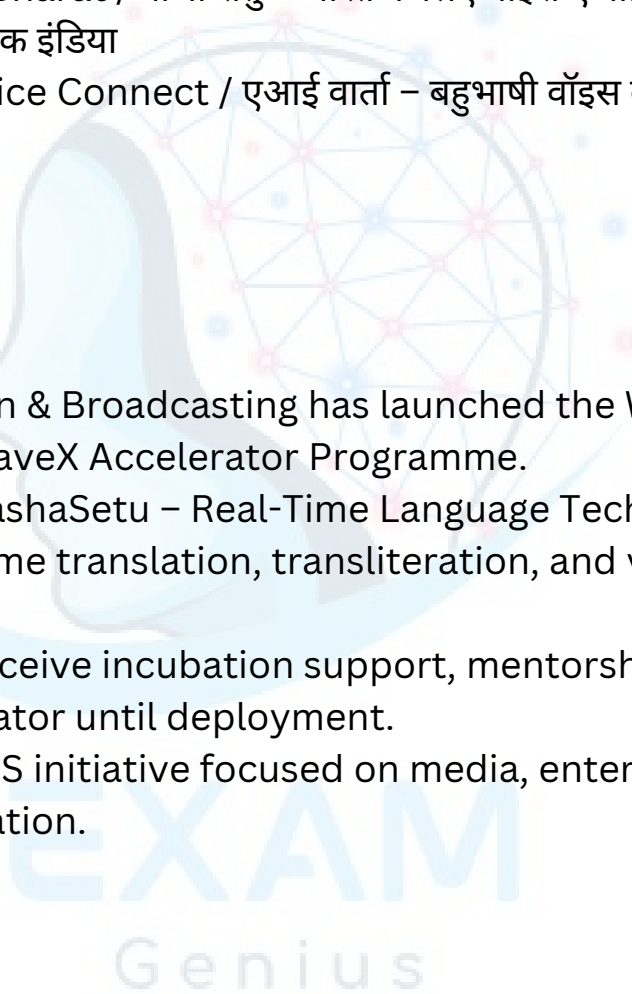

- Employers earn Rs.1,000 every month for each new employee, with an EPF wage of up to Rs.10,000.

- Employers will earn Rs. 3,000 for each employee, with incentives exceeding Rs. 20,000.
- Payments to First Time Employees under Part A of the Scheme will be made through DBT (Direct Benefit Transfer) via the Aadhar Bridge Payment System (ABPS). Payments to employers under Part B will be made straight into their PAN-linked accounts.

प्रेक्सिस ग्लोबल अलायंस की रिपोर्ट के अनुसार, भारत का गोल्ड लोन बाजार वित्त वर्ष 19 में 33 बिलियन अमरीकी डॉलर से बढ़कर वित्त वर्ष 24 में 83 बिलियन अमरीकी डॉलर हो गया है, जो 20% की सीएजीआर को दर्शाता है। दक्षिणी भारत इस क्षेत्र पर हावी है, जिसकी कुल बाजार हिस्सेदारी 79% है।

मानेसर में वीवीडीएन के ग्लोबल इनोवेशन पार्क में एरिक्सन की अत्याधुनिक एंटीना निर्माण सुविधा का शुभारंभ केंद्रीय संचार मंत्री और पूर्वोत्तर क्षेत्र विकास मंत्री (डोनर), श्री ज्योतिरादित्य एम. सिंधिया ने किया।

वित्तीय सेवा विभाग ने ग्राम पंचायत (जीपी) और शहरी स्थानीय निकाय (यूएलबी) स्तर पर वित्तीय समावेशन योजनाओं की संतृप्ति सुनिश्चित करने के लिए 3 महीने का अभियान (01.07.2025 से 30.09.2025) शुरू किया। इसका उद्देश्य विभिन्न गतिविधियों जैसे कि री-केवाईसी, पीएमजेडीवाई खाता खोलना, बीमा और पेंशन नामांकन आदि के माध्यम से पूरे भारत में 2.70 लाख जीपी और यूएलबी को कवर करना है।

2-9 जुलाई, 2025 तक, पीएम मोदी पाँच देशों की यात्रा करेंगे: घाना, त्रिनिदाद और टोबैगो, अर्जेंटीना, ब्राज़ील और नामीबिया। वे पहले चरण में दो दिनों के लिए घाना की यात्रा करेंगे, जो तीस से अधिक वर्षों में किसी भारतीय प्रधान मंत्री की पहली यात्रा है।
