- SEBI also cited lapses in supervising broker activities, such as unaudited client code modifications and lack of annual error-account audits.
- A time-gap mechanism to fix the access issue was introduced only after SEBI's intervention.
- SEBI has asked BSE to pay the penalty within 45 days.

- Moving forward, the insurer must mandatorily capture complete bank account details in proposal forms.

- This project will serve IT hubs, educational zones, and reduce traffic on roads like Paud Road and Nagar Road.
- Expected ridership is projected to grow from 0.96 lakh in 2027 to 3.49 lakh by 2057.
- It will be implemented by Maha-Metro (Maharashtra Metro Rail Corporation Ltd).

- He is part of a 4-member international crew including Peggy Whitson (USA), Slawosz Uznanski (Poland), and Tibor Kapu (Hungary).
- Shukla is conducting 25 experiments related to human physiology, agriculture, and material science.
- This marks India's return to human spaceflight after 41 years, since Rakesh Sharma's mission in 1984.
- The mission supports India's future goals under the Gaganyaan program and enhances private sector participation in global space research.

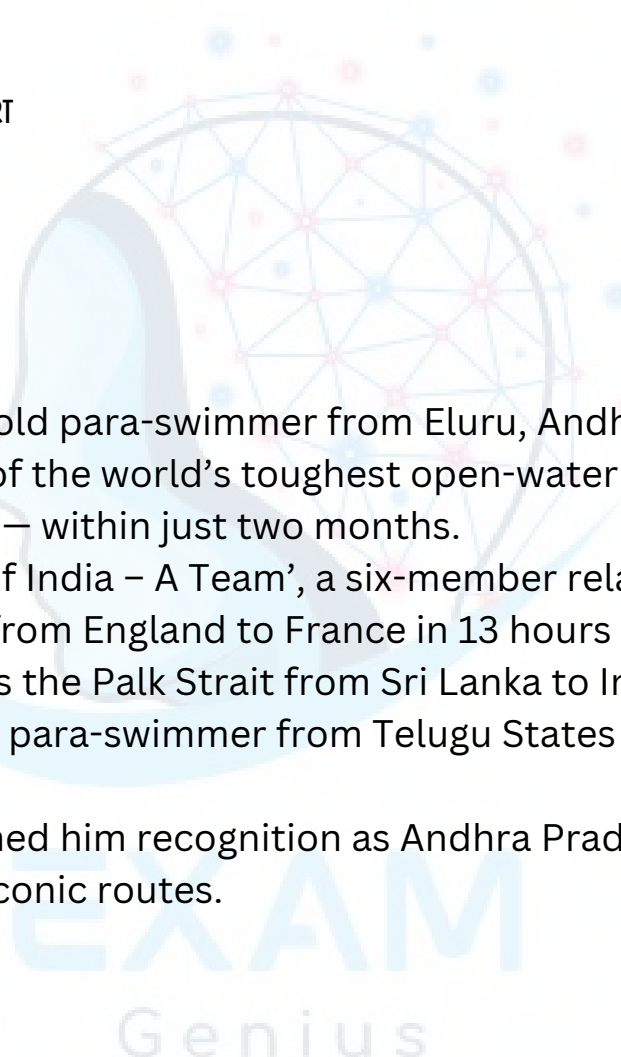

- Balaga Ganesh, a 38-year-old para-swimmer from Eluru, Andhra Pradesh, made history by completing two of the world's toughest open-water swims – the English Channel and the Palk Strait – within just two months.
- He was part of the 'Pride of India – A Team', a six-member relay group that crossed the 34 km English Channel from England to France in 13 hours and 37 minutes.
- He also swam 28 km across the Palk Strait from Sri Lanka to India in 10 hours and 30 minutes, becoming the first para-swimmer from Telugu States to accomplish this feat.
- This achievement has earned him recognition as Andhra Pradesh's first para-swimmer to conquer both iconic routes.

- Iceland retained its top spot as the most peaceful country, followed by Austria, New Zealand, and Switzerland.
- The report measures peace across three domains : Societal Safety and Security, Ongoing Domestic and International Conflict and Degree of Militarisation
- South Asia saw the largest deterioration in peace, especially in Bangladesh and Pakistan, while Afghanistan remains the least peaceful in the region.
- This year marks the 13th decline in global peace over the last 17 years.

- Major coffee-producing states in India are Karnataka, Kerala, and Tamil Nadu, with annual production around 3.6 lakh tonnes.

- However, tobacco taxation (‘R’ measure) is the least adopted MPOWER strategy in India.
- India leads globally by applying tobacco control regulations to digital streaming content, in addition to traditional media.

- Additionally, the minister announced Rs.5,400 crore in Viability Gap Funding (VGF) to support the development of 30 GWh battery storage systems, adding to the previously allocated Rs.3,700 crore.

**About Viability Gap Funding scheme :**

- Launched : 2004
- Contribution : 40% of the total project cost, amounting to Rs.3,760 crore, provided as VGF. Remaining 60% of project costs to be invested by participating companies.
- Total project outlay : Rs.9,400 crore
- Budgetary grant included in the initial outlay : Rs.3,700 crore
- Administered by : Department of Economic Affairs, Ministry of Finance
- Aims to develop 4,000 megawatt hours (MWh) of BESS by 2030-31.

- The Santhal Hul was a massive uprising against British colonial rule and exploitation by moneylenders and zamindars.
- Alongside Sidho and Kanhu, their sisters Phulo and Jhano also played key roles in mobilizing the Santhal community.
- Though the rebellion was suppressed, it influenced landmark legislations like the Santhal Parganas Tenancy Act (1876) and Chotanagpur Tenancy Act (1908) for protecting tribal land rights.
- The Santhal rebellion is regarded as a pivotal moment in India's tribal and anti-colonial resistance history.



## IMPORTANT ONE – LINER Current Affairs

The Union Cabinet, chaired by Prime Minister Shri Narendra Modi, has approved the Research Development and Innovation (RDI) Scheme with a corpus of Rs. One lakh Crore.

The Ministry of Power has announced the launch of a task force to conceive the India Energy Stack (IES), a pioneering initiative aimed at creating a unified, secure, and interoperable digital infrastructure for India's energy sector.

At a height of more than 18,510 feet (5,642 meters), Teghbir Singh of Ropar became the youngest person in history to climb Mount Elbrus, the highest peak in Europe and Russia.

India has imposed port entry restrictions on jute and allied products from Bangladesh, citing concerns over subsidized imports that harm the Indian jute sector.

Devendra Fadnavis, Chief Minister of Maharashtra, opened a 'Hedging Desk' in Pune as part of the Balasaheb Thackeray Agribusiness and Rural Transformation (SMART) Project. The goal is to secure fair market prices and higher revenue for farmers in the state.

CM Devendra Fadnavis has reversed the government resolutions (GRs) made on April 16 and June 17 regarding the controversial three-language policy, which included Hindi as the third language in primary schools.

18,510 फीट (5,642 मीटर) से अधिक की ऊँचाई पर, रोपड़ के तेगबीर सिंह यूरोप और रूस की सबसे ऊँची चोटी माउंट एल्ब्रस पर चढ़ने वाले इतिहास के सबसे कम उम्र के व्यक्ति बन गए।

मुख्यमंत्री देवेन्द्र फडणवीस ने विवादास्पद त्रि-भाषा नीति के संबंध में 16 अप्रैल और 17 जून को किए गए सरकारी प्रस्तावों (जीआर) को पलट दिया है, जिसमें प्राथमिक विद्यालयों में हिंदी को तीसरी भाषा के रूप में शामिल किया गया था।
