- Public sector banks contributed the bulk: Rs.58,330.26 crore (87% of total).
- State Bank of India (SBI) had the highest share, holding Rs.19,329.92 crore in unclaimed funds.
- Among private banks, ICICI Bank topped with Rs.2,063.45 crore, part of the Rs.8,673.72 crore from the sector.
- Accounts that are inactive for over 10 years are classified as unclaimed, and the RBI encourages banks to help claimants recover such deposits.





- The Securities and Exchange Board of India (SEBI) has introduced a compliance framework for Specialized Investment Funds (SIFs) to monitor and maintain a minimum investment threshold.
- As per the new rules, investors must maintain a minimum investment of Rs.10 lakh across all investment strategies of a SIF.
- If an investor's total holding falls below Rs.10 lakh due to sale, redemption, or transfer, it will be considered an "active breach."
- In such cases, all units held by the investor will be frozen for debit across all strategies.
- However, if the investor rebalances their investment and restores the minimum threshold within 30 calendar days, the units will be unfrozen.
- The move is aimed at ensuring minimum investor commitment and preventing misuse of the SIF platform.




- SEBI in collaboration with the National Stock Exchange (NSE), has launched Samuhik Prativedan Manch, a unified reporting platform
- SEBI renewed the recognition of Multi Commodity Exchange Clearing Corporation Limited (MCXCCL), a wholly owned subsidiary of the Multi Commodity Exchange of India (MCX) as a clearing corporation for a period of three years, from July 31, 2025, to July 30, 2028.

- This surge in digital transactions reflects India's progress toward a less-cash, more formal economy.








- The Power Ministry is implementing the Revamped Distribution Sector Scheme (RDSS) to install 25 crore smart meters across India
- The Bihar government, under Chief Minister Nitish Kumar, has revised the Journalist Samman Pension Scheme, increasing the monthly pension from Rs.6,000 to Rs.15,000 for eligible accredited journalists with a minimum of 20 years of experience
- The National Legal Services Authority (NALSA) launched 'Veer Parivar Sahayata Yojana', a scheme to strengthen legal aid for defence personnel and their families, during the North Zone Regional Conference held in Srinagar

- The second phase of the PM Internship Scheme (PMIS) will commence on August 1. The target for FY26 is 7 lakh interns, which is six times higher than the FY25 target


- The "Buddha Samyak Darshan Museum and Memorial Stupa" is located in Vaishaligarh, Vaishali district, Bihar.
- It is being inaugurated by Chief Minister Nitish Kumar and is expected to become a major spiritual and tourist attraction.
- Built over 72 acres with an investment of over Rs.550 crore, the structure is an architectural marvel.
- The stupa is made entirely of stone using tongue-and-groove techniques, with no cement, bricks, or concrete—a first in modern Indian history.
- It is almost twice as tall as the Sanchi Stupa and consists of 42,000 sandstone blocks.
- Designed to be earthquake-resistant, the complex also includes a meditation centre, library, museum, amphitheatre, cafeteria, solar plant, and more.
- A statue of Lord Buddha crafted by Odisha-based artists is also installed as a symbolic centerpiece.
- Buddhist monks from 15 countries including China, Japan, Sri Lanka, Thailand, Nepal, and Myanmar will attend the inauguration.

- These are state-of-the-art indigenous mobile hospital units, designed to respond to medical emergencies quickly and efficiently.
- BHISHM cubes are modular and portable, with medical supplies organized in 15inch boxes, based on injury type and medical need.
- Transport flexibility allows them to be carried by air, land, sea, or drone, with each cube weighing around 20 kg.
- A BHISHM cube = 2 Mother Cubes = 36 mini cubes x 2.
- One Mother Cube provides first-line care, shelter, and food for up to five people for 48 hours, while the second supports 10-15 surgeries per day.
- Each BHISHM Cube can support care for around 200 emergency cases, including trauma, burns, fractures, and shock, and is capable of generating its own power and oxygen for limited durations.
















