- In May 2022, the government sold 3.5% stake via an IPO, raising approximately Rs.21,000 crore.
- As per SEBI's minimum public shareholding norms, at least 10% of LIC shares must be held by the public by May 16, 2027.
- Therefore, the government needs to offload an additional 6.5% stake in LIC to meet this requirement.
- The Department of Investment and Public Asset Management (DIPAM) will decide the structure and timing of this disinvestment.



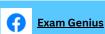

- This appointment strengthens SBI's leadership in cybersecurity and digital infrastructure protection.













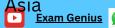






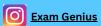

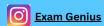
- PhonePe processed 8.45 billion UPI transactions in June 2025, worth Rs.11.99 lakh crore.

- Google Pay (GPay) was second with 6.54 billion transactions worth Rs.8.41 lakh crore, holding a 35.6% market share in volume.
- Combined, PhonePe and GPay handled 82.1% of total UPI volumes during this period.

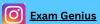

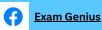
Answer: Option B

- Shriram Finance Limited violated provisions of the RBI (Digital Lending) Directions, 2025.
- The company routed loan repayments through a third-party account, instead of having borrowers directly repay to the company's account.
- This led to a Rs.2.70 lakh penalty under the RBI Act, 1934—specifically Section 58G(1)(b) read with 58B(5)(aa).
- In the exercise of its authority under Section 11(3) of the FEMA, 1999, the Reserve Bank of India fined HDFC Bank Ltd. Rs.4.88 lakh for breaking rules when issuing a term loan to a customer.









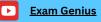




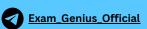
Recent Penalties imposed on Banks:

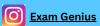
- SEBI imposed a Rs.25 lakh fine on BSE Ltd for regulatory violations between February 2021 and September 2022
- The Insurance Regulatory and Development Authority of India (IRDAI) imposed a fine of Rs.1 crore on Edelweiss Life Insurance for violating corporate governance norms
- The Reserve Bank of India (RBI) imposed a Rs.29.60 lakh penalty on Fino Payments Bank
- SEBI (Securities and Exchange Board of India) imposed a fine of Rs.25 lakh on MCX, India's largest commodity exchange
- RBI imposed a penalty of Rs.63.6 lakh on Union Bank of India for violating provisions of the Banking Regulation Act, 1949 and failing to comply with guidelines related to credit flow to agriculture, particularly in providing collateral-free agricultural loans
- The Insurance Regulatory and Development Authority of India (IRDAI) imposed a Rs.1 crore penalty on Acko General Insurance
- The Reserve Bank of India (RBI) imposed a Rs.50 lakh penalty on Deutsche Bank AG, India on May 13, 2025
- The Reserve Bank of India (RBI) imposed a penalty of Rs.29.60 lakh on Yes Bank Limited on May 16, 2025
- In May 2025, the Reserve Bank of India (RBI) penalised State Bank of India (SBI) and Jana Small Finance Bank for non-compliance with regulatory norms. SBI was fined Rs.1.72 crore for failing to comply with certain RBI directions
- Jana Small Finance Bank was fined Rs.1 crore for contravening provisions of the Banking Regulation Act, 1949
- RBI imposed a monetary penalty of Rs.31.80 lakh on IDBI Bank Limited on April 30, 2025, for non-compliance with regulatory directions
- RBI imposed a monetary penalty of Rs.61.40 lakh on Bank of Baroda on April 29, 2025, for non-compliance with directions related to financial services, customer service, and deposit interest rates
- RBI imposed a monetary penalty of Rs.31.80 lakh on Bank of Maharashtra on April 30, 2025, for non-compliance with regulatory KYC norms
- RBI imposed a monetary penalty of Rs.97.80 lakh on ICICI Bank Ltd. on April 29, 2025, for non-compliance with regulatory directions

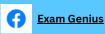

- Canara Bank informed the Bombay High Court that it has unconditionally withdrawn its earlier decision classifying Reliance Communications' (RComm) loan account as "fraudulent".
- The fraud tag was issued in November 2024, citing alleged fund diversion to group entities.
- The decision to withdraw the tag came after Anil Ambani, former director of RComm, challenged the classification, leading to a court stay in February 2025.
- As per Supreme Court and RBI guidelines, no loan account can be declared fraud without giving the borrower a personal hearing.
- The lender consortium to RComm includes Canara Bank, SBI, and Union Bank. While Canara Bank has withdrawn the tag, SBI may proceed to classify the account as fraud, which Anil Ambani is expected to challenge next.

- Maharashtra has become the fifth state to enact such a law, following Andhra Pradesh, Telangana, Odisha, and Jharkhand.



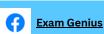

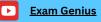




Recent records in Cricket:

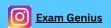
- Rishabh Pant: created history at Headingley in the first Test against England by becoming only the second wicketkeeper in Test cricket history to score centuries in both innings of a match
- Jasprit Bumrah: became the first Asian bowler to claim 150 Test wickets in SENA countries (South Africa, England, New Zealand, and Australia).
- Jos Buttler: surpassed Ireland's Paul Stirling to become the fourth-highest runscorer in T20 Internationals, with 3678 runs
- Virat Kohli: playing for Royal Challengers Bengaluru (RCB), became the first cricketer to score 9000 T20 runs for a single franchise
- Joe Root: fastest cricketer to reach 13,000 Test runs in terms of matches played during a four-day Test against Zimbabwe at Trent Bridge, Nottingham
- Rohit Sharma: After Virat Kohli, he was the only other Indian hitter to reach the milestone of 12,000 T20 runs
- Virat Kohli: 100th T20 half-century while playing for Royal Challengers Bengaluru against Rajasthan Royals at the Sawai Mansingh Stadium
- M.S. Dhoni: first player in IPL history to record 200 fielding dismissals
- Virat Kohli: highest run-scorer in Indian Premier League (IPL) history and the only player to cross the 8000-run mark and also became the first player to hit 1000 boundaries in IPL
- Virat Kohli: first Indian and fifth cricketer overall to reach 13,000 runs in T20 cricket
- Virat Kohli and Rohit Sharma: Break Yuvraj Singh's Record for Most ICC Final
- Virat Kohli: He played his 300th One Day International (ODI) match against New Zealand in Dubai
- Virat Kohli: fastest hitter to achieve 14,000 runs in one-day internationals
- Rohit Sharma: second fastest batter after compatriot Virat Kohli to complete 11,000 runs in One-day Internationals

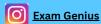


















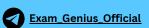

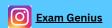
- The Assam Cabinet approved the Assam Goods and Services Tax (Reimbursement for Indigenous Bell Metal Industries) Scheme, 2025. The bell metal workers of Sarthebari will pay the GST, and their SGST amount will be reimbursed to them

- A NITI Aayog working group has been set up to study Jhum cultivation in detail.
- Arunachal Pradesh has already seen a decline in Jhum cultivation area, from 3,088 sq km in 2000 to 1,551 sq km in 2010.
- Experts believe the transition from Jhum to settled farming will take time due to economic and environmental challenges.
