

- NABARD provides financial support for conducting financial and digital literacy camps through rural bank branches and Financial Literacy Centres (FLCs) in lowawareness areas.
- The Centre for Financial Literacy (CFL) Project, initiated by the RBI in 2017, aims to adopt community-led, innovative, and participatory approaches to financial literacy.
- As of March 31, 2025, there are 2,421 CFLs across the country, with one CFL covering three blocks on average.



- RBI has expanded the Partial Credit Enhancement (PCE) facility to improve the creditworthiness of bonds and provide partial protection to investors against default risk.
- From April 1, 2026, or earlier as per lenders' internal policies, the maximum PCE limit will be raised from 20% to 50% of the total bond issue size.
- The 50% cap applies across commercial banks, co-operative banks, NBFCs, and development financial institutions.
- This facility will be available only for bonds with an initial rating lower than 'BBB-'.








- The RBI has granted 'in-principle' approval for the transition.

Eligibility criteria for an SFB to transition into a Universal Bank include:

- Scheduled status with satisfactory performance for at least 5 years.
- Shares listed on a recognised stock exchange.
- Minimum net worth of Rs.1,000 crore at the end of the previous audited quarter.
- Prescribed CRAR compliance, net profit in the last two financial years,
- GNPA \leq 3% and NNPA \leq 1% in the last two years.

For shareholding, no mandatory promoter requirement exists, but existing promoters (if any) will continue after transition. Diversified loan portfolio SFBs will be preferred.


- RBI's internal working group on liquidity management recommended retaining the overnight Weighted Average Call Rate (WACR) as the main policy operating target.
- Suggested phasing out 14-day Variable Rate Repo (VRR) and Variable Rate Reverse Repo (VRRR) auctions as the main liquidity tool.
- Short-term liquidity to be managed mainly through 7-day repo/reverse repo operations and other tenors (overnight to 14 days), based on RBI's liquidity assessment.
- Recommended keeping the daily minimum Cash Reserve Ratio (CRR) requirement at 90%, rejecting banks' request to reduce it to 85%.
- WACR was found effective in aligning rates across collateralised segments and in transmitting policy signals to the broader market.







- The Reserve Bank of India reduced its CPI inflation forecast for FY26 from 3.7% to 3.1% in its latest monetary policy review.
- The downward revision is attributed to large favourable base effects, steady monsoon progress, healthy kharif sowing, adequate reservoir levels, and sufficient food grain buffer stocks.
- RBI Governor Sanjay Malhotra said that while the inflation outlook is more benign, risks still exist due to weather uncertainties, unfavourable base effects, and global financial market volatility.
- GDP growth for FY26 is retained at 6.5%, supported by private consumption, public investment, and steady monsoon-driven agricultural output.



- Financial assistance provided includes Rs.1.50 lakh for expenses in registering the designs/products. Rs.1.50 lakh for training personnel of Implementing Agencies (IA) and effective enforcement of GI registration.
- As of now, 106 handloom products, 6 product logos, and 227 handicraft products have been registered under the GI Act, 1999.
- Exhibitions and events like "GI & Beyond Virasat se Vikas Tak" are organized to promote GI-tagged products and showcase their cultural and historical significance.
- The Silk Samagra-2 scheme supports GI-tagged silk products through the Central Silk Board.
- Registered GI users have legal rights to protect against unauthorized use.
- Additional Rs.1.50 lakh assistance is available for enforcement and legal protection.



- Indian Navy: Approval for Compact Autonomous Surface Craft, BrahMos Fire Control System and launchers, and upgradation of BARAK-1 Point Defence Missile System for anti-submarine warfare missions.
- Indian Army: Acceptance of Necessity for Thermal Imager-based Driver Night Sight for BMP/infantry vehicles to improve night mobility and operational advantage.
- Indian Air Force: Approval for mountain radars, upgradation of SAKSHAM/SPYDER Weapon System, and integration with the Integrated Air Command and Control System.
- Tri-services: Procurement of Medium Altitude Long Endurance (MALE) Remotely Piloted Aircraft capable of multiple payloads, long endurance, and round-the-clock surveillance.


- The Government of India launched the first phase of four development projects under the India-United Nations Global Capacity Building Initiative to achieve Sustainable Development Goals for nine partner countries.
- This is a joint initiative of the GoI and the United Nations to support Asia, Africa, and Caribbean countries through South-South cooperation, sharing India's successful development models.
- The initiative was announced in September 2023 during the 78th UN General Assembly as part of India's G20 Presidency legacy by External Affairs Minister Dr. S. Jaishankar.
- Training will be provided via the Indian Technical and Economic Cooperation (ITEC) programme in collaboration with UN agencies.
- The ITEC programme offers 12,000 training slots with 400 specialised courses to nearly 160 countries worldwide.

- The building will house the Ministries/Departments of Home Affairs, External Affairs, Rural Development, MSME, DoPT, Petroleum and Natural Gas, and the Principal Scientific Adviser.
- It replaces the need for several ministries to function from ageing buildings like Shastri Bhawan, Krishi Bhawan, Udyog Bhawan, and Nirman Bhawan, which were constructed between the 1950s and 1970s.








- Appointed as Bihar Governor in October 2017, he was transferred to J&K just over a year later.
- In October 2019, he was moved to Goa, and nine months later to Meghalaya, where he retired on October 4, 2022.







- Hiroshima Day is observed every year on 6 August to mark the anniversary of the atomic bombing of Hiroshima, Japan, by the United States during World War II in 1945.
- On August 6, 1945, the US dropped an atomic bomb called "Little Boy" on Hiroshima using the B-29 bomber Enola Gay.
- On August 9, 1945, a second bomb "Fat Man" was dropped on Nagasaki, leading to Japan's surrender and the end of World War II.
- The bombs were developed under the Manhattan Project launched in December 1941, led by J. Robert Oppenheimer.
- The incident led to the creation of various nuclear control treaties such as the CTBT, Nuclear Non-Proliferation Treaty, Limited Test Ban Treaty, and the Nuclear Suppliers Group.
