
- The SBI Economic Research Department (ERD) report on Unified Payments Interface (UPI) transactions shows a significant increase in UPI adoption.
- Average daily transaction value rose from ₹75,743 crore in January 2025 to ₹90,446 crore in August 2025.
- Average daily transaction volume increased by 127 million, reaching 675 million in August 2025.
- Top 5 states by UPI usage (volume %): Maharashtra (9.8%), Karnataka (5.5%), Uttar Pradesh (5.3%), Telangana (4.1%), Tamil Nadu (4%).
- Top 5 states by transaction value: Maharashtra (9.2%), Karnataka (5.8%), Uttar Pradesh (5.3%), Telangana (5.1%), Tamil Nadu (4.7%).
- Top remitter bank: SBI (handling 5.2 billion transactions).
- Top beneficiary bank: Yes Bank Limited, with nearly 8 billion transactions.
- The report highlights the structural shift from cash and debit cards to UPI, with UPI's share in transaction value increasing from 40% in Nov 2019 to 91% in May 2025.

- The State Bank of India's Economic Research Department (ERD) released state-wise UPI transaction data for the first time. Maharashtra emerged as the leader with 9.8% share in July.
- A unique personal loan program designed especially for Agniveers has been introduced by SBI. Agniveers with an SBI salary account are eligible for loans up to ₹4 lakh under the scheme
- The State Bank of India (SBI), India's largest lender, has revised its IMPS (Immediate Payment Service) charges effective from August 15
- State Bank of India (SBI), the country's largest lender, plans to raise up to ₹15,000 crore in FY26 through Tier-II bonds
- As per Rajya Sabha data, SBI disbursed ₹32,311 crore in education loans between FY 2022-23 and 2024-25, making it the top lender in this category. Union Bank of India ranked second with ₹14,559 crore sanctioned in the same period

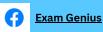
- Real Madrid has been crowned the world's most valuable football club in the Brand Finance Football 50–2025 report

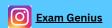

- Rubella (German measles) is a contagious viral disease spread through respiratory droplets when an infected person coughs or sneezes.
- It is especially dangerous during pregnancy, as it may cause miscarriage, stillbirth, or congenital rubella syndrome (CRS) in infants.
- Symptoms: Mild fever, rashes (starting on the face and spreading), swollen lymph nodes, joint pain, conjunctivitis, and general malaise. Many infections remain asymptomatic.
- Treatment: No specific antiviral treatment exists.
- Prevention: Through immunisation with the MMR vaccine (Measles, Mumps, Rubella).











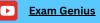

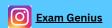

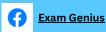

- Earlier FTA talks started in 2020 but were stalled due to the Covid-19 pandemic.

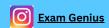

- The exercise involves computer-simulated command post operations as well as field training, enhancing coordination and readiness between the two nations' armed forces.

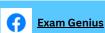


- The 12th edition of Sri Lanka-India Naval Exercise (SLINEX-25) was held from 14-18 August 2025 in Colombo, Sri Lanka
- The 21st edition of Yudh Abhyas (a joint military exercise between India and the U.S.) will be held in Alaska this month
- •The Indian Navy and the Hellenic (Greek) Navy held a joint PASSEX(passing exercise) near the Mumbai coast in the Arabian Sea. The Western Naval Command deployed INS Tarkash to conduct a PASSEX exercise with the passing Hellenic Navy Ship HS Psara.
- •Exercise Divya Drishti is a high-altitude technology demonstration conducted by the Indian Army in East Sikkim. It aimed to test advanced technologies that enhance battlefield awareness, real-time surveillance, and swift decision-making
- •The Indian Navy and the Republic of Singapore Navy (RSN) jointly organize the Singapore India Maritime Bilateral Exercise (SIMBEX), which is one of India's longest continuous maritime exercises
- •Talisman Sabre 2025 is the 11th edition of a major bilateral military exercise led by Australia, started on July 13, 2025. It is the largest bilateral military drill between Australia and the United States, held biennially since 2005
- •The Indian Army conducted a military exercise titled 'Prachand Shakti' in Meerut. It was organised by the Charging RAM Division at the Kharga Corps Field Training Area
- •The Japan Coast Guard Ship Itsukushima arrived at Chennai Port as part of a Global Ocean Voyage Training. The port call will culminate in a joint sea exercise named 'Jaa Mata' (meaning See you later) on July 12, 2025
- •ConvEx-3 (2025) is a full-scale international emergency preparedness exercise focused on nuclear or radiological emergencies with potential cross-border impacts
- •The 53rd edition of NATO's premier multinational maritime-focused exercise, BALTOPS 25, was launched in Latvia
- •Tiger Claw is the first-ever joint exercise between the Special Forces of the Indian Air Force (Garud) and the United States Air Force Special Forces
- •The 8th edition of Exercise Shakti 2025, a biennial bilateral military exercise between India and France, will be held at La Cavalerie, France, from June 18 to July 1, 2025
- •The India-U.K. joint naval Passage Exercise (PASSEX) took place in the North Arabian Sea on June 9–10, 2025. The Indian Navy was represented by INS Tabar (a stealth frigate), a submarine, and a P-81 maritime patrol aircraft

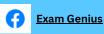

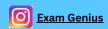




- The label will carry a QR code and logo providing details such as manufacturing location, validity of the label, and product-specific information.
- The scheme is being led by DPIIT (Department for Promotion of Industry and Internal Trade) with advisory support from Quality Council of India (QCI) and India Brand Equity Foundation (IBEF).
- Government has allocated ₹995 crores for 3 years, after which the scheme is expected to become self-sustaining.
- Eligibility: At least 50% value addition in India, wholly or substantially manufactured/assembled domestically, meeting industry-specific quality standards.


- "One Freezone Passport," a new program launched by Dubai (United Arab Emirates (UAE)), enables businesses licensed in one free zone to expand operations into other free zones within the emirate without needing a second license.
- The Shakti Scheme was implemented by the Karnataka Government on June 11, 2023. It provides free bus travel for women across all state-run transport corporations
- West Bengal CM Mamata Banerjee launched the Shramshree Scheme for migrant workers returning to Bengal after facing harassment in other states
- The SASCI scheme (Special Assistance to States for Capital Expenditure and Investment) was launched in FY21 with an initial allocation of ₹12,000 crore (COVID pandemic support)

- The National Means-cum-Merit Scholarship Scheme (NMMSS) is a Central Sector merit-based scholarship scheme launched by the Department of School Education and Literacy, Ministry of Education

Anti-Conversion Bill, 2025: Increased punishment for forced conversions → from 10 years to life imprisonment in extreme cases.

Minority Education Bill, 2025:

- Made it mandatory for minority educational institutions (incl. madrasas) to seek affiliation with Uttarakhand Education Board by July 2026.
- Institutions must reapply for minority status recognition.

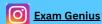





- Agni-5 has a strike range of up to 5,000 km (≈ 3,100 miles), making it capable of covering the entire Asia and parts of Europe, including China and Turkey.
- The missile can reach a maximum speed of Mach 24 (≈ 29,400 km/h) and has a reentry speed of Mach 20-24, making interception nearly impossible.
- First tested in 2012 by DRDO, after several developmental trials it was handed over to Strategic Forces Command, which conducted the first user trial in 2021.
- The nuclear-capable missile is 17.5 meters long, weighs 50 tons, and is a three-stage rocket with advanced indigenous technologies.



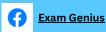



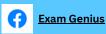
