Ques: Recently, RBI announced premature redemption of 28 SGBs. What is the fixed repurchase price set by RBI?

- RBI has announced premature redemption for 28 Sovereign Gold Bonds (SGBs) issued between May 2018 and March 2021.
- The repurchase price for these SGBs is fixed at ₹10,070 per unit.
- SGB investors receive 2.5% annual interest (paid semi-annually) in addition to capital gains linked to gold prices.
- The redemption price is based on the average closing price of 999 purity gold published by the India Bullion and Jewellers Association (IBJA) for the preceding three working days.
- Earlier, from April 2024, RBI had already opened early redemption for 34 SGBs issued between October 2017 – September 2020.

Recent News Headlines Related to RBI

- According to RBI & NABARD, India has 1,457 Urban Cooperative Banks (UCBs). Maharashtra (458) has the highest number, followed by Karnataka (250) and Gujarat (211).
- RBI survey revealed that foreign liabilities of India's mutual fund (MF) industry rose 19.9% in FY25, reaching \$30.5 billion
- RBI's Master Circular on Customer Service in Banks requires all customer-facing materials at branches of Scheduled Commercial Banks to be available in Hindi, English, and the concerned regional language
- RBI had set up a committee under Pushpak Bhattacharya to prepare a framework for Responsible and Ethical Enablement of Artificial Intelligence (FREE-AI).
- RBI will implement a new cheque clearance mechanism from October 4, 2025, reducing the settlement cycle from the current T+1 days (up to 2 working days) to just a few hours
- RBI granted Equirus Group a non-deposit taking NBFC license, enabling the launch of Equirus Finance.
- RBI has proposed that banks must settle deposit account claims of deceased customers within 15 calendar days from receipt of all required documents
- RBI released a draft circular proposing easier claim settlement after the death of an account holder, covering deposit accounts, lockers, and articles in safe custody.
- RBI introduced Systematic Investment Plan (SIP) for Treasury Bills and Auto-Bidding facility on its Retail Direct platform. SIP allows small, periodic investments in T-Bills instead of lump sums.
- RBI's final co-lending norms mandate that each entity in a Co-Lending Agreement (CLA) must retain at least 10% of individual loans in its own books
- AU Small Finance Bank applied to the RBI for voluntary transition from a Small Finance Bank to a Universal Bank. The RBI has granted 'in-principle' approval for the transition
- RBI's SA-CHET portal recorded 3,454 complaints between April 2020 and March 2025 regarding non-repayment of money collected through various investment schemes. Of these, 1,531 complaints were related to MLM (Multi-Level Marketing), direct selling, and Ponzi schemes, based on complainants' category selection

- This fund is the eighth fund launched by Aavishkaar Capital, and it was established in collaboration with the German Development Bank (KfW).
- Japan International Cooperation Agency (JICA): Established in 2003, headquartered in Tokyo, Japan, with Akihiko Tanaka as its President.

- India Exim Bank signed a \$40 million commercial credit line agreement with ECOWAS Bank for Investment and Development (EBID)
- Bharat Earth Movers Limited secured its first overseas rail and metro contract worth USD 1 million from Malaysia for retrofitting and reconditioning its Mass Rapid Transit system.
- The International Finance Corporation (IFC) will invest \$150 million (about Rs.1,300 crore) as an anchor equity investment in the H-DREAM Fund (HDFC Capital Development of Real Estate Affordable and Mid-Income Fund).

- The Union Cabinet has approved the continuation of the universal supply of fortified rice under all government schemes until December 2028.
- The scheme aims to combat micronutrient deficiencies, particularly iron, folic acid, and vitamin B12, addressing anaemia and malnutrition among vulnerable populations.
- The pilot phase began in 2019 across 15 states, and by March 2024, fortified rice distribution was extended nationwide across schemes such as the Public Distribution System (PDS), Integrated Child Development Services (ICDS), and PM POSHAN.
- The scheme is 100% centrally funded at ₹17,082 crore under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY).
- The Department of Food and Public Distribution (DFPD) under the Ministry of Consumer Affairs, Food and Public Distribution is the nodal agency, and technical standards are framed by the Food Safety and Standards Authority of India (FSSAI).

- ISRO is developing a Next Generation Launch Vehicle (NGLV) that can carry 75,000 kg payload into Low Earth Orbit (LEO)
- ISRO will launch a 6,500 kg communication satellite built in the United States in the coming months.
- The Human Outer Planet Exploration (HOPE) station is an analogue site developed by Bengaluru-based space tech company Protoplanet in collaboration with the Indian Space Research Organisation (ISRO)
- The Indian Space Research Organisation (ISRO) will launch three more navigation satellites – NVS-03, NVS-04, and NVS-05 – by 2026 to enhance IRNSS, also known as NavIC (Navigation with Indian Constellation).
- NISAR (NASA-ISRO Synthetic Aperture Radar) is the first joint satellite developed by NASA and ISRO

- This system is crucial to safely decelerate and recover the crew module during re-entry.
- The upcoming uncrewed Gaganyaan mission (G1) in December will carry the half-humanoid robot Vyommitra to test human spaceflight systems ahead of crewed missions.
- Vyommitra is a female robot designed to accompany astronauts, simulating human responses during unmanned test flights.

- For the first time in South-Central Railway (SCR) history, five key departments – Operations, Commercial, Finance, Security, and Medical – are being led by women officers

- Training was delivered through local bodies, highlighting Kerala's decentralized governance and participatory approach.

 - Chip Design infrastructure support: Under this, C-DAC will set up the India Chip Centre
 - Product Design Linked Incentive.
 - Deployment Linked Incentive.



- Product Design Incentive : Reimbursement of up to 50% of eligible costs, capped at ₹15 crore per application
- Deployment Linked Incentive : Incentive of 4%-6% on net sales turnover over five years, capped at ₹30 crore per application

India has imposed anti-dumping duty on certain hot-rolled flat steel products imported from Vietnam. Earlier in April, India applied a 12% safeguard duty on some steel imports, mainly from China, to curb cheap shipments.
