- The Union Finance Ministry has introduced a one-time, one-way switch facility allowing central government employees to move from the Unified Pension Scheme (UPS) to the National Pension System (NPS).
- Employees can switch anytime, but not later than one year before superannuation or three months before voluntary retirement.
- Employees facing disciplinary action, dismissal, or removal are not eligible.
- Once switched to NPS, employees will no longer receive assured UPS payouts, but the government's 4% differential contribution will be added to their individual NPS corpus.
- The last date to enroll in UPS is 30 September 2025.

# **About Unified Pension Scheme (UPS):**


- Upgraded from: Existing NPS, which was introduced on 1st January, 2004 by Atal Bihari Vajpayee government
- Contribution: The central government employees will be required to contribute 10% of their basic salary and Dearness Allowance (DA). The central government has increased its contribution from 14% (currently under NPS) to 18.5%.
- Adoption: Maharashtra was the 1st state, which has implemented UPS for its government employees with effective from March 2024

- The urban survey will cover 19 cities, including Ahmedabad, Bengaluru, Bhopal, Bhubaneswar, Chandigarh, Chennai, Delhi, Guwahati, Hyderabad, Jaipur, Jammu, Kolkata, Lucknow, Mumbai, Nagpur, Patna, Raipur, Ranchi, and Thiruvananthapuram.
- The survey captures urban households' views on the general economic situation, employment scenario, price levels, and their own income and spending behaviour.
- The rural survey will cover 31 states and union territories.








- The aircraft can fly up to 30 hours with an operational range of 3,000 kilometres.







- Accounts grew from 14.72 crore (2015) to 56.16 crore (2025).
- PMJDY provides small accounts for those without legal documents, a free RuPay debit card with ₹2 lakh accident insurance, and overdraft facility up to ₹10,000.
- Accounts are linked to schemes like DBT, PMJJBY, PMSBY, APY, and MUDRA.
- Guinness World Record: Most bank accounts opened in one week = 18,096,130.


- From 27th August 2025, most Indian goods entering the US will attract a 50% tariff.
- The 50% tariff includes the 25% tariff announced in late July and an additional 25% "penalty" tariff announced in early August, targeting India's purchases of Russian oil and defence imports from Moscow.
- Trade experts estimate that India's merchandise exports to the US could drop by 40-45% in 2025-26 compared to the previous year.
- About 30% of exports (valued at \$27.6 billion in FY25) such as pharmaceuticals, electronics, and petroleum products remain duty-free.
- 4% of exports, mainly auto parts, face a 25% tariff.
- Competitors like Vietnam, Bangladesh, Cambodia, China, and Pakistan could benefit from India's potential export losses.
- The US accounts for 20% of India's merchandise exports and 2% of GDP.
- Specific sectors impacted include marine exports (48% revenue from US), home textiles (60% exports to US), and carpets (50% exports to US).


- India's Akums Drugs and Pharmaceuticals Limited signed a framework agreement with the Government of Zambia (GRZ) to establish a pharmaceutical manufacturing facility and supply medicines for Zambia's national health programs.
- Akums will hold a 51% stake in the new joint venture company, while the Zambian state will hold the remaining 49% stake.
- The facility will manufacture general oral solids, liquids, injectables, and betalactam products.
- GRZ will procure medicines worth at least USD 50 million (₹425 crore) over 2026-27, supplied from Akums' facilities in India.
- Once established, the plant will also export medicines to neighboring African countries like Zimbabwe, Namibia, Botswana, Malawi, Tanzania, and Mozambique.



- Earlier in January 2025, Pixxel had launched 3 Firefly satellites. With all 6 Fireflies in orbit, Earth becomes a "living laboratory" for continuous planetary observation.





- Aim: To stabilize input costs across the textile value chain (yarn, fabric, garments, made-ups) and support global competitiveness while safeguarding domestic cotton farmers.
- India's textile-apparel sector employs over 45 million people, making it the secondlargest employment provider in the country.
- Farmers' interests are protected through the Minimum Support Price (MSP) by Cotton Corporation of India (CCI), ensuring at least 50% above the cost of production.
- Cotton textile exports accounted for 33% of total textile & apparel exports (USD) 7.08 billion) during April-October 2024-25.

- This fine ensures compliance with SEBI norms to strengthen corporate governance in listed companies.



- Overall, six in ten women surveyed felt safe in their city, while 40% considered themselves "not so safe" or "unsafe", with the highest risk group being women under 24 years.



- Developed by Indian institutions including IITM-Pune, NCMRWF-Noida, and IMD, and supported by supercomputing facilities Arka and Arunika, it enables real-time, high-resolution weather prediction.
- The system aims to provide forecasts at the cluster of panchayats level and improve the prediction of extreme weather events.





