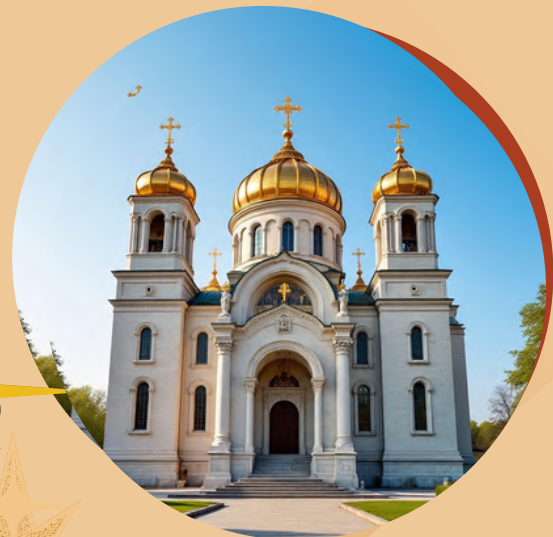

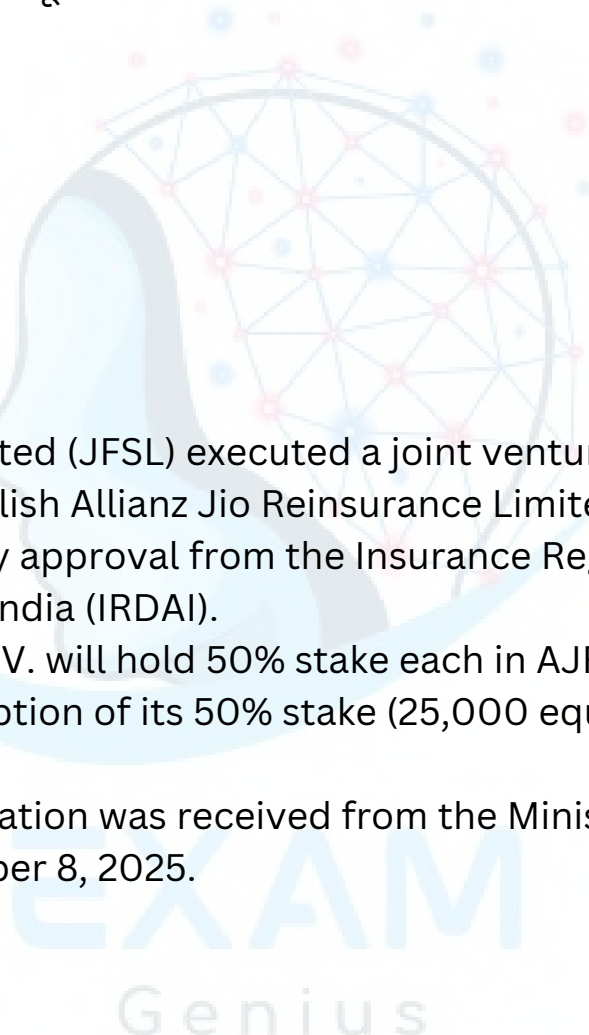

- JFSL and Allianz Europe B.V. will hold 50% stake each in AJRL. JFSL has invested Rs.2.50 lakhs in the subscription of its 50% stake (25,000 equity shares) at a price of Rs.10 per share.
- The Certificate of Incorporation was received from the Ministry of Corporate Affairs (MCA) via email on September 8, 2025.

- Kotak Securities, Jefferies, and Nomura are acting as joint placement agents for this deal.
- This marks SMBC's complete exit from Kotak Mahindra Bank, realizing a significant profit on its 15-year-old investment.

- It has the capacity to store 74 billion cubic meters of water and generate 5,150 MW of electricity, making it the most powerful dam on the continent.
- Ethiopian PM Abiy Ahmed described it as a "historic achievement for all black people."
- Egypt protested at the United Nations, claiming that the GERD poses an "existential threat" to its water security, as 97% of Egypt's water comes from the Nile River.

- The revised MRP can be displayed using stickers, stamping, or online printing, but the original MRP must remain visible.
- Companies are required to issue a public notice in newspapers and inform legal metrology authorities about the changes.
- The price revision should only reflect the actual tax change due to GST, without any additional price hike.
- Old packaging material with previous MRP can still be used till December 31, provided that the corrected price is displayed clearly.
- This move will reduce packaging waste, give operational flexibility, and help industries manage large inventories smoothly.

Amnesty Scheme-2025:

- Effective from 1st October 2025 to 30th September 2026.
- A one-time dispute resolution scheme to settle issues related to damages, interest, and coverage under the ESI Act.
- Aims to reduce lawsuits, strengthen compliance, and ensure smooth delivery of social security benefits to employees.

- On September 9, 2025, the Rajasthan Assembly passed the Rajasthan Prohibition of Unlawful Religious Conversion Bill, 2025 to curb forced or fraudulent religious conversions.
- The bill provides life imprisonment, fines up to ₹1 crore, and confiscation and demolition of properties where mass conversions take place.
- Exemption: Returning to ancestral religion is not covered under this law.
- Additional measures: Mandatory prior notice for voluntary conversions, annulment of marriages done solely for conversion, and property confiscation.
- All offenses are cognizable and non-bailable, triable by a sessions court.

Key penalties under the bill:

- Forced/fraudulent conversion: 7–14 years imprisonment + fine up to ₹5 lakh.
- Conversion of minors, women, SC/ST, or PwD by fraud: 10–20 years imprisonment + fine ≥ ₹10 lakh.
- Mass conversions through fraud: 20 years–life imprisonment + fine between ₹25 lakh–₹1 crore.
- Using foreign/illegal funds for conversions: 10–20 years imprisonment + fine ≥ ₹20 lakh.

- The move will strengthen India's position as a reliable supplier of high-quality seafood, particularly aquaculture shrimps and cephalopods like squid, cuttlefish, and octopus.
- It is expected to boost export volumes, create employment, diversify coastal exporters' products, and increase foreign exchange earnings.
- This development followed discussions between Indian officials, including Union Commerce Minister Piyush Goyal, and EU counterparts, which helped build trust in India's regulatory systems.

- Schedule 8 of the Constitution lists 22 languages, including Hindi.
- The first Hindi Diwas was celebrated in 1953, while World Hindi Day is observed on 10 January.
