Recent Penalties imposed on Banks:

- Reserve Bank of India (RBI) imposed a penalty of ₹39.60 lakh on Tamilnad Mercantile Bank Limited.
- The Central Consumer Protection Authority (CCPA) imposed a penalty of ₹8,00,000 each on Dikshant IAS and Abhimanu IAS for misleading advertisements, unfair trade practices, and violation of consumer rights under the Consumer Protection Act, 2019.
- The Insurance Regulatory and Development Authority of India (IRDAI) imposed a ₹1 crore penalty on Liberty General Insurance for violations related to outsourcing, commission payments, and remuneration to intermediaries.
- The Reserve Bank of India (RBI) imposed a monetary penalty of ₹31.80 lakh on American Express Banking Corp. for non-compliance with its Credit Card and Debit Card - Issuance and Conduct Directions, 2022.
- The Reserve Bank of India (RBI), exercising powers under Section 58G(1)(b) read with Section 58B(5)(aa) of the RBI Act, 1934, imposed a monetary penalty of ₹4.20 lakh on HDB Financial Services Ltd for non-compliance with certain provisions of the KYC Directions, 2016.
- The Reserve Bank of India (RBI) has cancelled the banking licence of Jijamata Sahakari Bank, an Urban Cooperative Bank (UCB) based in Satara, Maharashtra.
- The Reserve Bank of India (RBI) imposed a monetary penalty of ₹2.7 lakh on Muthoot FinCorp Limited for non-compliance with Internal Ombudsman guidelines.
- The CCPA imposed a penalty of ₹2,00,000 on M/s Digital Age Retail Pvt. Ltd. (FirstCry) for misleading price representations.
- RBI imposed a ₹21 lakh monetary penalty on PhonePe Limited (formerly PhonePe Private Limited).





- IDBI Bank filed a fresh insolvency plea in NCLT against Zee Entertainment Enterprises Ltd (ZEEL) alleging default of ₹225.23 crore.
- Coal India Ltd was fined a total of ₹10.72 lakh (₹5.36 lakh each by BSE and NSE) for non-compliance with SEBI LODR Regulation 17.

- **Easebuzz**, an Indian fintech company, received RBI approval under the Payment and Settlement Systems (PSS) Act, 2007 to operate as a full-service Payment Aggregator (PA).
- **PayGlocal** has received final approval from the Reserve Bank of India (RBI) to operate as a Payment Aggregator – Cross Border – Inward & Outward (PA-CB-I&O).
- The Reserve Bank of India (RBI) added 7 new names to its alert list of unauthorised forex trading platforms, taking the total number to 95.
